KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of Three Hundred Eighty-One Thousand Seven Hundred Seventy And No/100 Dollars (\$381,770.00) paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, Marilyn C. Spacht, an unmarried person (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Raymond E. Kell, Jr. and Delia S. Kell (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.

Lot 46, according to the Final Record Plat of Greystone Farms, Terrace Hills, as recorded in Map Book 24, Page 54, in the Probate Office of Shelby County, Alabama.
Together with the nonexclusive easement to use the private roadways, Common Areas and Hugh Daniel Drive, all as more particularly described in the Greystone Farms Declaration of Covenants, Conditions, and Restrictions recorded in Instrument # 1995-16401 in the Probate Office of Shelby County, Alabama, and all amendments thereto

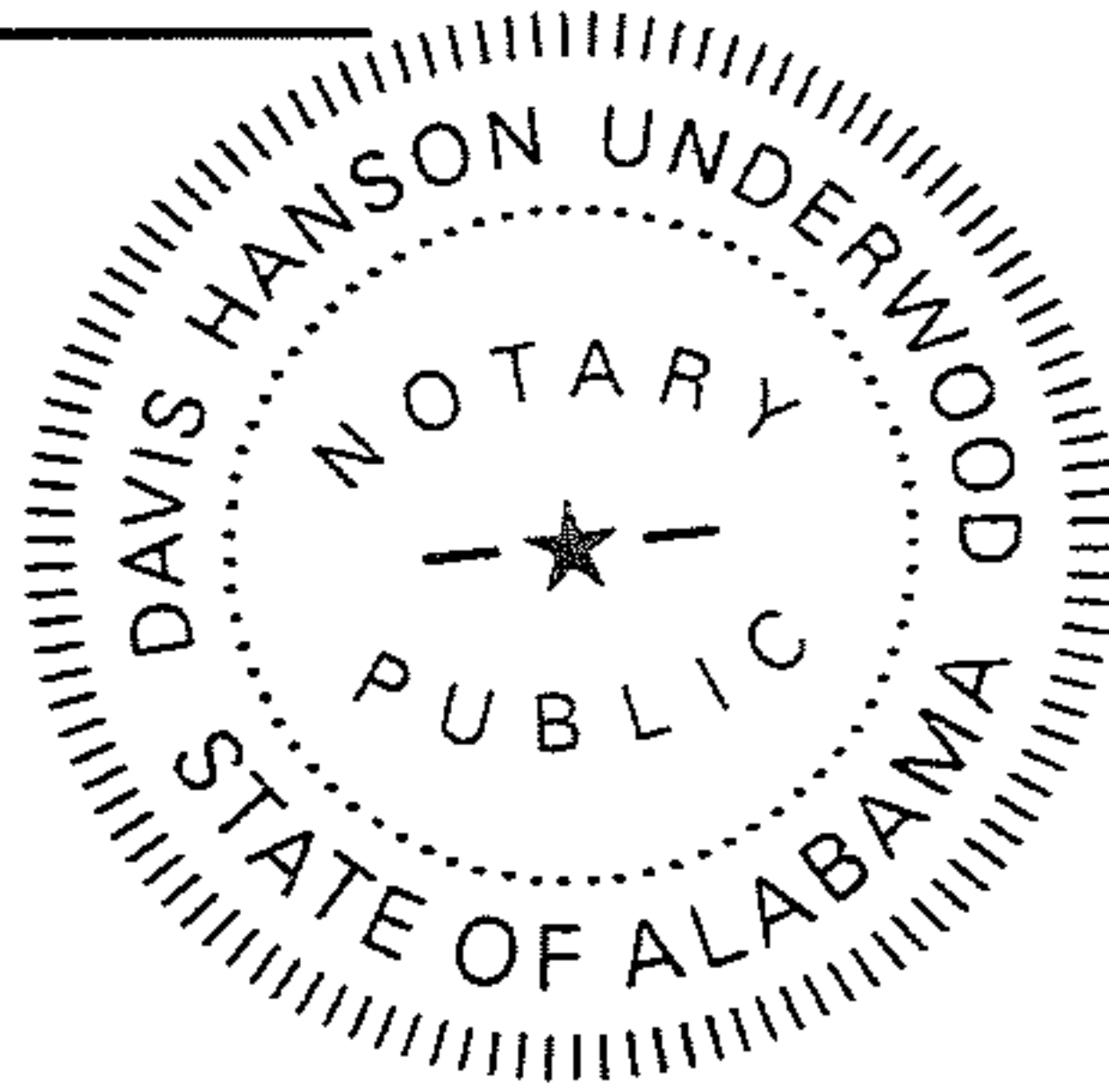


