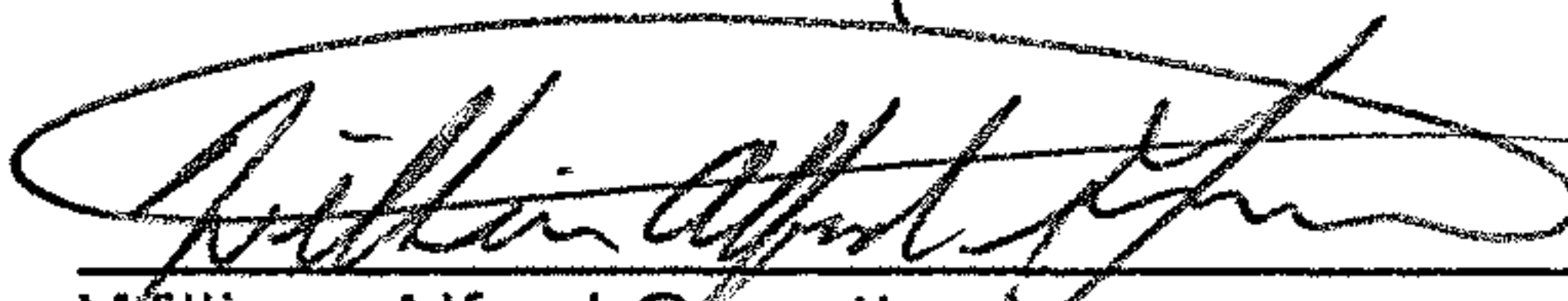
\$ 466,096 of the consideration was paid from a mortgage loan closed simultaneously herewith.

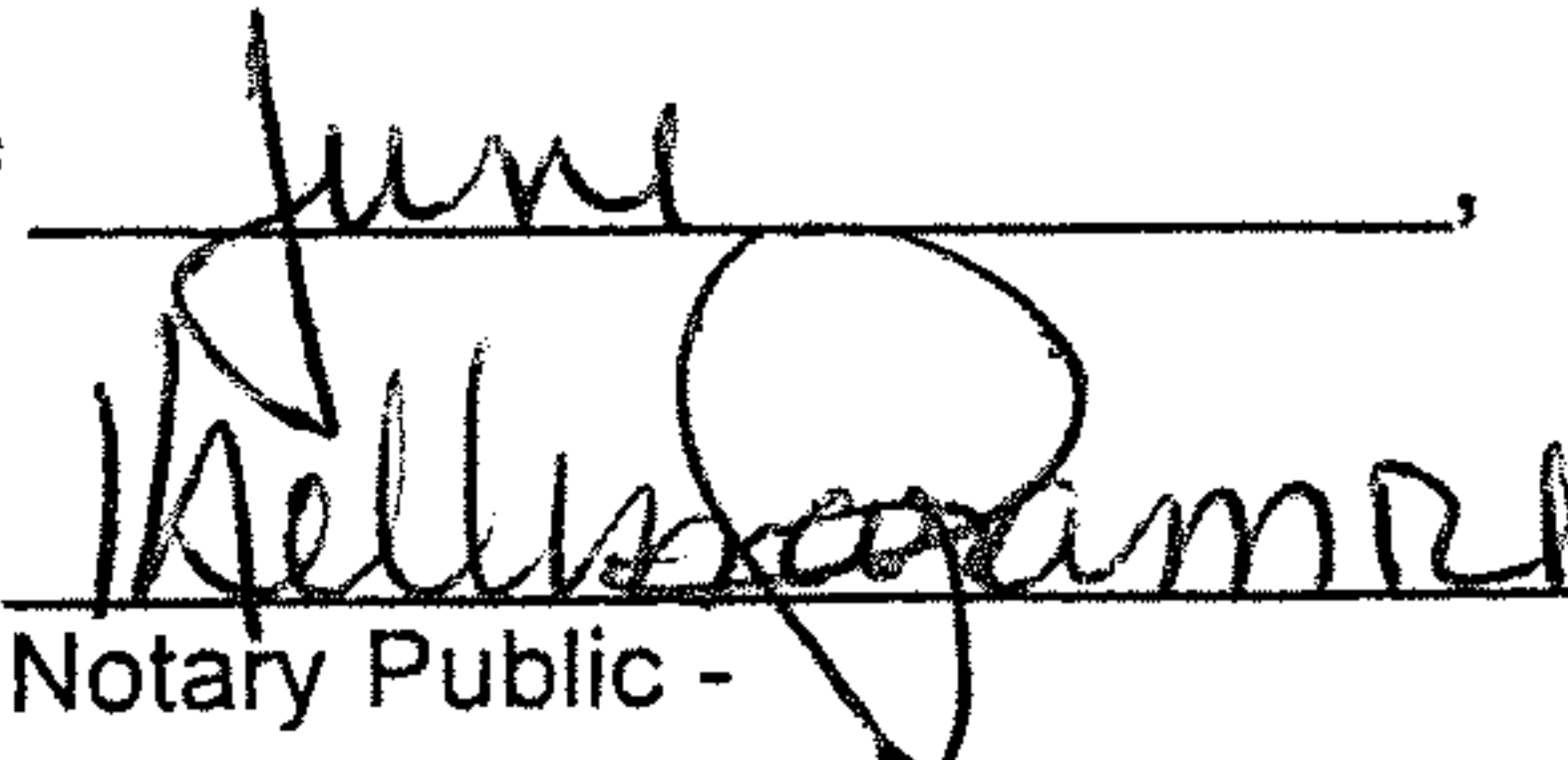

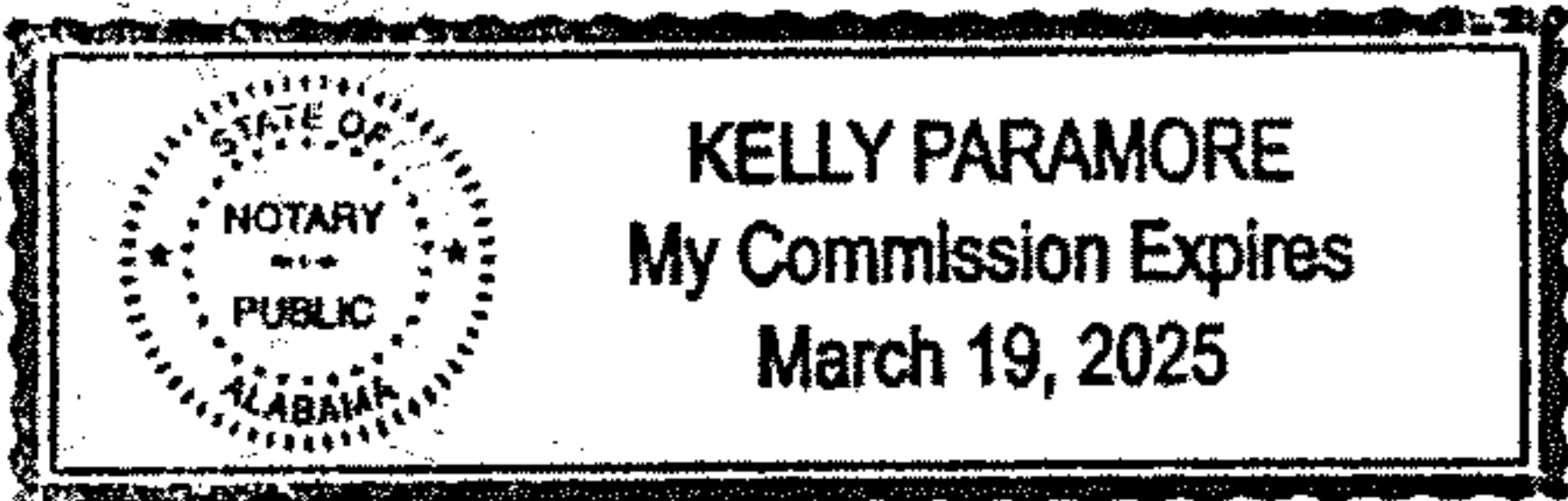
