Stamps, a single man (herein referred to as Grantors)** grant, bargain, sell and convey unto **Jerrold C. Stamps and Paula B. 
SUBJECT TO:

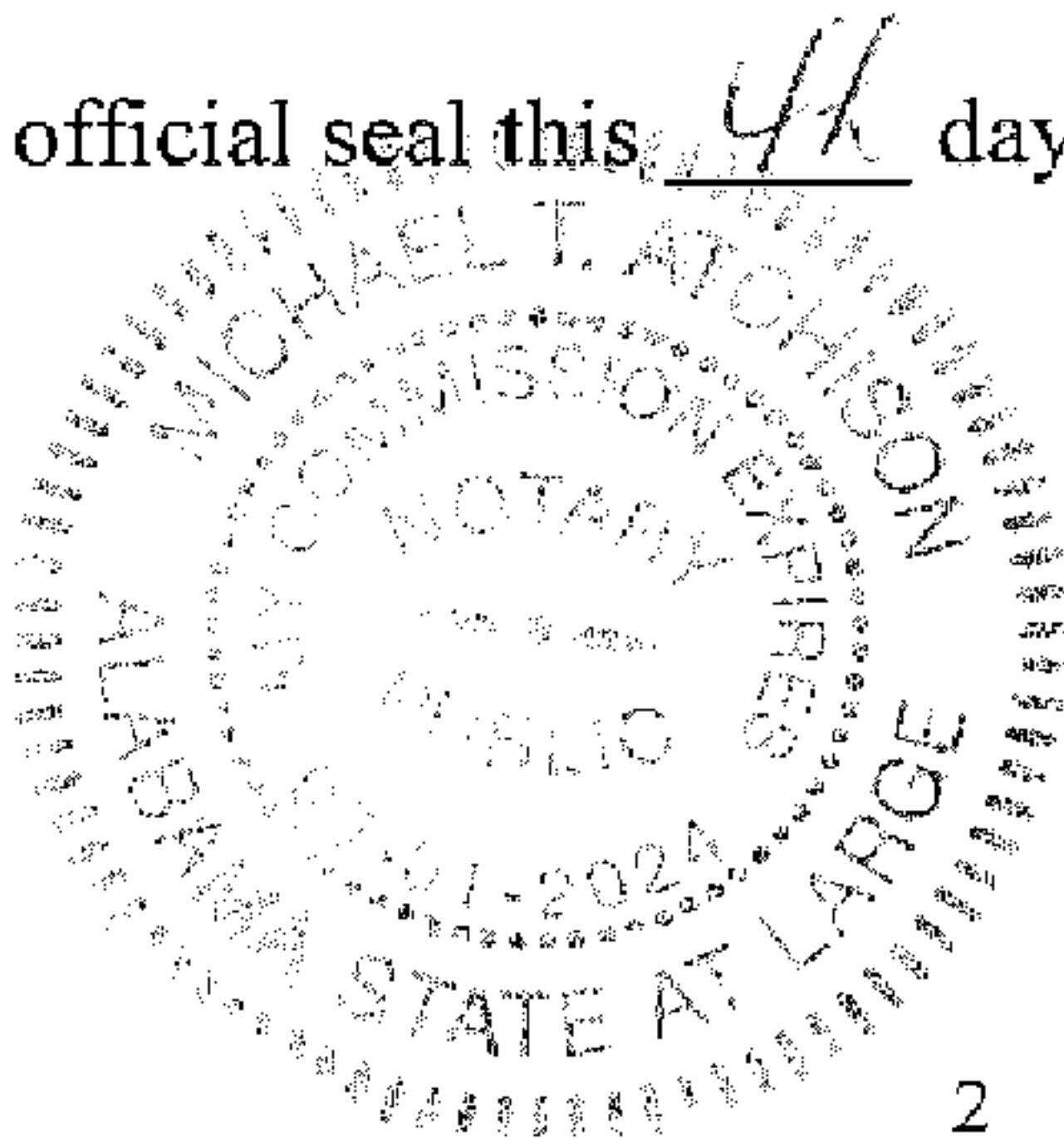


