That in consideration of the sum of **One Hundred Twenty Five Thousand Dollars and No Cents (\$125,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Jerrold C. Stamps and Paula B Stamps**, husband and wife (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Moeen UD-DIN Chaudhry and Elisa Gay Blankenship Chaudhry**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit:

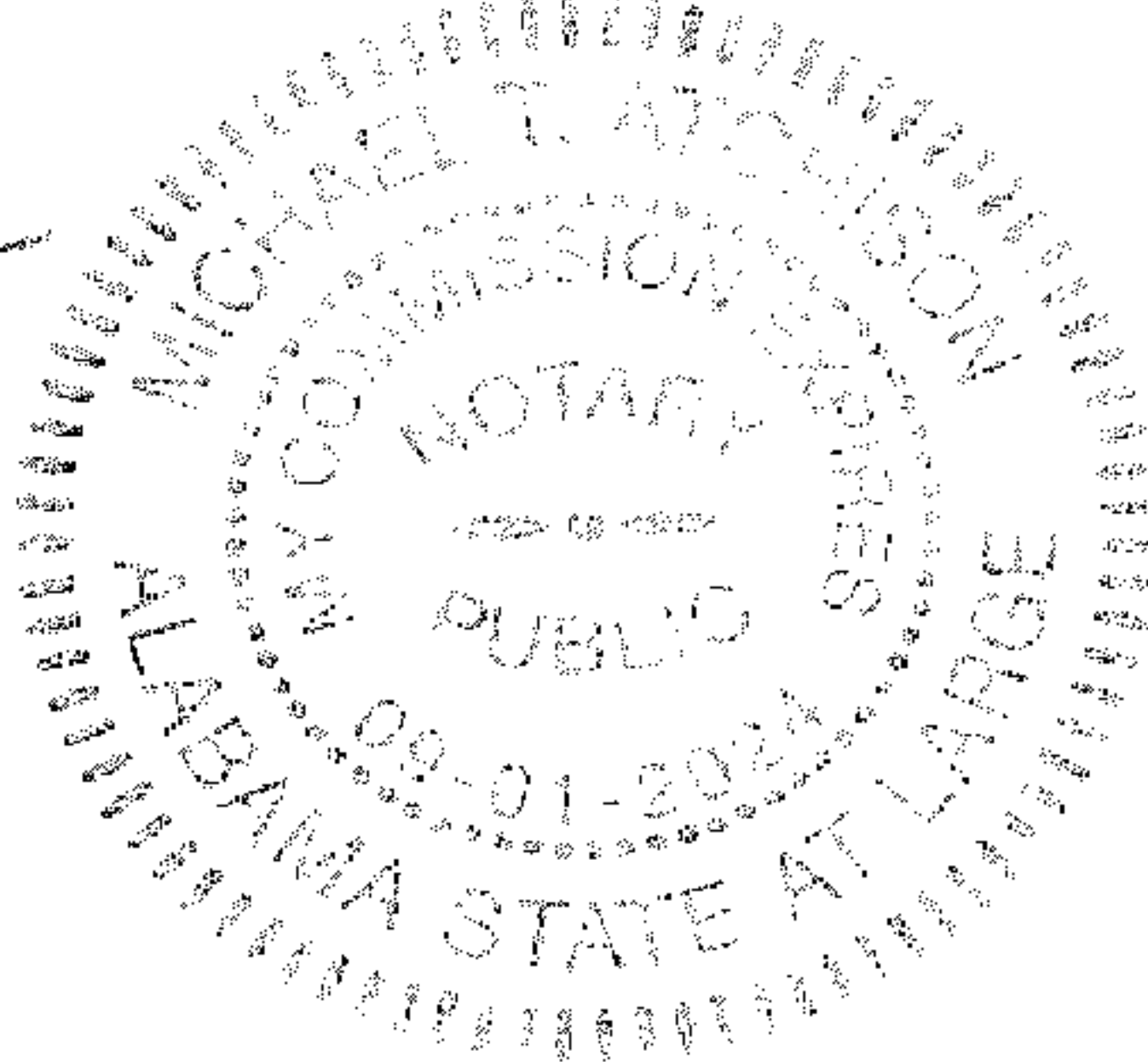
