The width of the Company's right of way will depend on whether the Facilities are underground or overhead: for underground, the right of way will extend five (5) feet on all sides of said Facilities as and where installed; for overhead Facilities. the right of way will extend fifteen (15) feet on all sides of said Facilities as and where installed.
