Harris**, (hereinafter "Grantee", whether one or more), the receipt and sufficiency of which are hereby acknowledged, Grantor does, by these presents, grant, bargain, sell, and convey unto Grantee **Micah D. Harris**, the following described real estate situated in Shelby County, Alabama, **the address of which is 1016 Kingston Road, Chelsea, AL 35043 to-wit:**

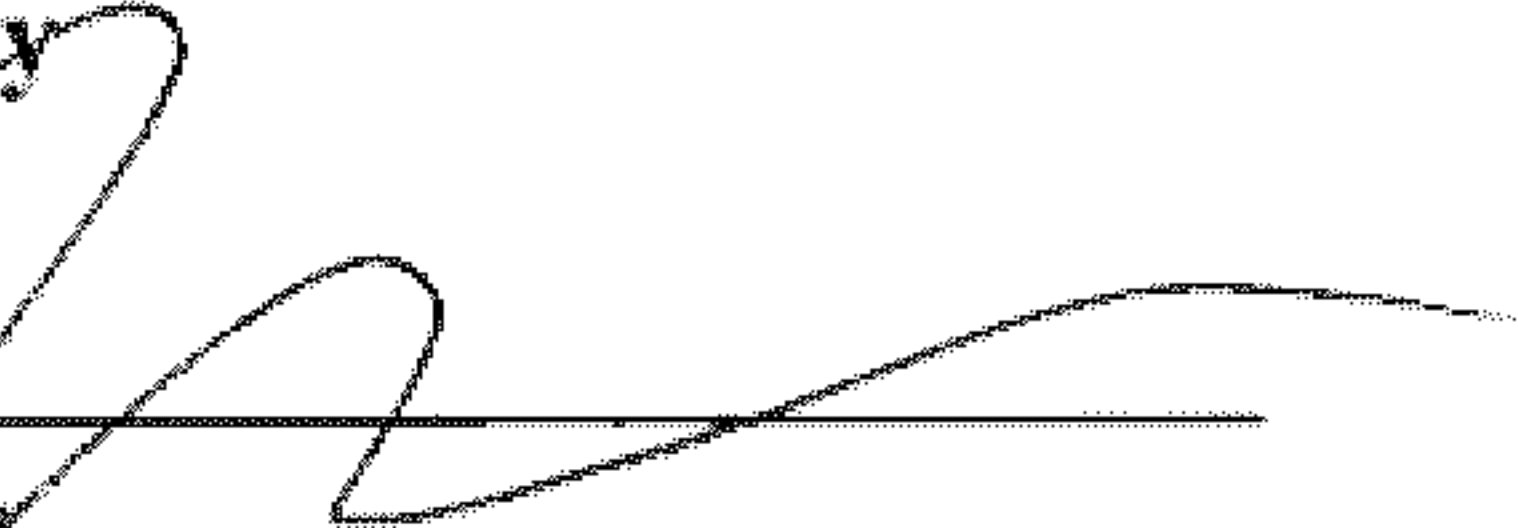
Subject to a third-party mortgage in the amount of \$598,500.00 executed and recorded simultaneously herewith.

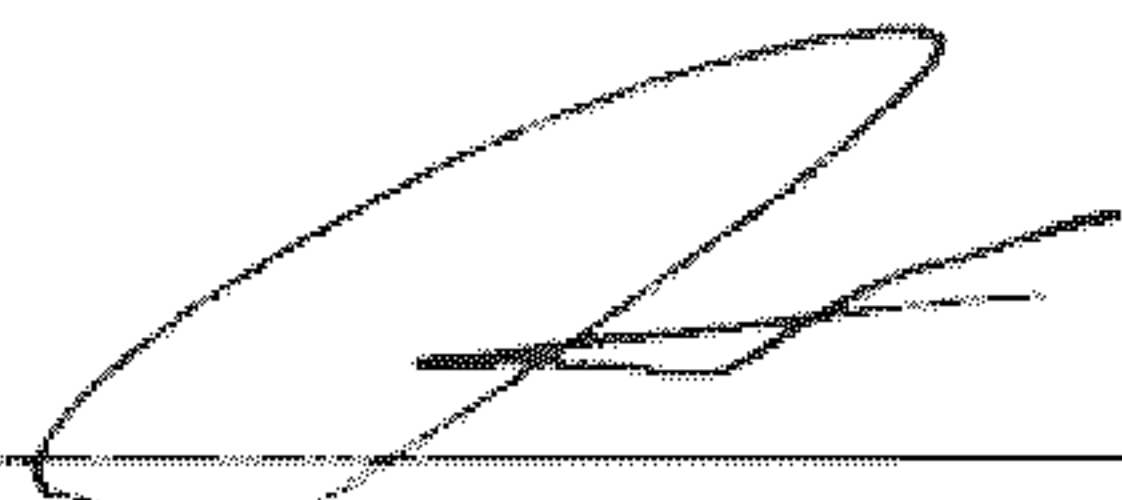
