Parcel:

Commence at the northeast corner of the NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 16, Township 21 South, Range 3 West, Shelby County, Alabama, and run thence westerly along the north line of said quarter-quarter section a distance of 239.32 feet to a steel pin corner and the point of beginning of the property being described; thence continue along last described course 160.00 feet to a steel rebar corner; thence turn 91 degrees 04 minutes 24 seconds left and run southerly a distance of 267.05 feet to a steel rebar corner on the northerly margin of Shelby County Highway No. 26 in a curve to the left; thence turn 83 degrees 23 minutes 54 seconds left to chord and run easterly along the chord of said curve a chord distance of 160.00 feet to a steel pin corner; thence turn 96 degrees 23 minutes 32 seconds left and run northerly a distance of 282.45 feet to the point of beginning, containing 1.01 acres.
