

WARRANTY DEED CREATING JOINT TENANCY WITH RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS that, for and in consideration of the payment of Ten and No/100 (\$10.00) and other good and valuable consideration to the undersigned Grantors in hand paid by the Grantees herein, the receipt and sufficiency whereof is hereby acknowledged, Michael L. Specht and Stacie L. Specht, husband and wife (herein referred to as "Grantors"), do hereby grant, bargain, sell and convey unto Jermale Merritt and Antionette Latrice Merritt (herein referred to as "Grantees"), as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama, to-wit:

Lot 569, according to the Survey of Lake Forest, Fifth Sector, as recorded in Map Book 30, Page 25 in the Probate Office of Shelby County, Alabama.

This conveyance is hereby made subject to restrictions, easements, rights of way and reservations appearing of record in the Office of the Judge of Probate of Tuscaloosa County, Alabama which apply to the subject property.

\$304,000.00 of the consideration herein was derived from a mortgage loan closed simultaneously herewith.

TO HAVE AND TO HOLD, all and singular, the above mentioned and described premises, together with the appurtenances, unto the said Grantees, for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, and to the heirs and assigns of such survivor forever, together with every contingent remainder and right of reversion.
