Know All Men by These Presents: That in consideration of **Four Hundred Twenty-Eight Thousand Five Hundred and 00/100 Dollars (\$428,500.00)**, to the undersigned Grantors, in hand paid by the Grantees herein, the receipt where is acknowledged, we, **WILLIAM R. 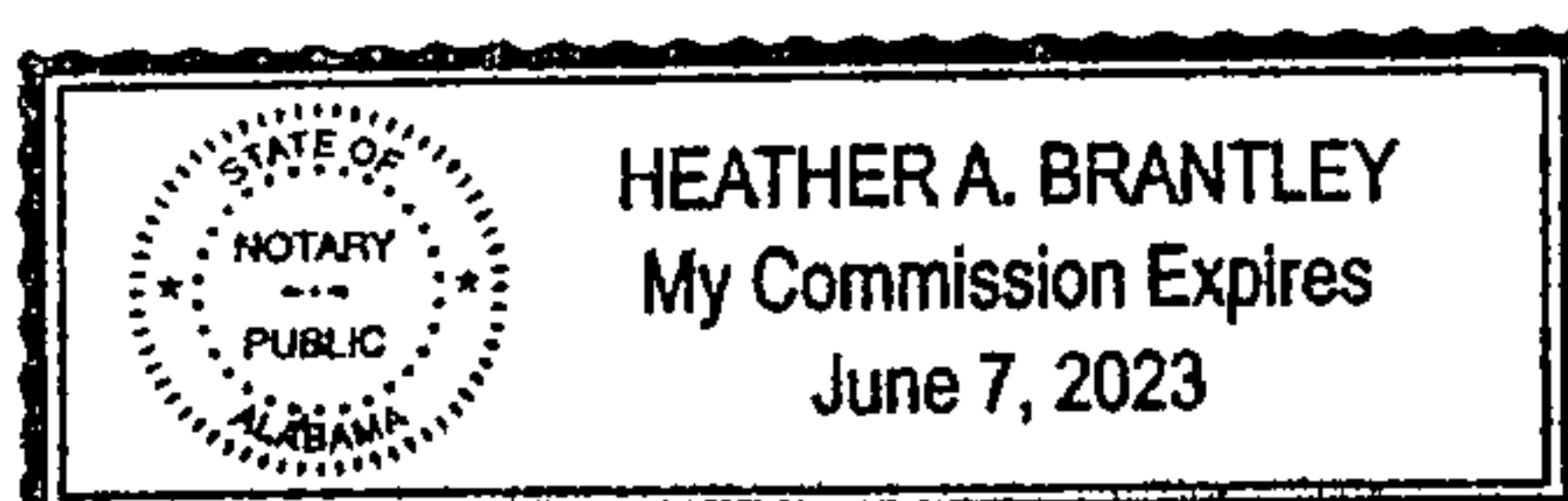
