County of Shelby

That in consideration of the sum of **Four Hundred Sixty Thousand Dollars and No Cents (\$460,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Gayle Mitchell Falkner, a married woman and Susan Mitchell Jones, a married woman**, (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Melanie H. Averill and John C. Averill**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;


No part of the homestead of the Grantors herein or their spouses.


\$310,000.00 of the purchase price of the above described property was financed with the proceeds of a mortgage loan closed simultaneously herewith.




