KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration THREE HUNDRED EIGHTY FOUR THOUSAND AND 00/100 (\$384,000.00), and other **good** and valuable consideration, this day in hand paid to the undersigned GRANTOR, **Nathaniel Mason, a married man**, (hereinafter referred to as GRANTOR), the receipt whereof is hereby acknowledged, the GRANTOR does hereby give, grant, bargain, sell and convey unto the GRANTEES, **Douglas G. Regan and Catherine Regan**, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:

Lot 22, according to the Survey of Meadow Brook Cluster Homes, 2nd Sector, as recorded in Map Book 22, page 110, in the Probate Office of Shelby County, Alabama.

This property is not the homestead of Nathaniel Mason or his spouse.


Subject to existing easements, current taxes, restrictions and covenants, set-back lines, rights of way and mortgages, if any, of record.

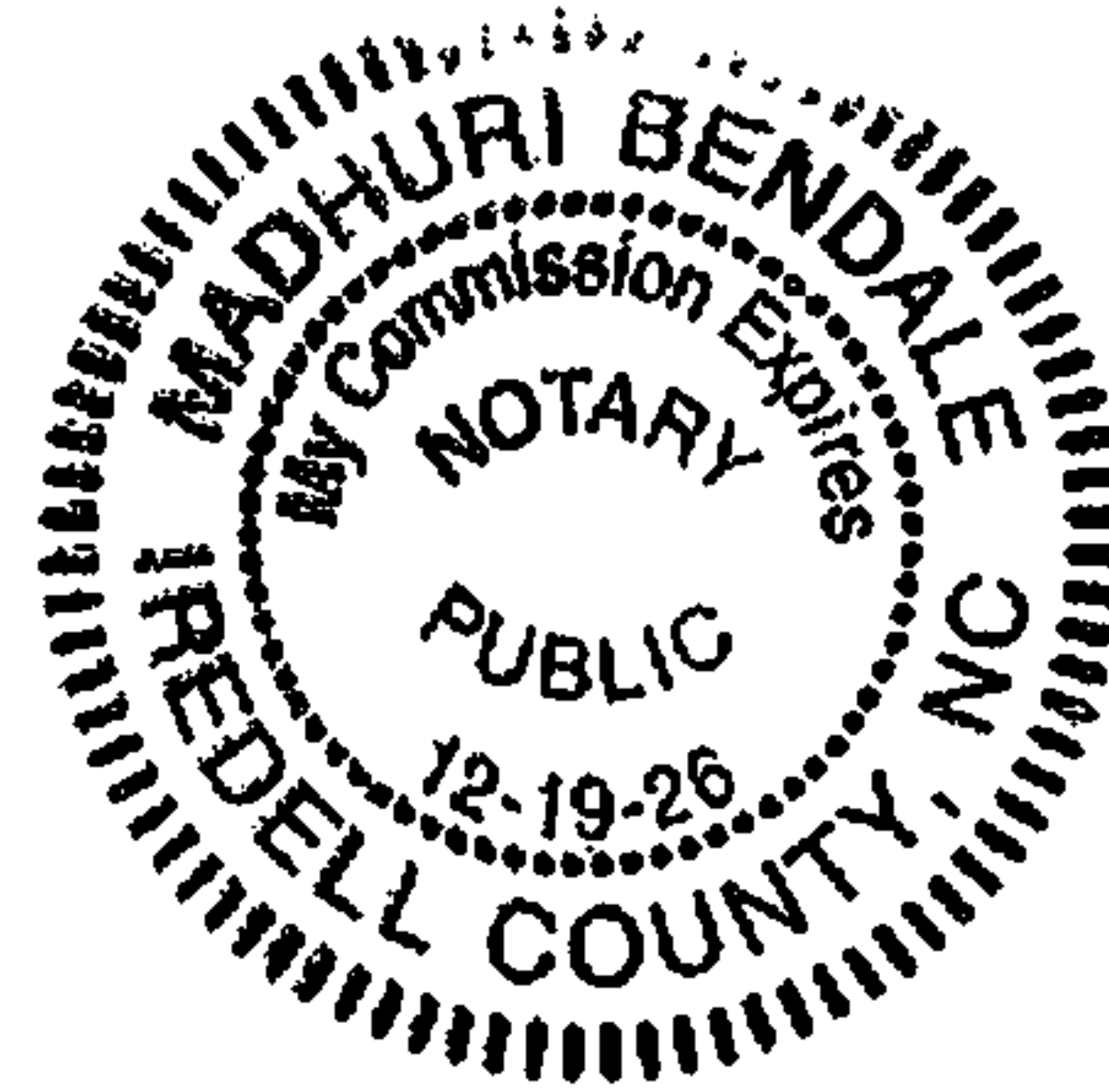
