KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore, on to-wit, February 9, 2007, **Jerry Scarborough, A Married Person and Wendy Scarborough, Non Purchasing Spouse, Mortgagor**, did execute a certain mortgage to **Mortgage Electronic Registration Systems, Inc., as mortgagee, as nominee for Resmae Mortgage Corporation, its successors and assigns**, which said mortgage is recorded in Instrument No. 20070227000089280 as modified by that certain Modification Agreement in Instrument No. 20100429000131910, in the Office of the Judge of Probate of Shelby County, Alabama.; and

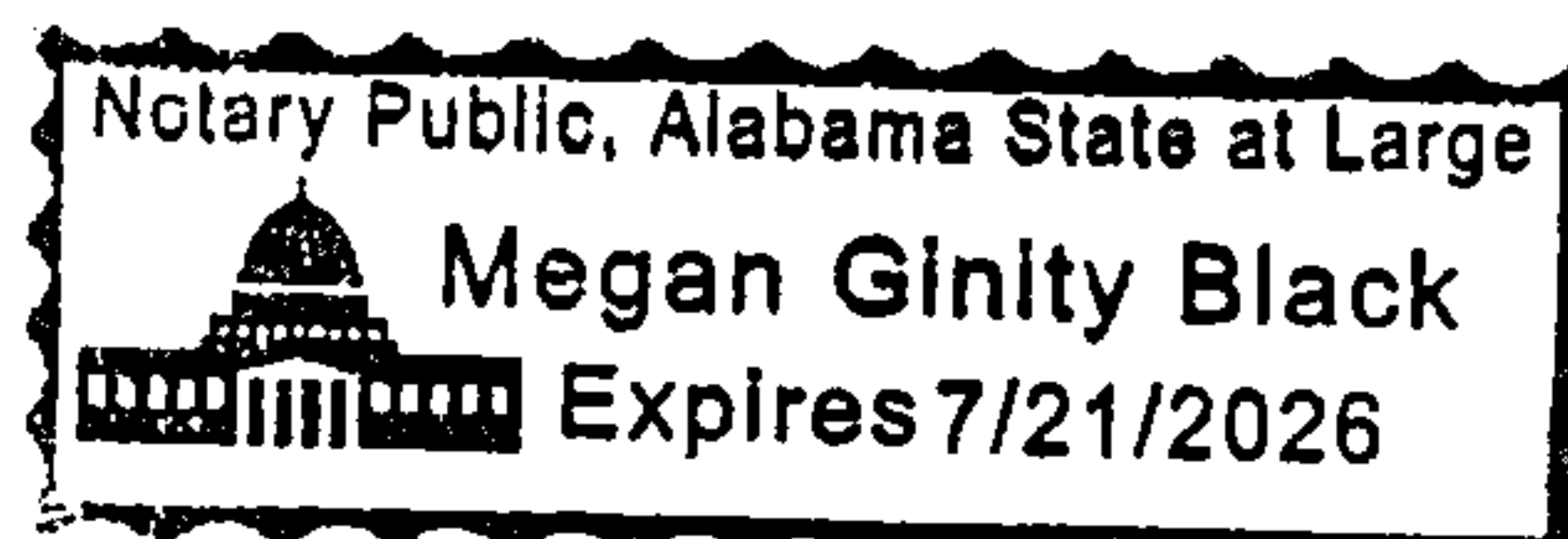
