ORDER

This cause was heard by the court on July 21, 2022, pursuant to the Contempt Petition filed herein by the State of Alabama Department of Human Resources. The Plaintiff was not present in Court. The Defendant was **not** present in Court but has been duly served with the Petition and Notice to Appear and the State's Motion for entry of judgment by default is hereby granted.

The Court having considered the pleadings, process and stipulation of the parties and after a consideration thereof and all prior matters had and done herein and by agreement of parties, it is adjudged as follows:

1. The Defendant is in contempt of the orders of this Court for her willful failure and refusal to pay child support as ordered.

2. As of June 30, 2022, the Defendant owes child support arrearages as follows:

\$28,086.92 to the individual Plaintiff together with interest of \$22,277.07 for a total of \$50,363.99 for which a judgment is entered.

\$7,595.17 to the State of Alabama together with interest of \$14,394.57 for a total of \$21,989.74 for which a judgment is entered.

3. The Defendant is ordered to continue paying the sum of \$50.00 per month toward retirement of the above judgment of arrears and continuing until said judgment is paid in full.

4. No sanctions for contempt are ordered at this time, but are reserved for further determination by the Court. Until said determination, the Defendant is ordered to comply with all previous orders of this court concerning payment of support and arrearages.

5. All payments of support shall be made to Alabama Child Support Payment Center, P.O. Box 244015, Montgomery, Alabama 36124-4015.

6. An income withholding order for payment of the Defendant's child support/arrears obligation herein shall be immediately entered and served on any employer or any agency of the state or federal government which is indebted or obligated to the Defendant for benefits or entitlements of any kind, or any future employer or obligated agency as aforesaid.

7. Defendant is ordered to notify the Clerk of the Court and the appropriate caseworker with the Department of Human Resources of any change of address.

8. Court costs waived.

9. The Clerk shall provide copies of the order herein to District Attorney, Dept. of Human Resources, and all other parties hereto.
