(herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

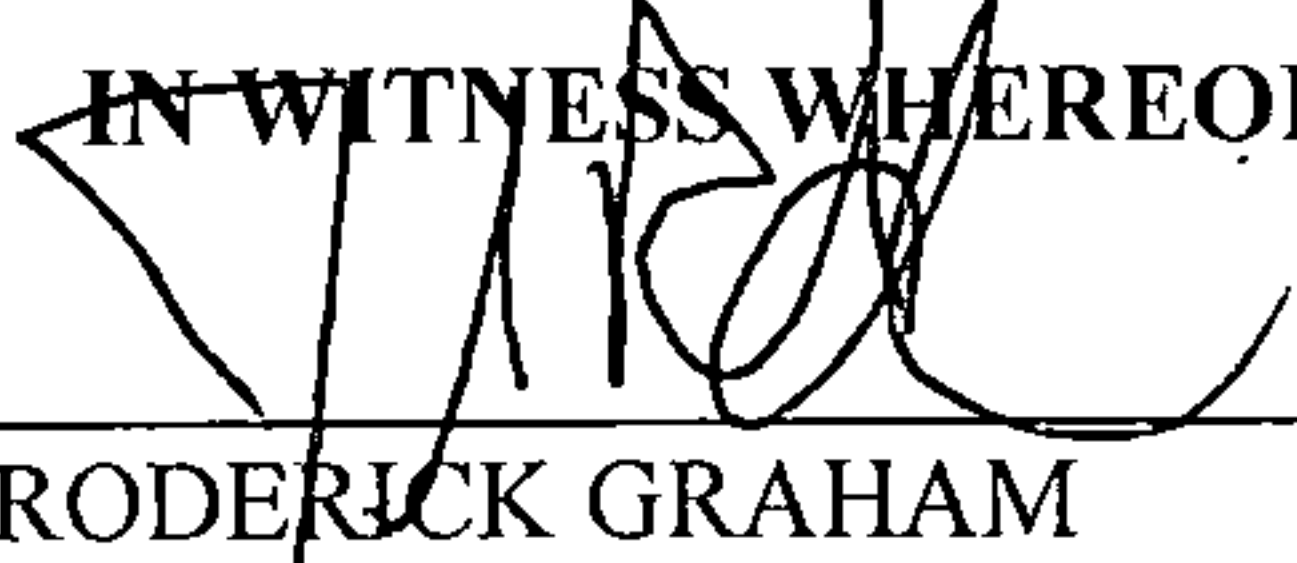
Lot 29, in Block 1, according to the Amended Map of Southlake Crest, 2nd Sector, as

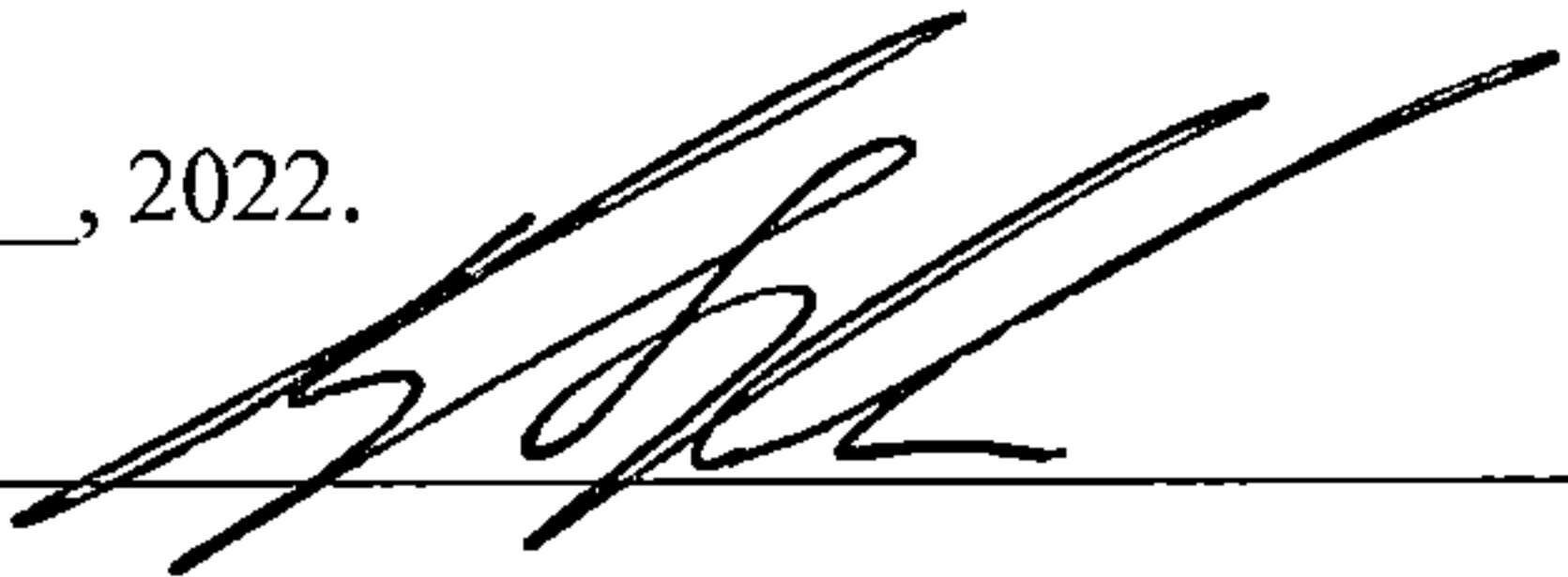

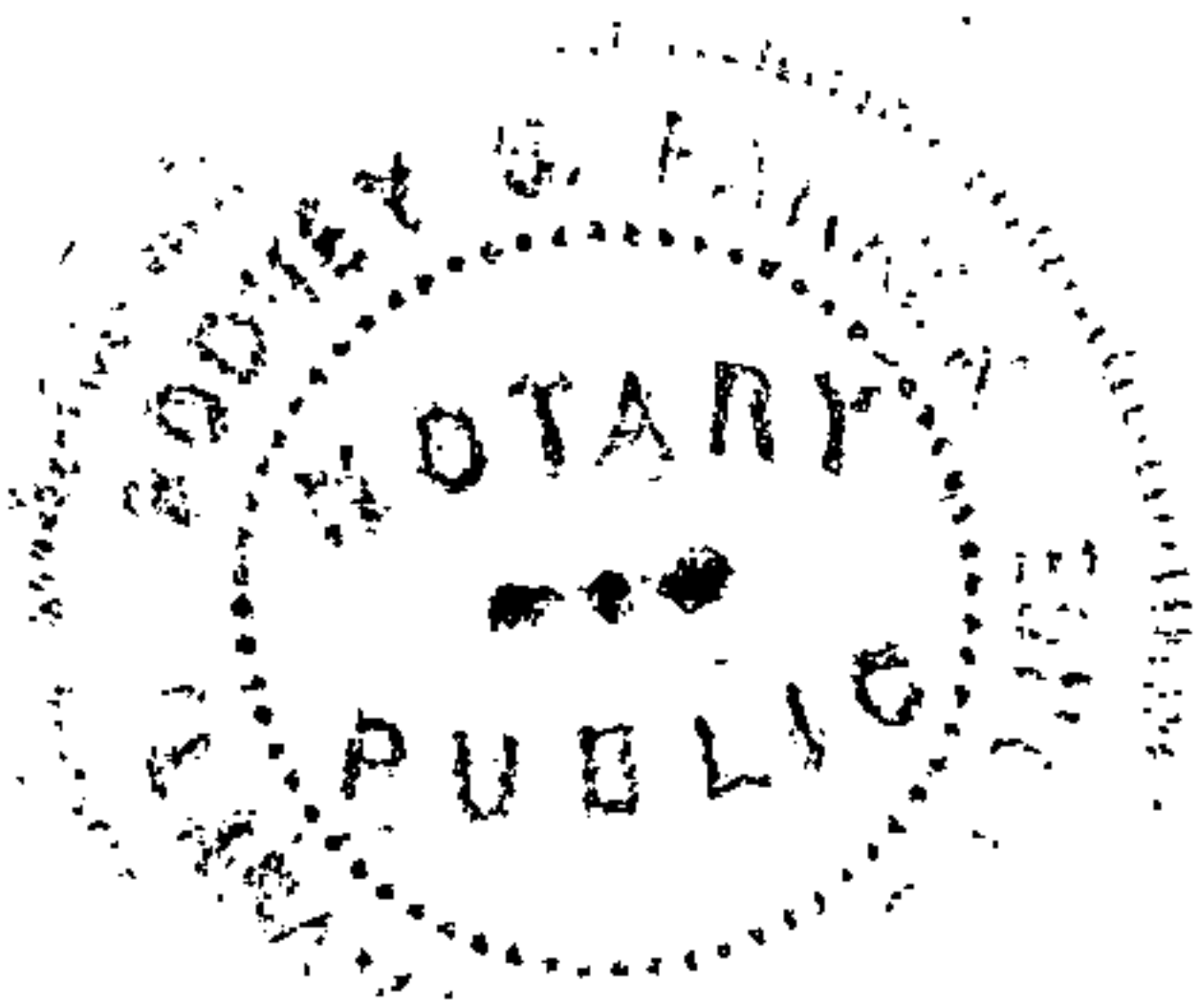
