ORDER

THIS MATTER coming before the Court for Trial on August 27, 2021 and again on May 12, 2022 by the Plaintiff, on a Petition for Grandparent Visitation. Present were the Plaintiff, Robert A. Johnson, Defendants, Jessica and Kyle Kornegay, with their attorney of record, Joey Walden and the Guardian Ad Litem for the minor child, Meagan Michard. After ore tenus testimony and exhibits presented in Court, it is therefore,

ORDERED, ADJUDGED, and DECREED as follows:

1. The court finds that visitation between Robert A. Johnson and minor child, Alyson Kay Kornegay (DOB 5-15-2006) is NOT in her best interest. Additionally, the Defendants, Jessica Kornegay and Kyle Kornegay (the parents of said child) do not have a healthy relationship with the Plaintiff, Robert Johnson. This relationship between the father (Plaintiff/MGF) and his daughter (Defendant/Mother) is strained and has been for quite some time.
2. Therefore, the Plaintiff has NOT met the burden as outlined in §30-3-4.2 (Code of Alabama 1975). This matter is DISMISSED.
3. The court orders the Plaintiff to pay the Guardian Ad Litem and amount of \$4,000.00 for her time in this matter. Any prior payments made to the Clerk of the Court shall be credited to this amount.
4. The court orders attorney's fees for the Defendant in the amount of \$4,000.00 for his time in this matter.
5. Court costs taxed as paid.
