Know All Men by These Presents: That in consideration of **Two Hundred Thousand and 00/100 Dollars (\$200,000.00)**, to the undersigned Grantors, in hand paid by the Grantees herein, the receipt where is acknowledged, we, **CASSANDRA BREEDING and ANDREW D. 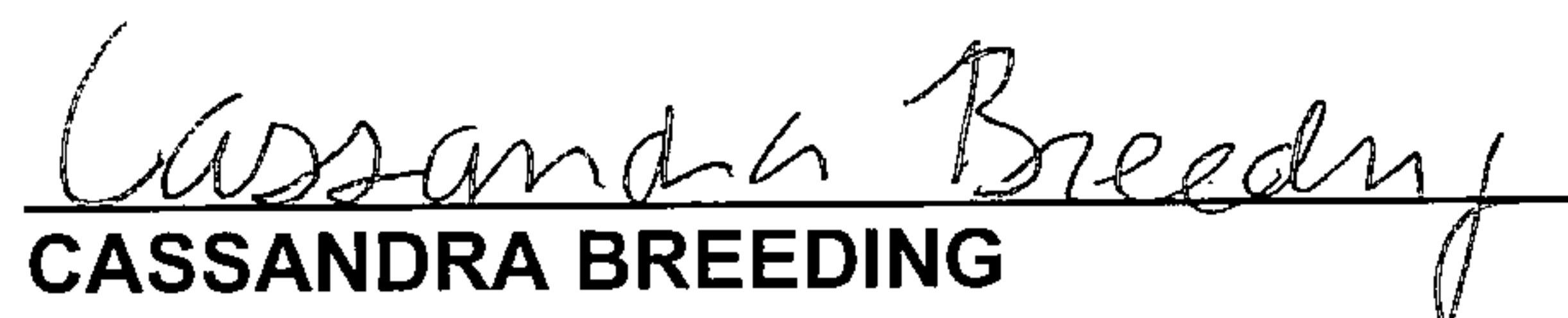

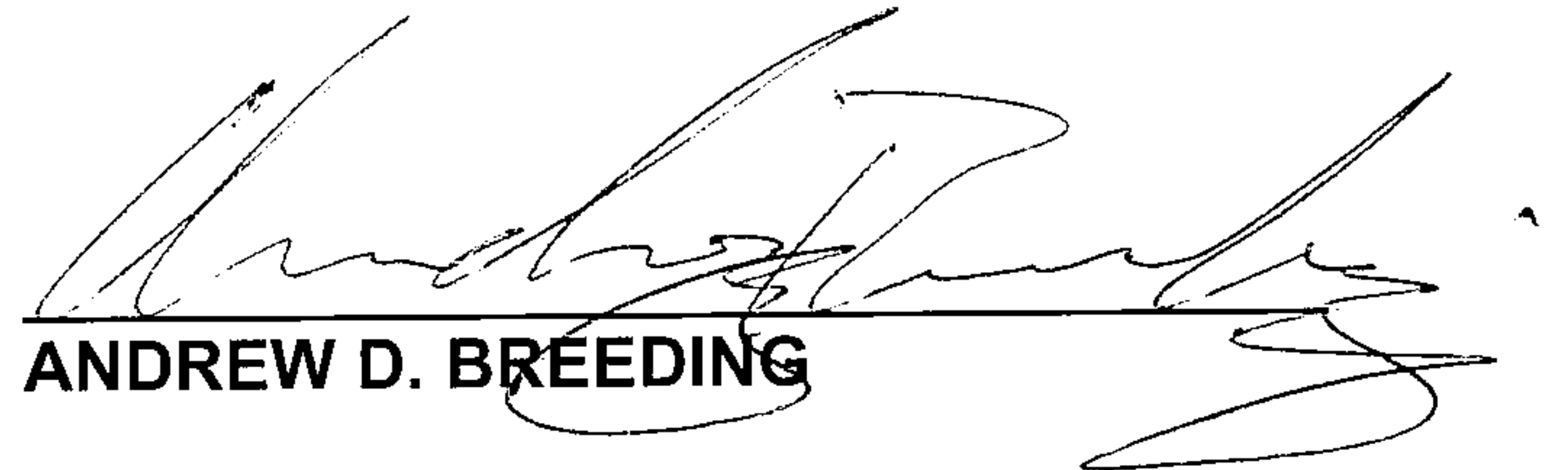
Subject to mineral and mining rights if not owned by Grantors. Subject to existing easements, restrictions, set-back lines, rights of way, limitations, if any of record.

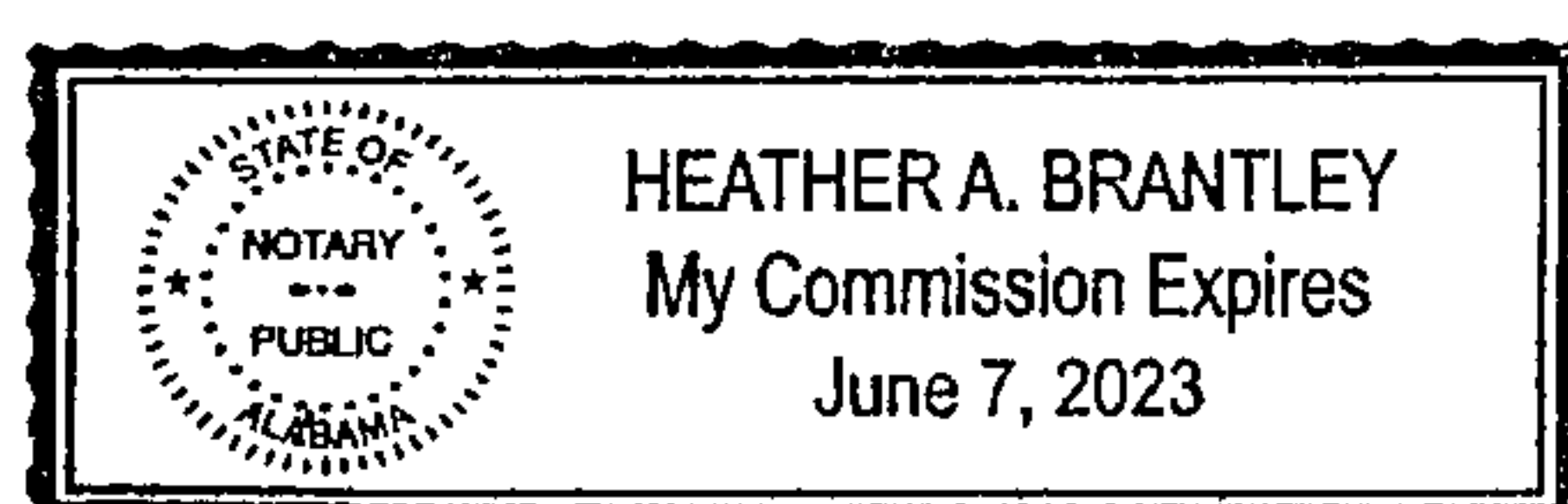

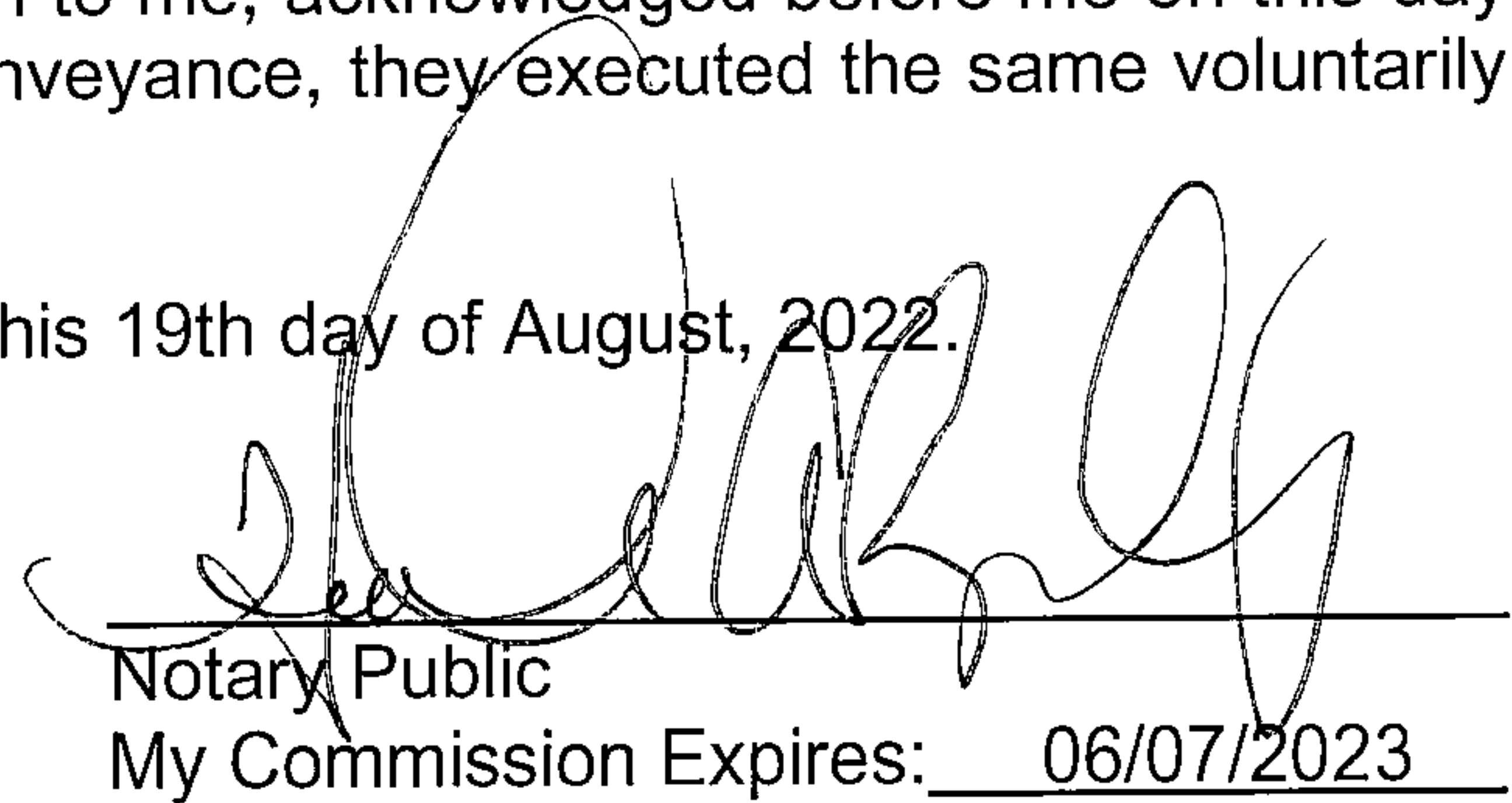

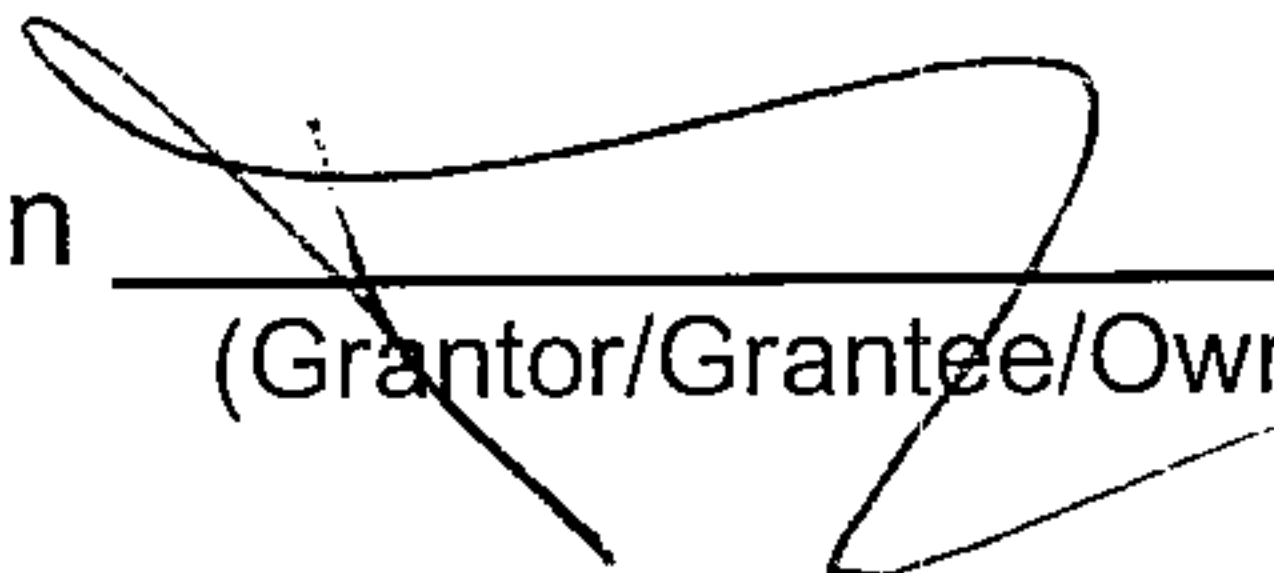
