WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP

**STATE OF ALABAMA
COUNTY OF SHELBY**

KNOW ALL MEN BY THESE PRESENTS,

That for and in consideration of **SIX HUNDRED FIFTEEN THOUSAND AND NO/100 (\$615,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned **ROBERT CLARK, JR. and MAMIE D. CLARK**, husband and wife, (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **JOHN R. WYNN and JO ANN B. WYNN**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 1, according to the Survey of Meadow Brook, 10th Sector, as recorded in Map Book 11, Page 27, in the Probate Office of Shelby County, Alabama.

Subject to:

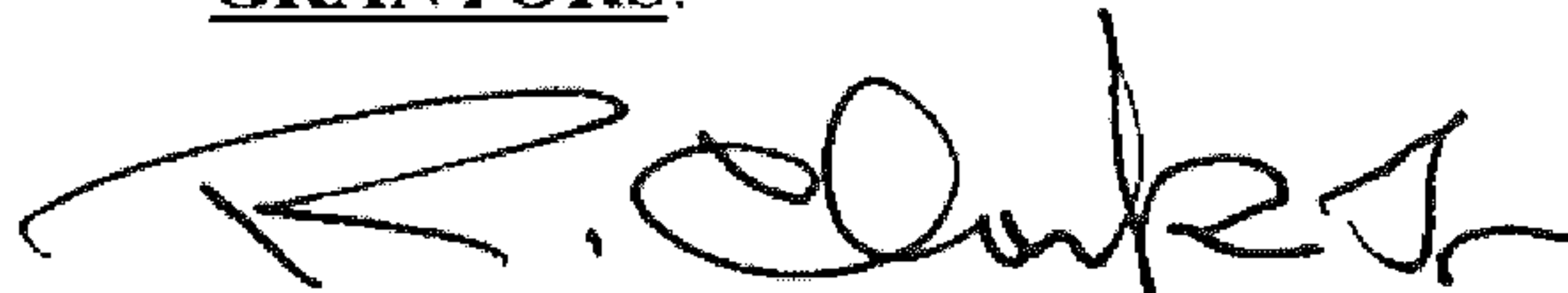
1. General and special taxes or assessments for the year 2022 and subsequent years not yet due and payable.
2. Municipal improvements, taxes, assessments, and fire district dues against subject property, if any.
3. Mineral and mining rights not owned by Grantors.
4. Any applicable zoning ordinances.
5. Easements, encroachments, building set back lines, rights-of-ways as shown of record by recorded plat or other recorded instrument, including any amendments thereto.
6. All matters, facts, easements, restrictions, assessments, covenants, agreements and all other terms and provisions in Map Book 11, Page 27.
7. Public utility easements as shown by recorded plat, including an irregular easement on the southeasterly rear and a 10 foot on the Northeasterly and Southwesterly sides of lot.
8. Building set back line of 35 feet reserved from Meadow Brook Road, as shown by recorded map.
9. Restrictions, Covenants and Conditions set out in instrument recorded in Map Book 11, Page 27 and in Real 141, Page 106.

TO HAVE AND TO HOLD, the tract or parcel of land above described together with all and singular the rights, privileges, tenements, appurtenances, and improvements unto the said Grantees, for and during their joint lives as joint tenants and upon the death of either of them, then to the survivorship of them in fee simple, and to the heirs and assigns of such survivor, forever.

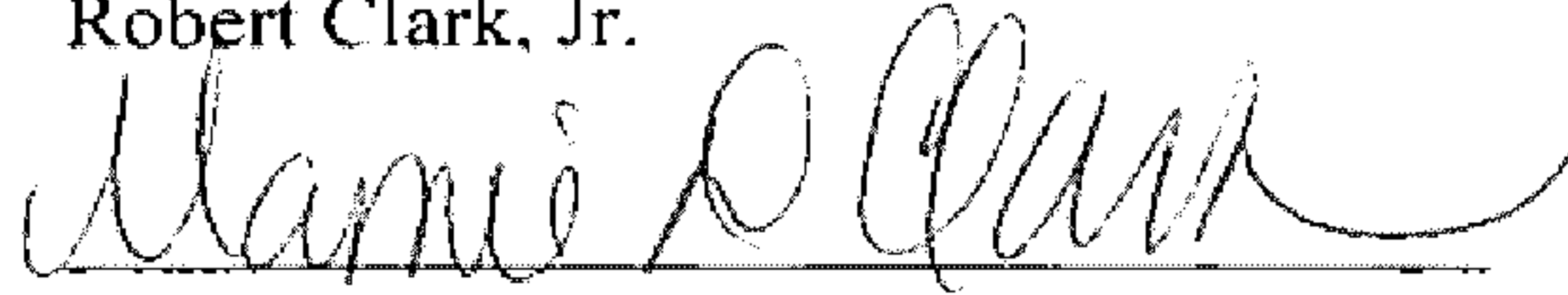

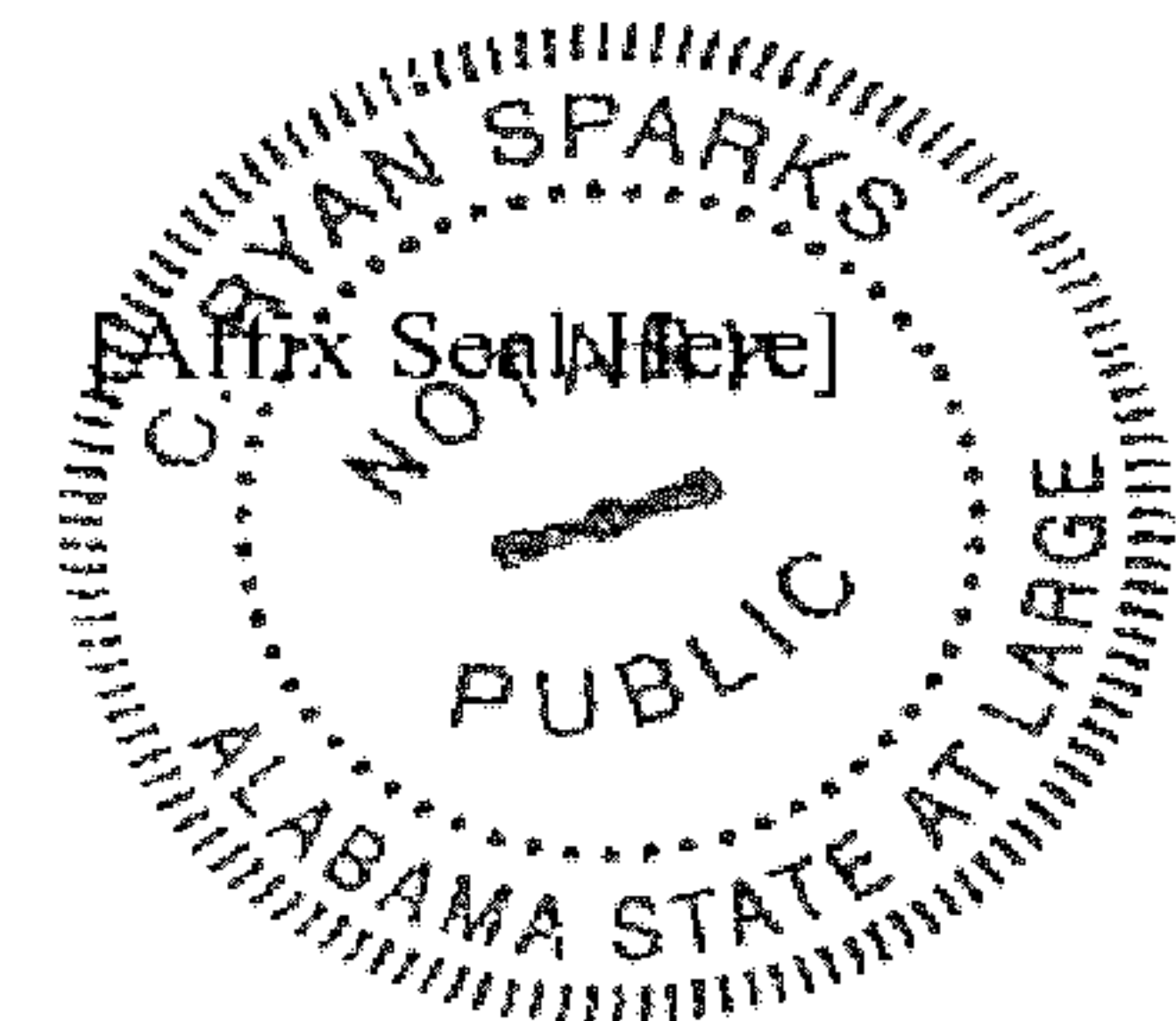
