KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of **THREE HUNDRED NINETY SEVEN THOUSAND AND 00/100 (\$397,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned GRANTORS, **Jae Do Lee, and spouse, Chung Rhan Lee** (hereinafter referred to as GRANTORS), the receipt whereof is hereby acknowledged, the GRANTORS do hereby give, grant, bargain, sell and convey unto the GRANTEES, **Joshua Smallwood and Emily Smallwood** (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of **Shelby**, State of Alabama, to-wit:

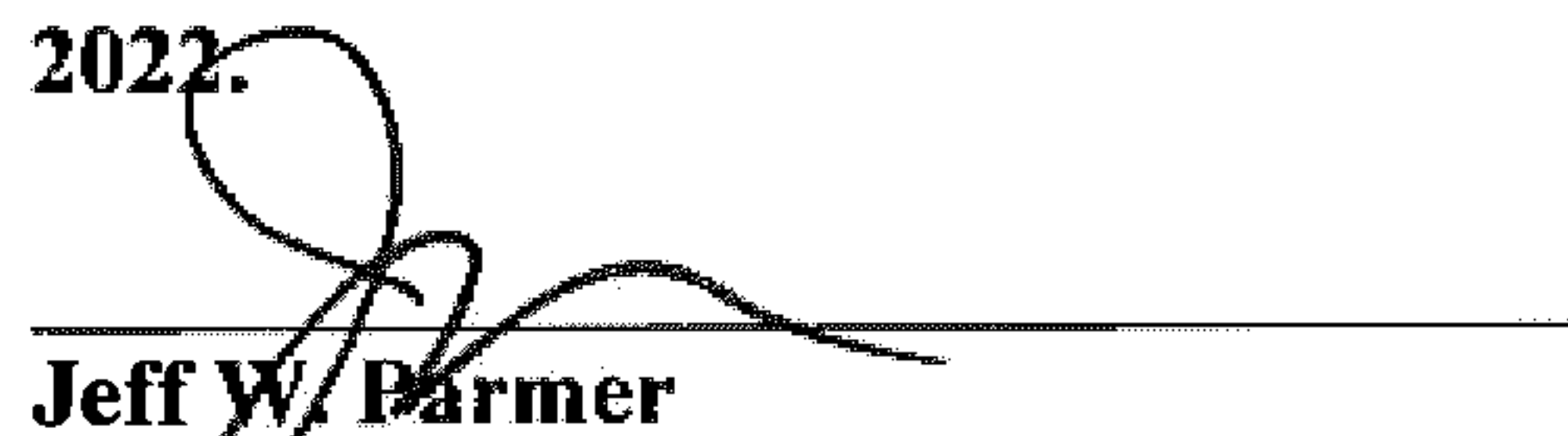

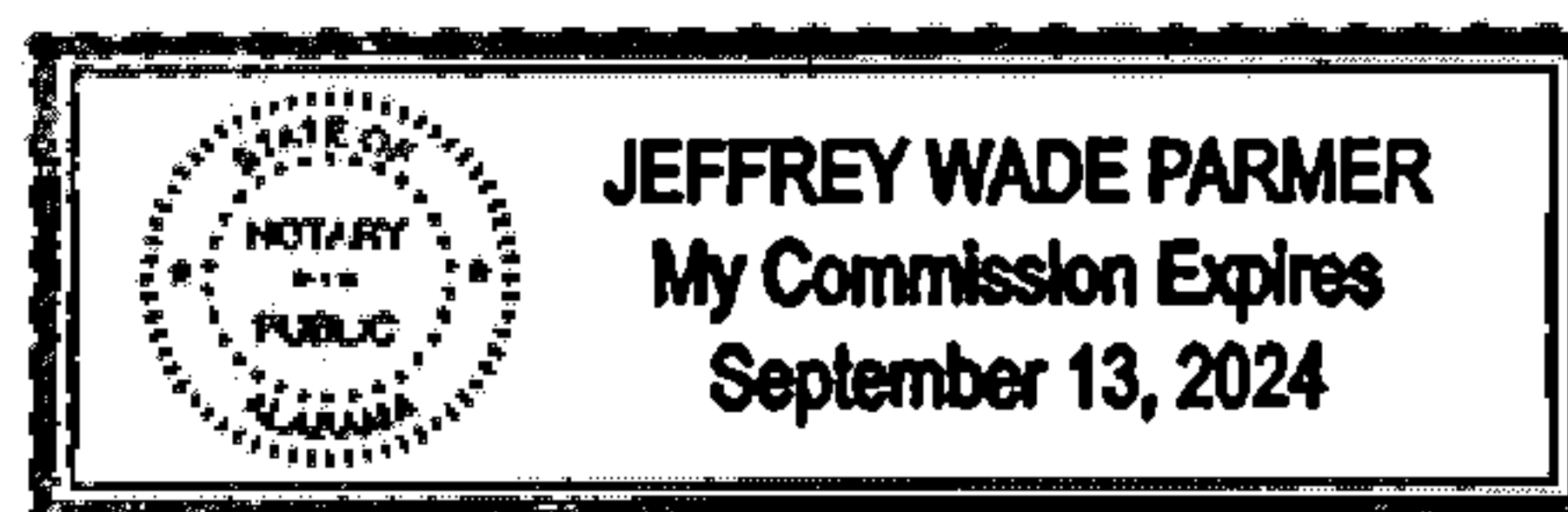
