**GENERAL WARRANTY DEED**

THAT IN CONSIDERATION OF **Three Hundred Eighty Thousand Dollars and NO/100 (\$380,000.00)** to the undersigned grantors, in hand paid by the grantees herein, the receipt whereof is acknowledged, we, **Kimberly Crye Rickels formerly known as Kimberly Thornton and J.P. Rickels, husband and wife**, (herein referred to as Grantors), grant, sell, bargain and convey unto, **Kristen Chalonne Ford and Sidney Micah Lanier Moore III** (herein referred to as Grantees) for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in Shelby County, Alabama to wit:

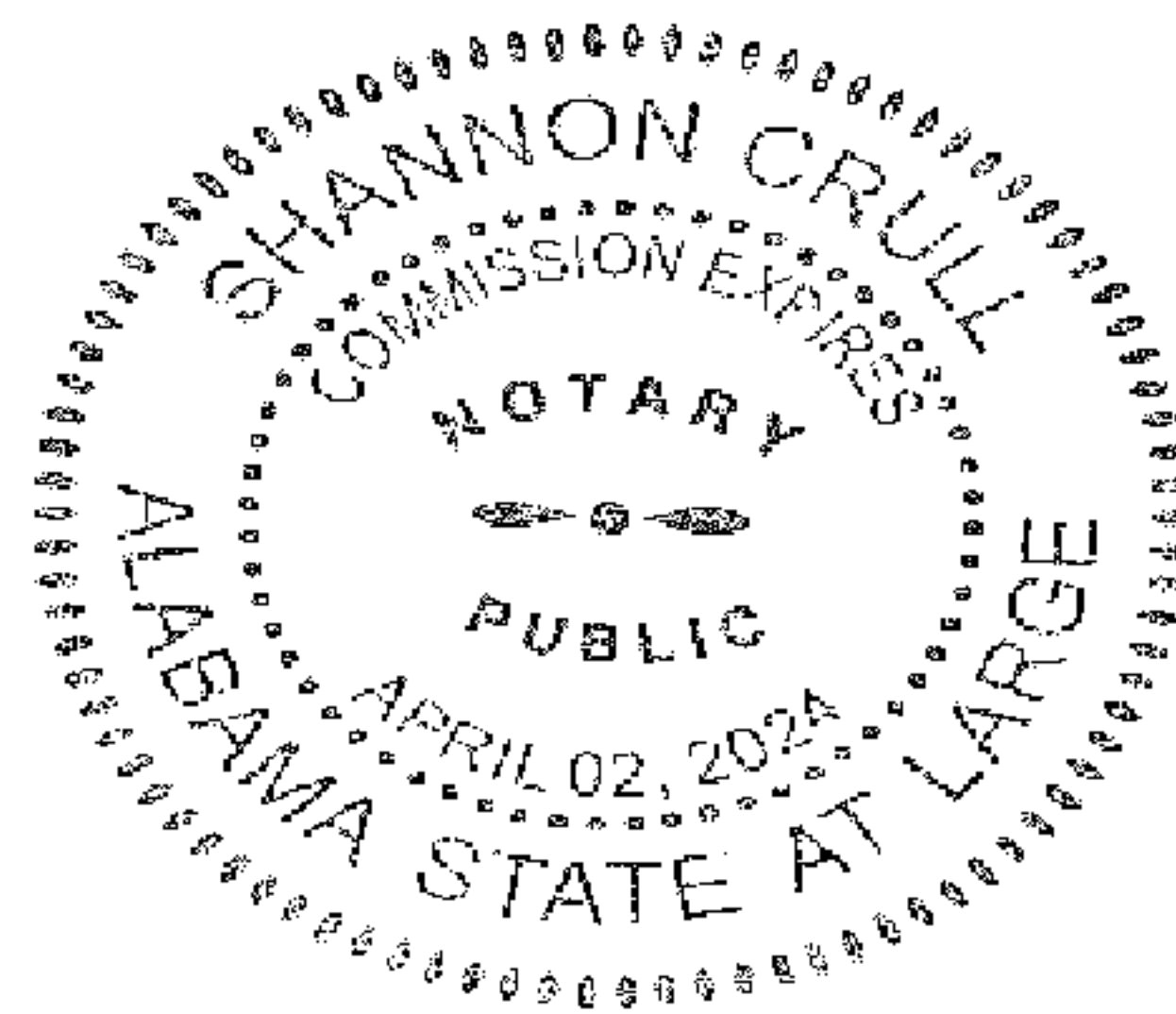

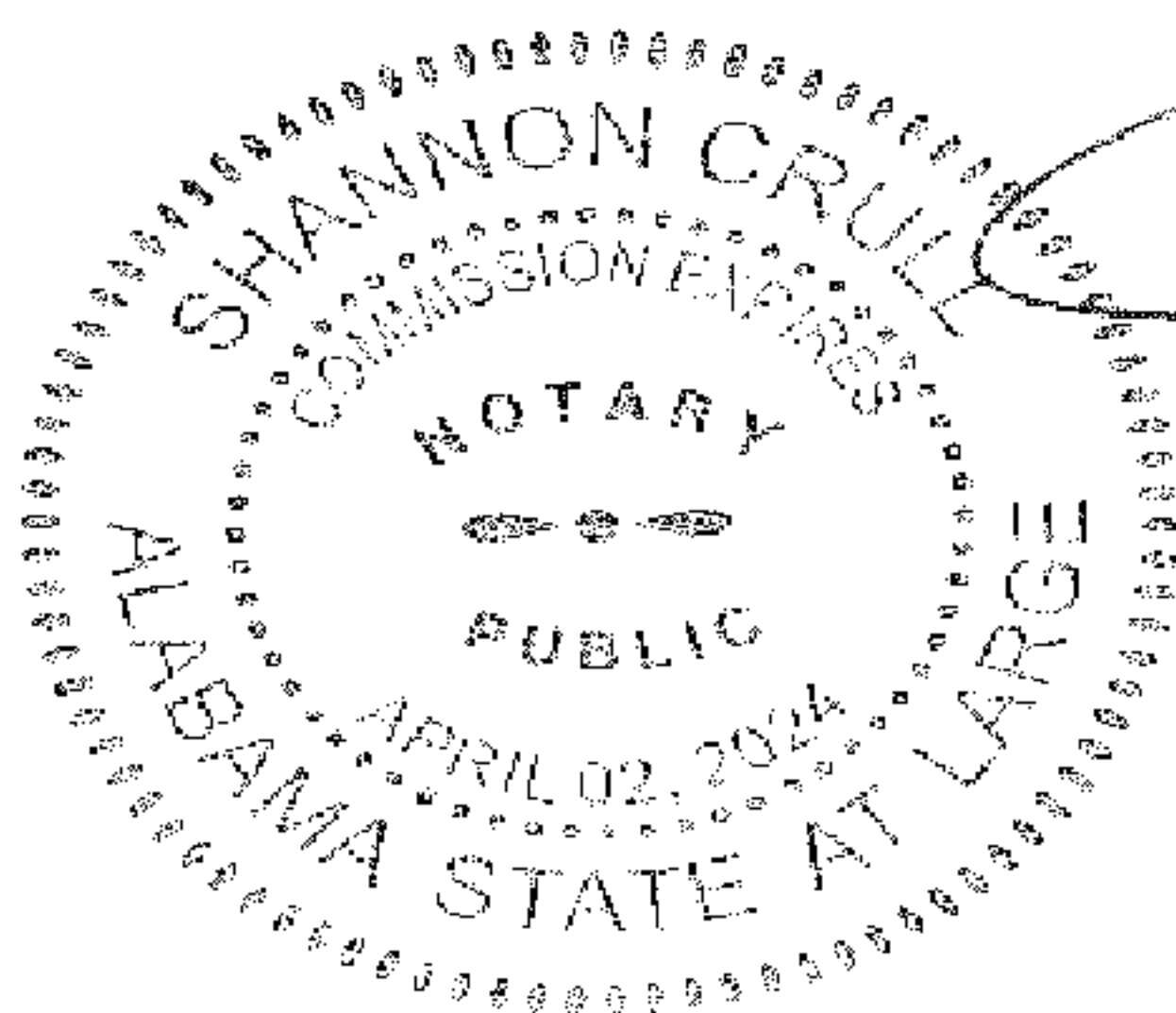

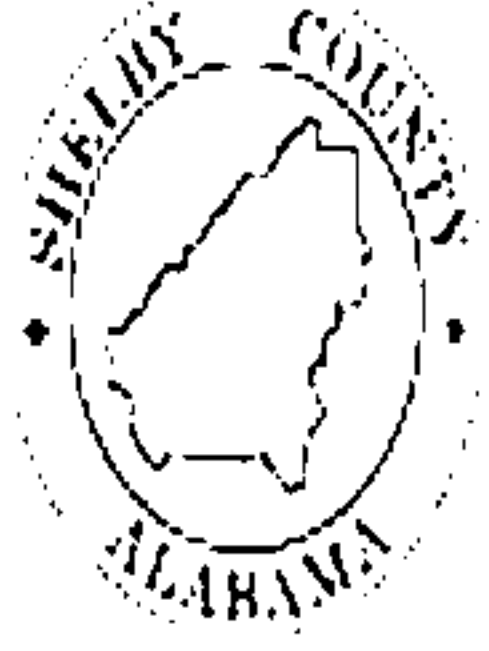
