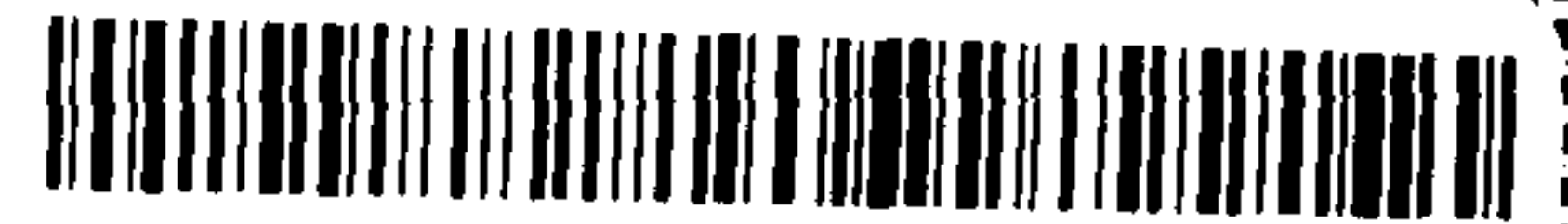

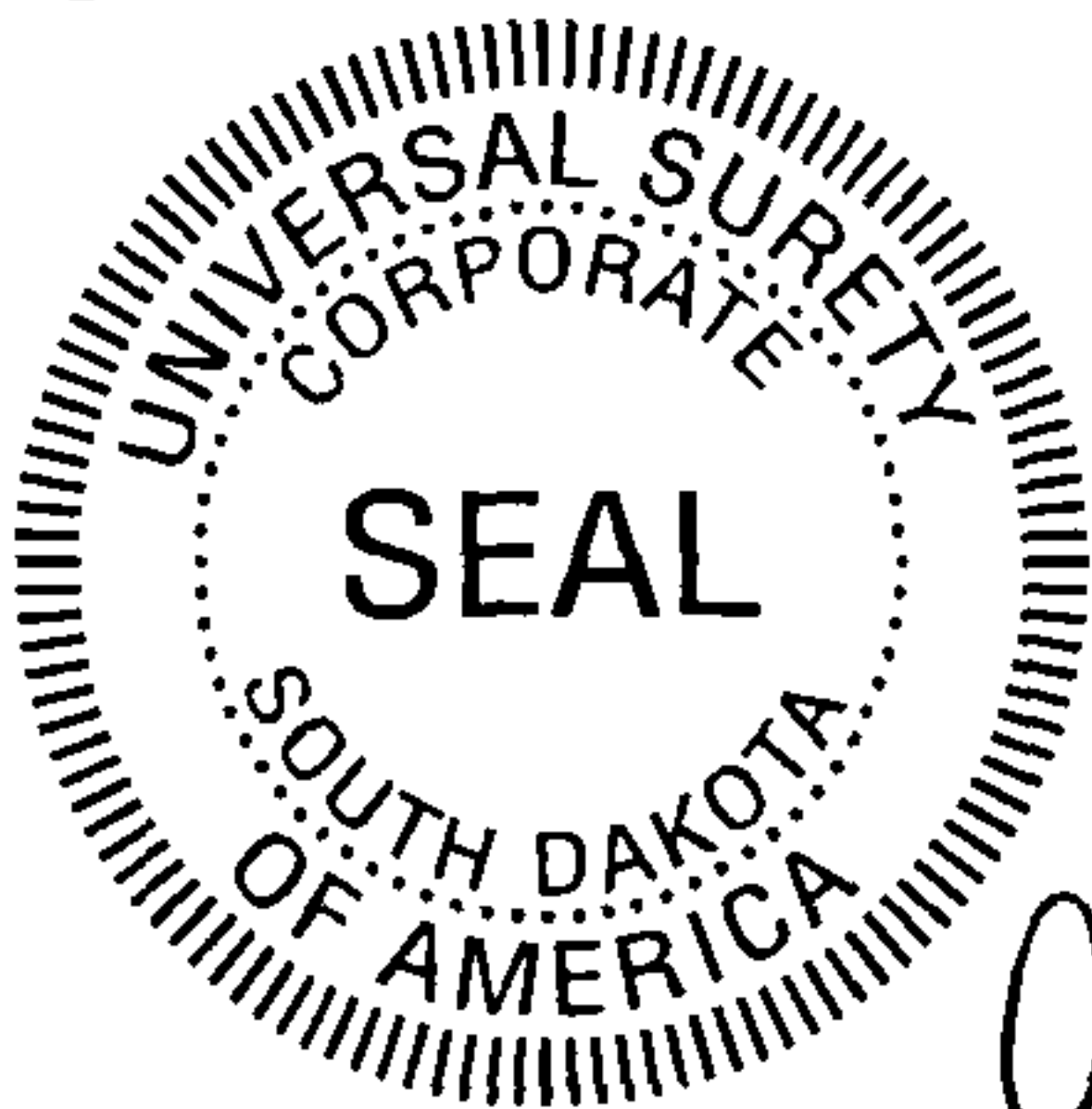

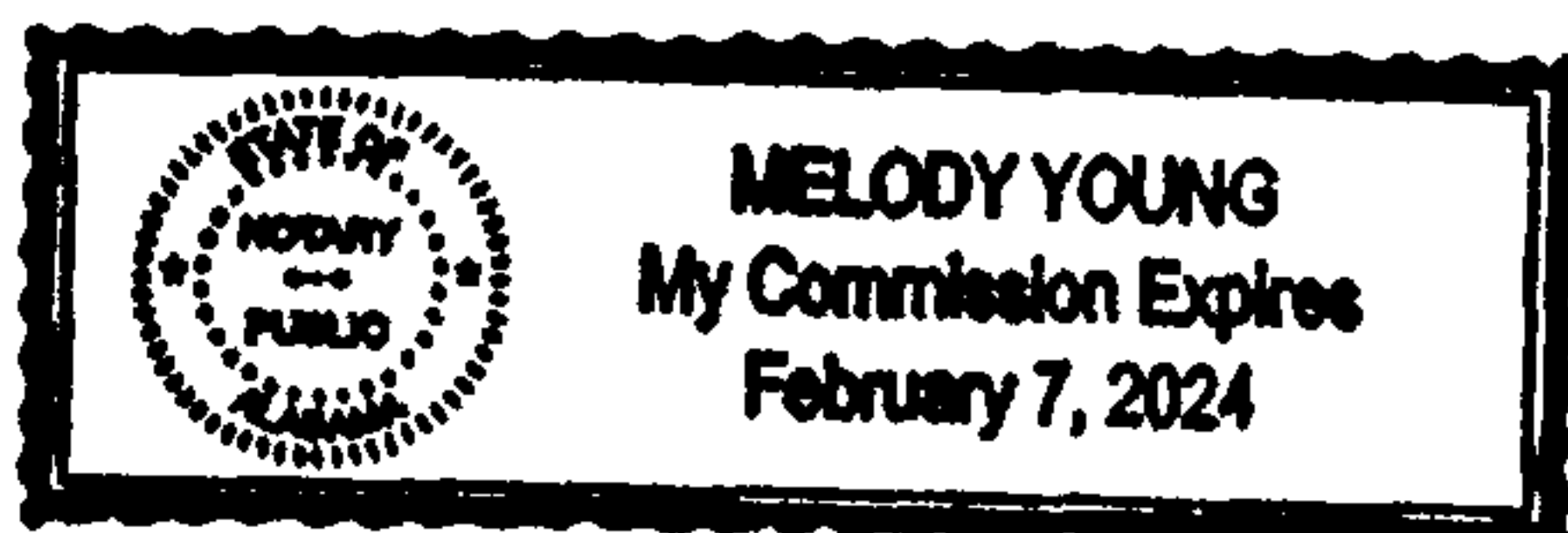
## OATH OF OFFICE

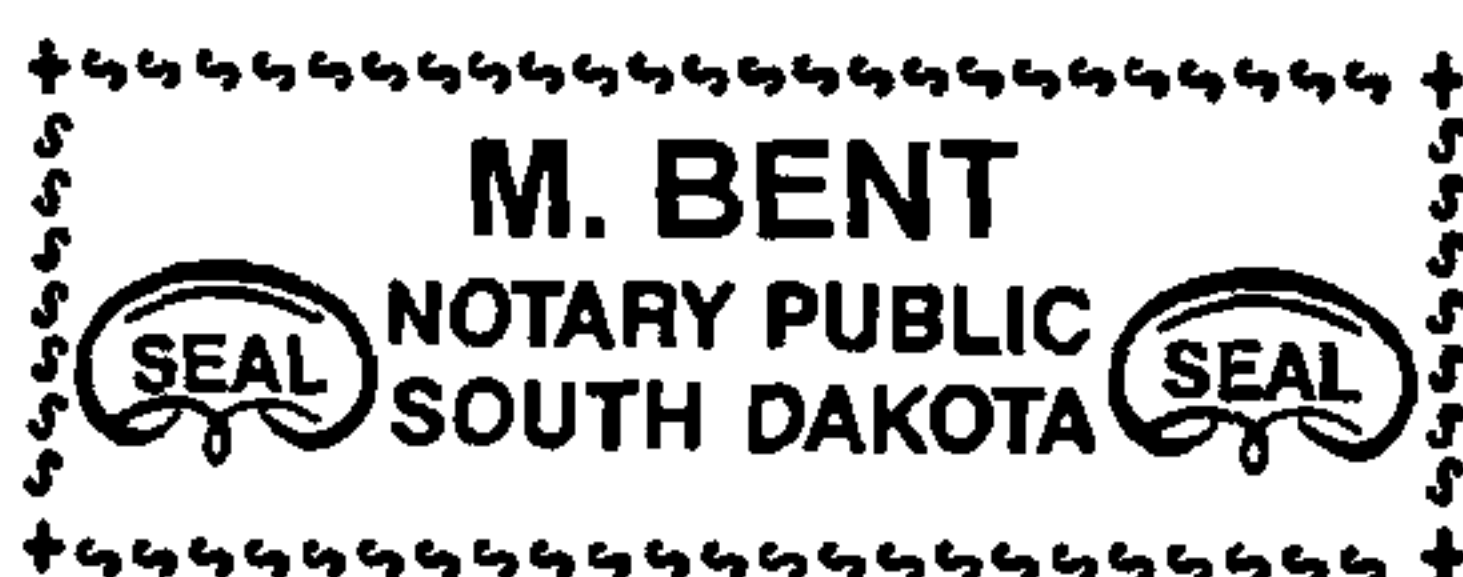
