**KNOW ALL MEN BY THESE PRESENTS,,** That in consideration of FOUR HUNDRED FORTY NINE THOUSAND ONE HUNDRED NINETY AND 00/100 D O L L A R S (\$449,190.00) and other good and valuable consideration the receipt and sufficiency whereof is hereby acknowledged, Clayton Properties Group, Inc., a TN corporation (herein referred to as GRANTOR) does by these presents grant, bargain, sell and convey unto Victoria Jackson, a single woman (herein referred to as GRANTEE, whether one or more) the following described real estate situated in SHELBY COUNTY, Alabama to-wit:


Note: \$390,000.00 of the purchase price is being paid by the proceeds of a first mortgage loan executed and recorded simultaneously herewith.

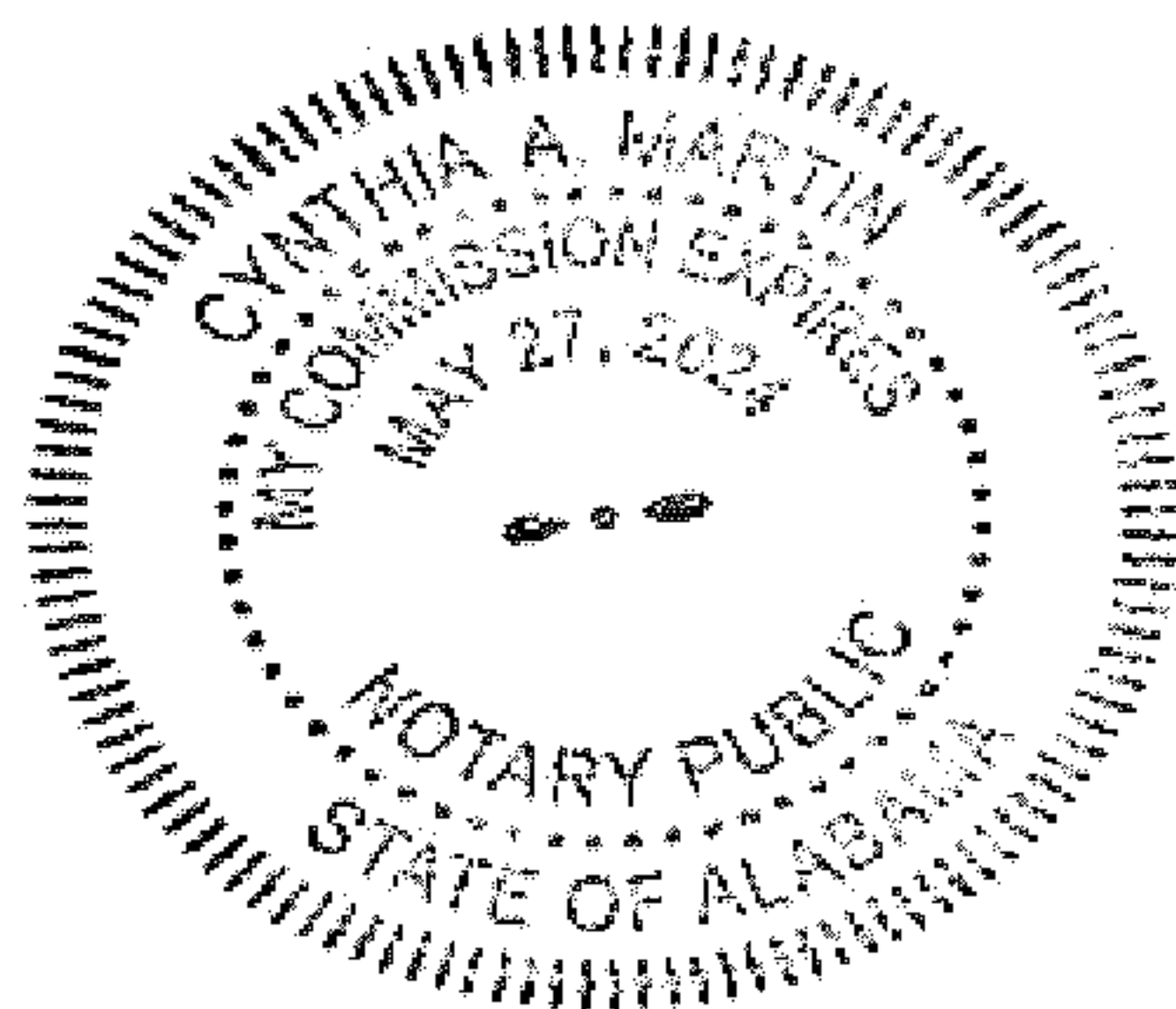



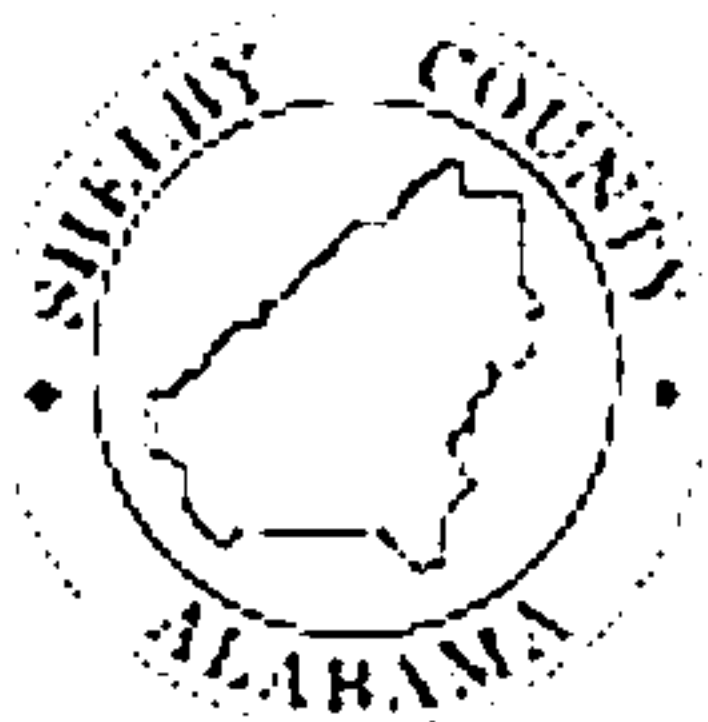
