## **CORPORATION WARRANTY DEED**

**KNOW ALL MEN BY THESE PRESENTS,** That in consideration of FIVE HUNDRED SEVENTY THOUSAND NINE HUNDRED FIFTY FIVE AND 00/100 DOLLARS (\$570,955.00) and other good and valuable consideration the receipt and sufficiency whereof is hereby acknowledged, Clayton Properties Group, Inc., a TN corporation (herein referred to as GRANTOR) does by these presents grant, bargain, sell and convey unto Jennifer Bishop McCord, a married woman (herein referred to as GRANTEE, whether one or more) the following described real estate situated in SHELBY COUNTY, Alabama to-wit:

Lot B-72, according to the Survey of Griffin Park at Eagle Point, Sector 2, Phase 2B, as recorded in Map Book 54, Page 41 A & B, in the Probate Office of Shelby County, Alabama.


Note: \$542,171.00 of the purchase price is being paid by the proceeds of a first mortgage loan executed and recorded simultaneously herewith.

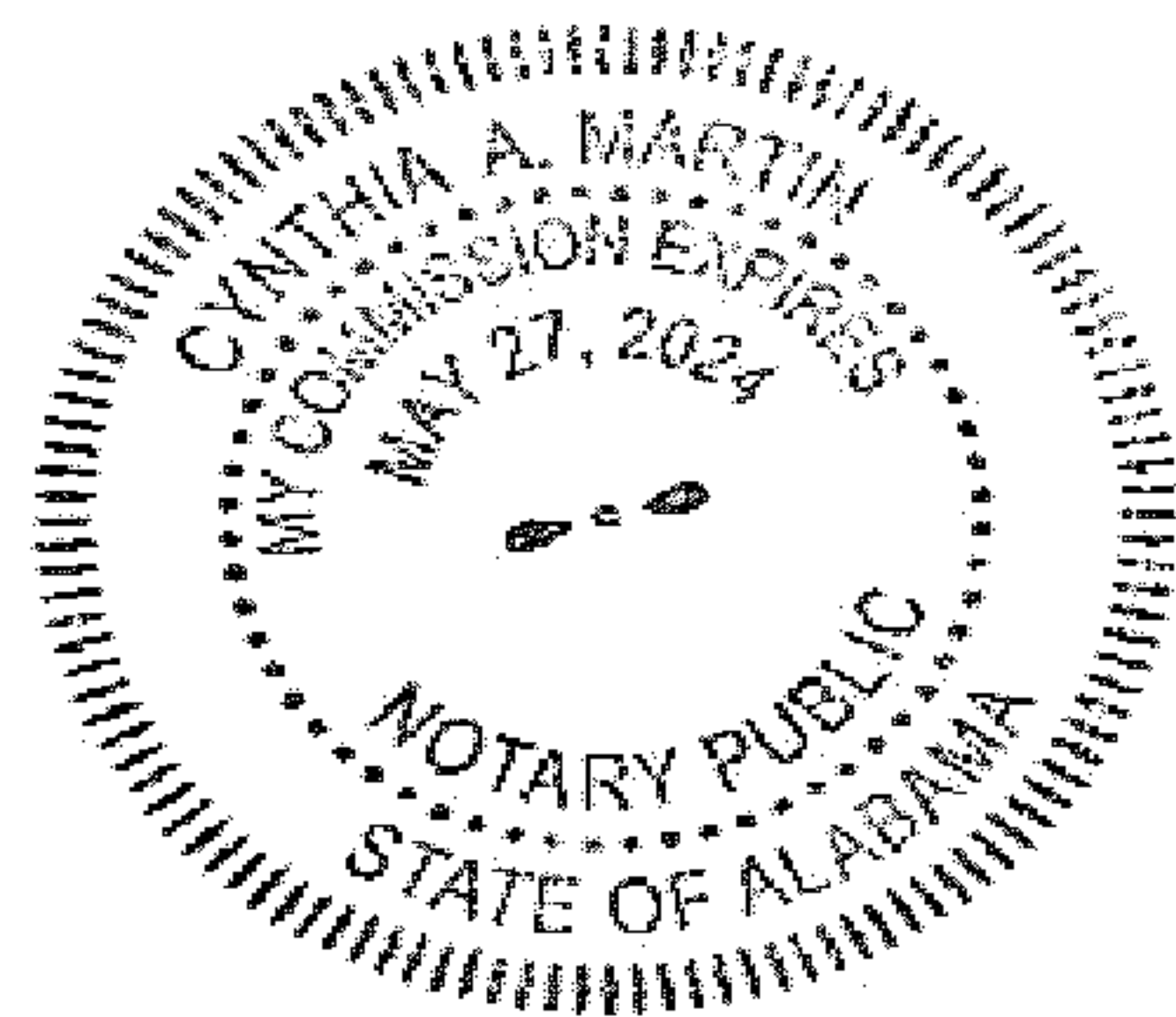

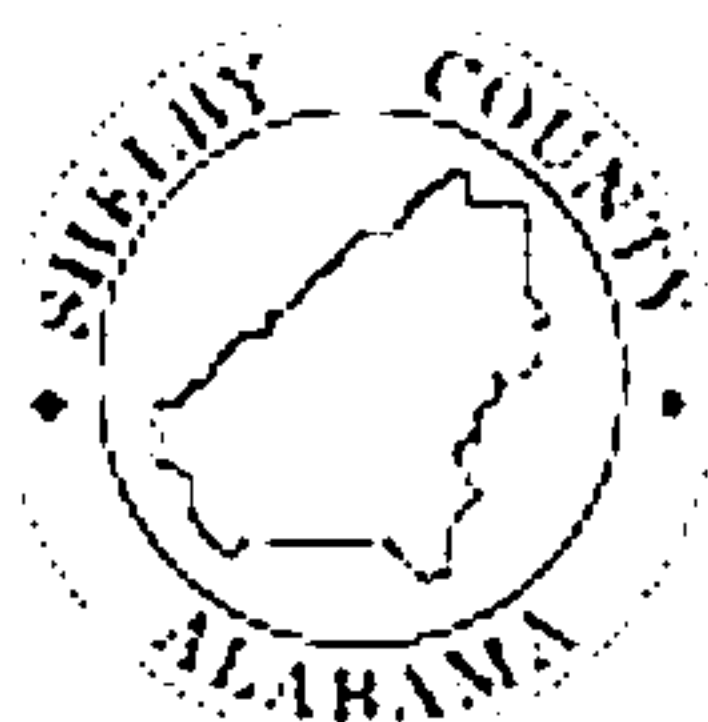
