WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS

That in consideration of **Four Hundred Twenty Five Thousand and 00/100 Dollars (\$425,000.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

David Johnston, and his wife, Debra Johnston

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

Deepak J. Basapathi and Lyndon Bishop

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Jefferson** County, Alabama to-wit:

Lot 725, according to the Final Plat Riverwoods Seventh Sector, Phase I, as recorded in Map Book 35, page 69, in the Probate Office of Shelby County, Alabama.


\$403,750.00 of the proceeds come from a mortgage recorded simultaneously herewith.

Subject to: (1) 2022 ad valorem taxes not yet due and payable;
 (2) all mineral and mining rights not owned by the Grantors; and
 (3) all easements, rights-of-way, restrictions, covenants and
 encumbrances of record.

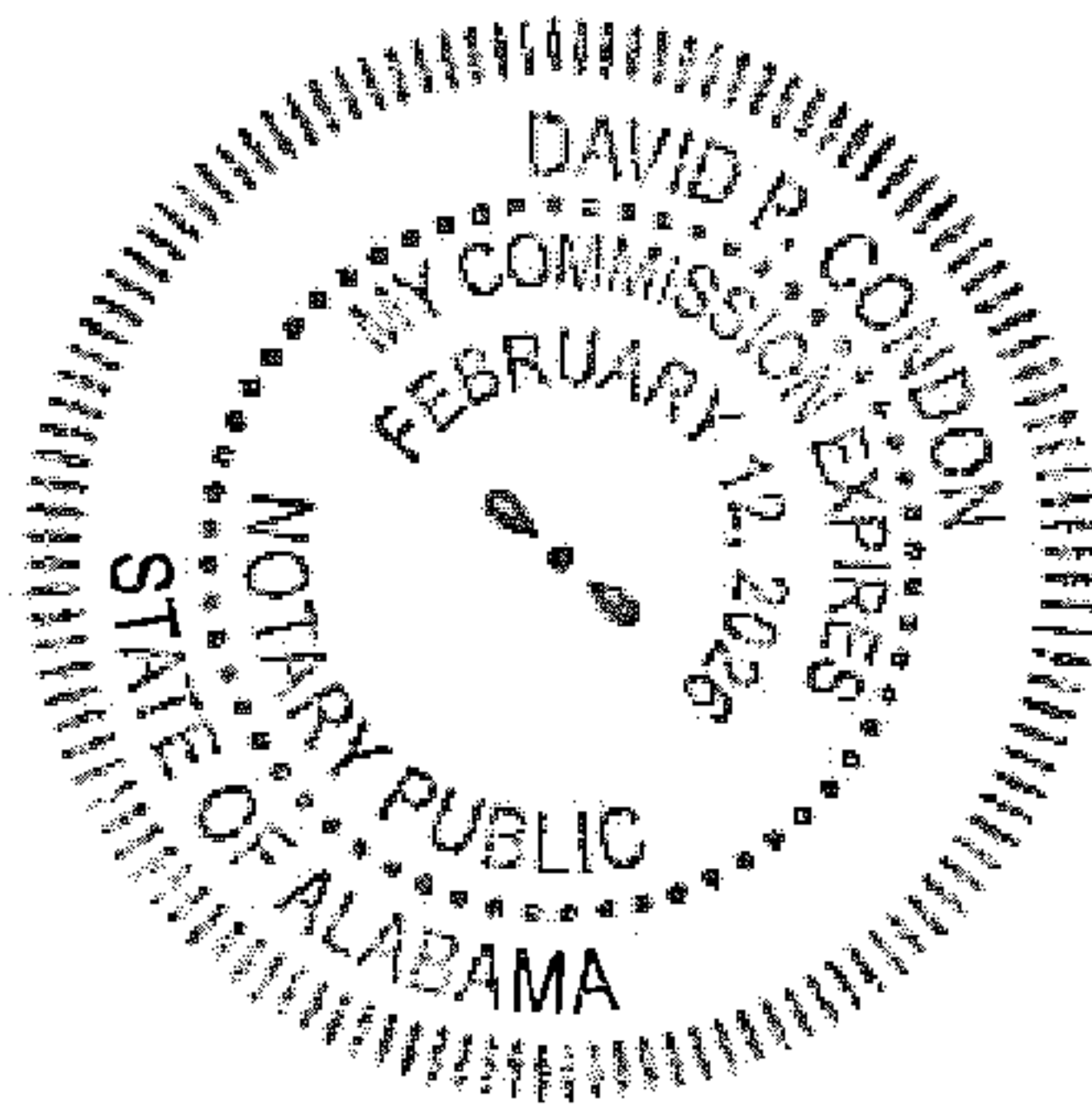
