At a point near Lat. 33° 8' 26.0874" N and Long. -86° 48' 24.696" W in the Northeast Quarter of the Northwest Quarter of Section 12, Township 22 South, Range 3 West, Shelby County, Alabama, and shown on a copy of the Power Company's Sketch of Proposed Work — Simplified W.E. No. A6170-00-DF22, attached hereto and made a part hereof as Exhibit "A."

NOW THEREFORE, in consideration of the premises and of their mutual covenants and agreements, the parties hereto have mutually covenanted and agreed as follows: The Gas Company hereby grants to the Power Company, insofar as the Gas Company has any right or title to make such grant, the right to construct, operate, and maintain the power line crossing as shown on the print hereto attached and marked Exhibit "A" but subject, however, to all the terms and conditions of the aforesaid agreement dated June 2, 1971, and the parties agree that all and singular provisions of said agreement shall apply to the transmission and distribution line crossing(s) herein described, in the same manner and to the same extent as though such crossing(s) had been included in the said agreement.
