FORECLOSURE DEED

KNOWN ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore on, to-wit, 06/30/2010, Rodney D Mines, an unmarried man, as Mortgagor, executed a Real Estate Mortgage on the property hereinafter described to MORTGAGE ELECTRONIC REGISTRATION SYSTEMS, INC., AS NOMINEE FOR DHI MORTGAGE COMPANY LTD which is recorded as Instrument # 20100713000221580, in the Office of the Judge of Probate, Shelby County, Alabama on 07/13/2010 and subsequently assigned to JPMORGAN CHASE BANK, NATIONAL ASSOCIATION and recorded as Instrument # 20220805000305840 on 08/05/2022, and,
