Effective date of deed is 9/27/2022.

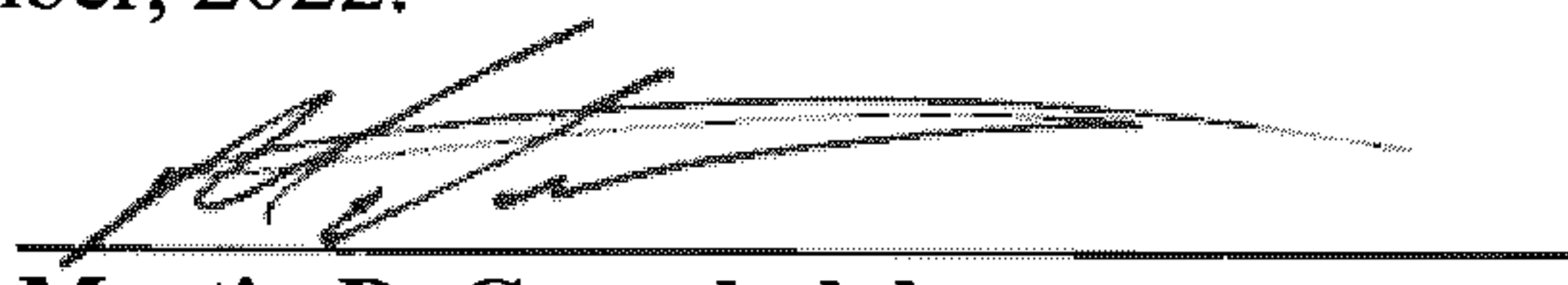

2. Easements, restrictions, reservations and conditions of record.

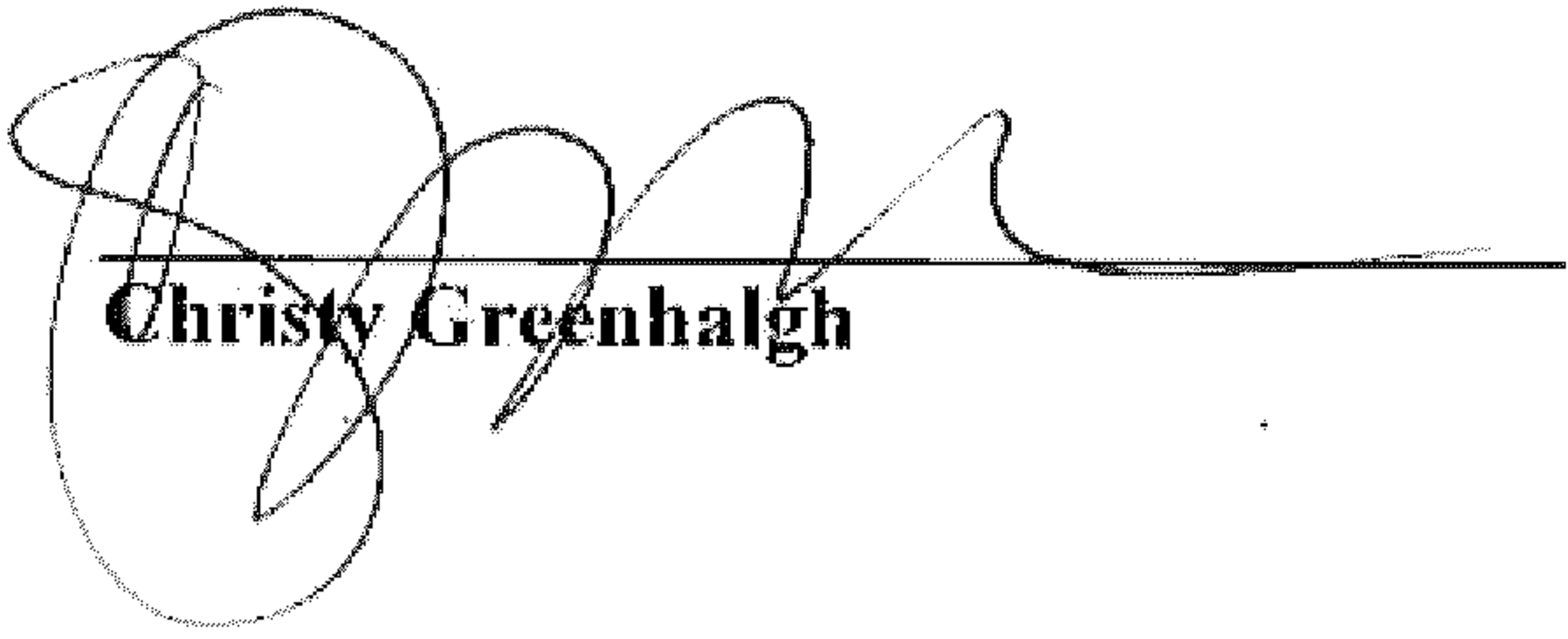

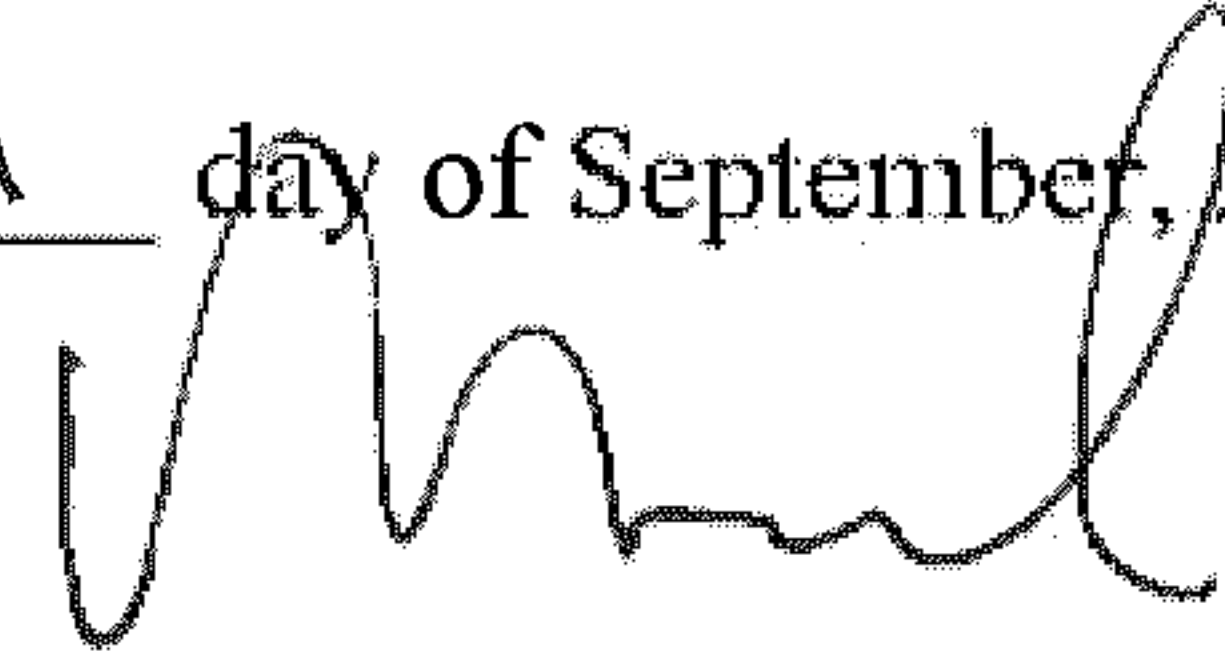

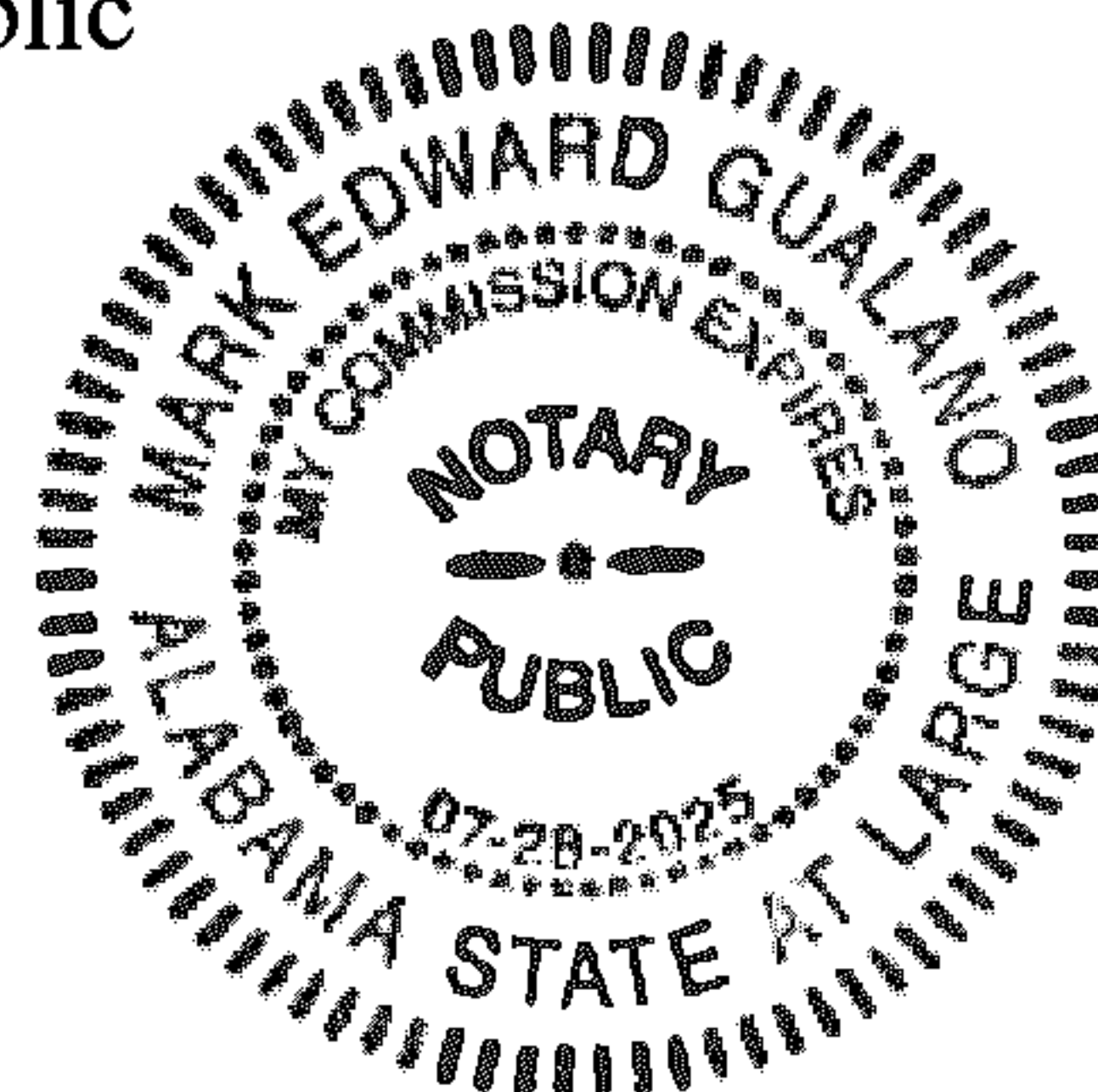
