AMENDMENT OF RESTRICTIVE COVENANTS As Recorded 07/26/2006

THIS AMENDMENT OF RESTRICTIVE COVENANTS is made this 22nd day of September 2022, by The United States Army, Corps of Engineers, Mobile District ("Corps") and Joshua and Hannah Harris ("Covenantors").

RECITALS

WHEREAS, Covenantors are the owners of a certain parcel of real property located in Shelby County, State of Alabama, (hereinafter "The Property"), and more particularly described as Shelby County Parcel Number: 13 8 34 3 002 001.000; and described in the records of the Property Tax Commissioner of Shelby County, Alabama as: "BEG NE COR NW1/4 SW1/4 SEC 34 W1327.44 S390 SE966.9 E128.73 N217.97 E415.51 N477.95 W130.09 TO POB"; and

WHEREAS, the Corps and Edwards Specialties, Inc., as a requirement of Corps Permit AL 05-02181-V, entered into a DECLARATION OF RESTRICTIVE COVENANTS (hereinafter the "DECLARATION") recorded at page # 20060726000359530 in the Records of the Judge of Probate of Shelby County, AL and recorded 07/26/2006; and

WHEREAS, The DECLARATION imposed certain restrictive covenants which protected an area of land described in that document which extends over multiple platted parcels, including a portion of the Property referenced above; and

WHEREAS the Corps has determined that the restrictions imposed by the DECLARATION, to the extent these restrictions are attached to The Property described above, no longer serve a mitigation interest and are no longer in the Public Interest.

NOW THEREFORE, in consideration of the premises and other good and valuable consideration, the Corps and Covenantor jointly AMEND the DECLARATION as follows:

- 1. The restrictive covenants described in the DECLARATION and imposed upon The Property are Hereby RELEASED. The area of The property released from the restrictive covenants is more particularly described in Exhibit A:
- 2. The restrictive covenants described in the DECLARATION and imposed upon lands outside of The Property are NOT RELEASED and remain in full force and effect.


