6. Such error was a scrivener's error and this affidavit is given for the purpose of correcting such scrivener's error.

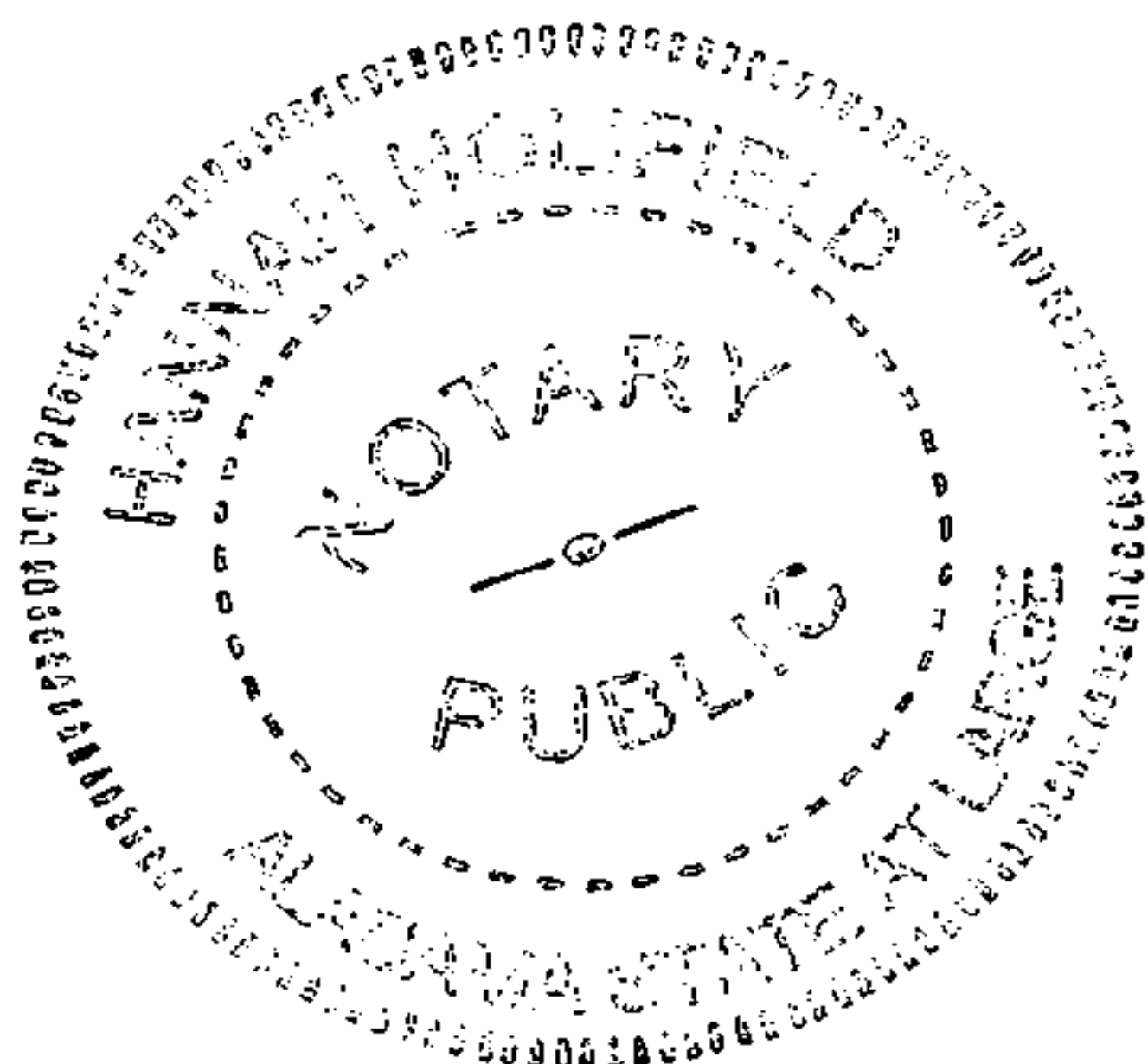



That in consideration of **Four Hundred Seventeen Thousand Nine Hundred and 00/100 (\$417,900.00) Dollars** and other good and valuable consideration paid in hand by the GRANTEES herein to the undersigned GRANTOR, the receipt and sufficiency whereof is acknowledged,

D.R. Horton, Inc. – Birmingham (herein referred to as GRANTOR, whether one or more) does, grant, bargain, sell and convey unto

Marcus Brent Lea and Anna Lea (herein referred to as GRANTEE, whether one or more), all of its right, title and interest in and to that certain real estate situated in Shelby County, Alabama, to-wit:

Lot 1342, according to the Plat of Chelsea Park 13th Sector, recorded at Map Book 55, Pages 53A and 53B, in the Office of the Judge of Probate, Shelby County, Alabama.

Mineral and mining rights excepted. Subject to: current taxes, conditions, covenants, easements and restrictions of record.



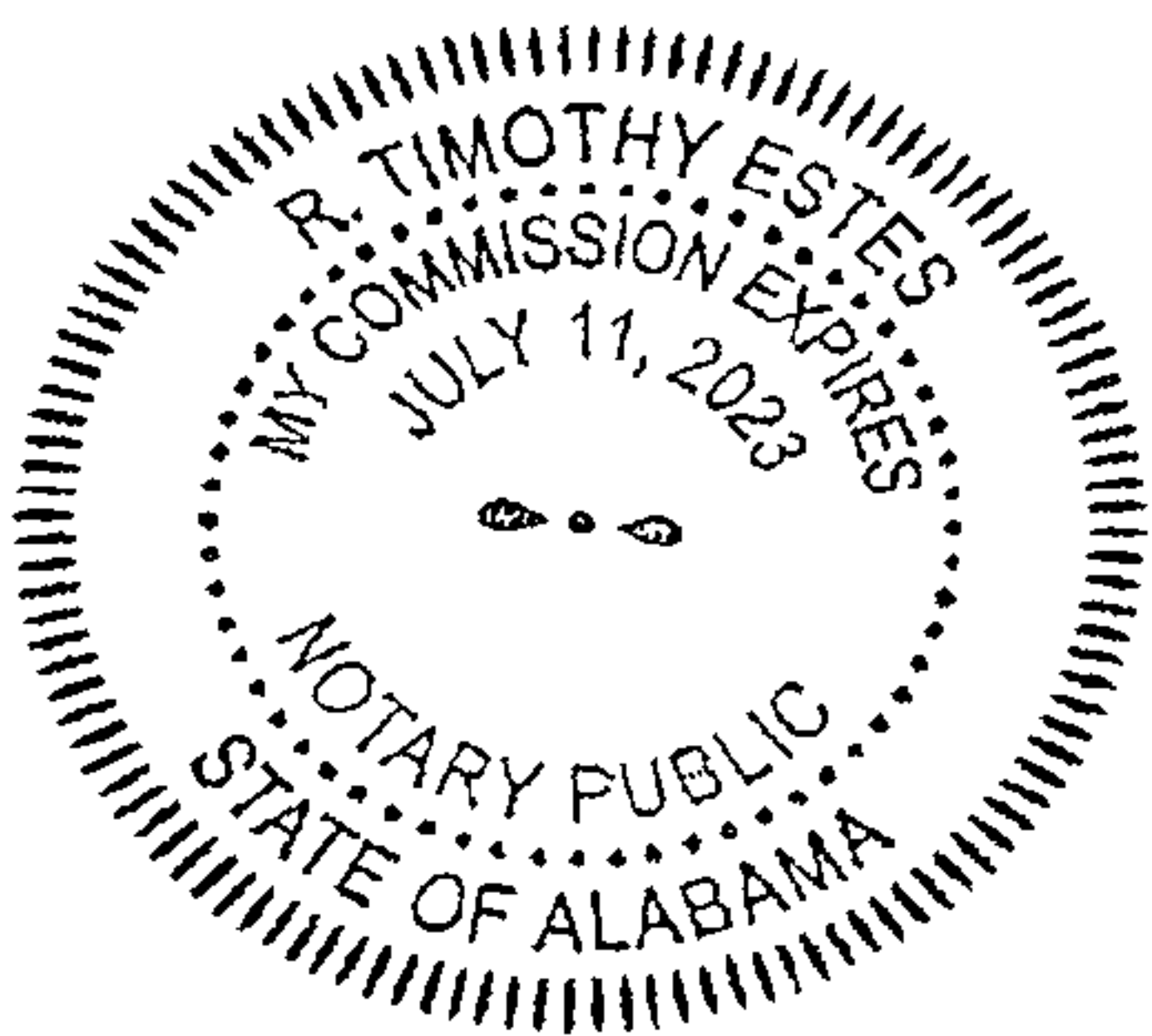


