KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on to wit, March 7, 2014, Jamie H. 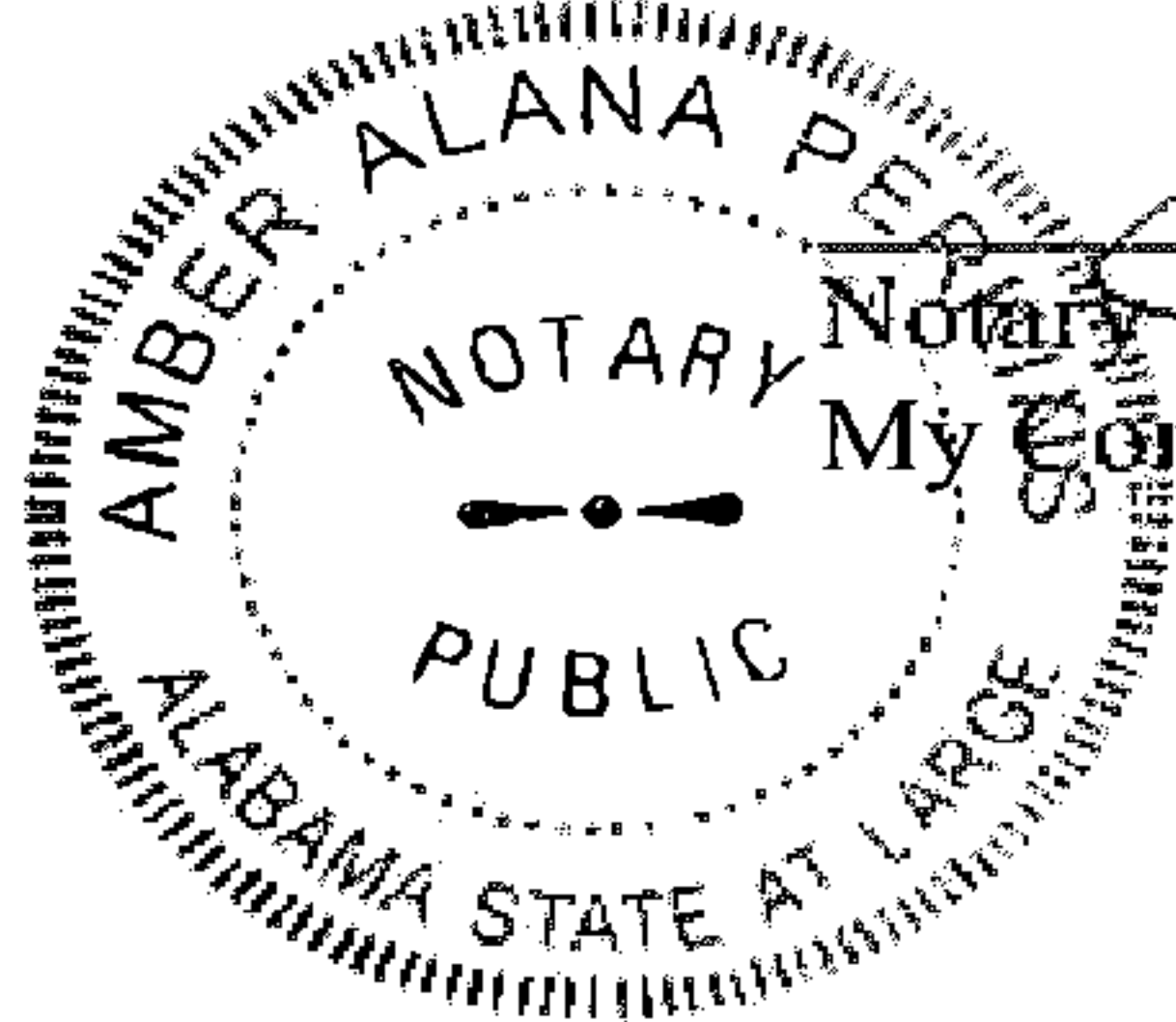

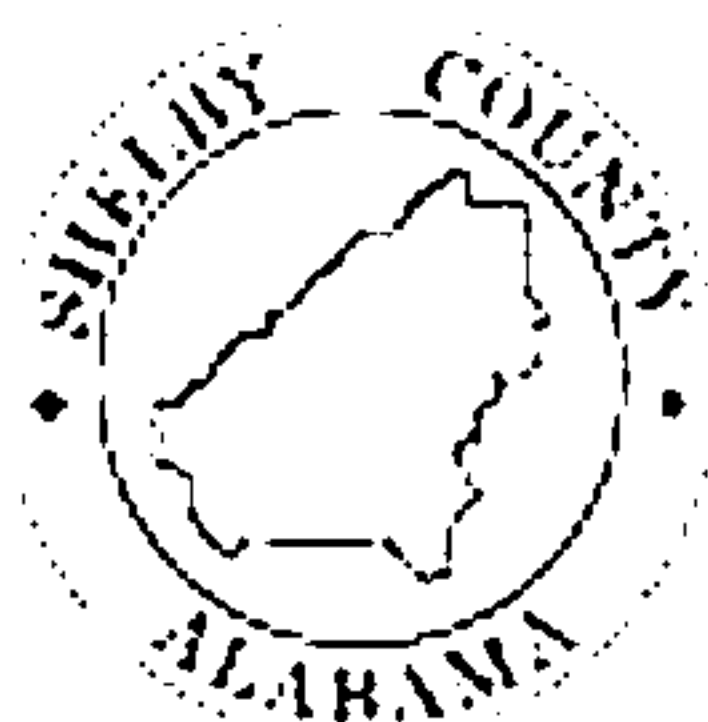
