ITEM I


DEBTS AND TAXES

In the event that there is any indebtedness owing by me, whether secured or unsecured, which has not matured at the time of my death, I authorize my executor/executrix to pay any such indebtedness as my executor may deem best advisable under the then existing circumstances. I further direct that all further estate, or any part thereof, whether or not passing under my will, shall be paid out of my residuary estate as an expense of administration without apportionment. My executor or alternate executor hereinafter named, has the power to sell any of my property to carry out the administration of the estate, without first obtaining permission of the Court.

ITEM II

I hereby will, bequeath and devise my homestead, consisting of a house and lot, located at: 137 Blackstone Court, Chelsea, Alabama 35043, and the contents thereof, to my beloved son, Derrell Jarmaine Blackmon, to be his in fee simple absolute.

In the event, son, Derrell Jarmaine Blackmon, should predecease me of if he and I should die simultaneously in what is known as a common disaster, in either event, I hereby will, bequeath and devise my homestead, consisting of a house and lot, located at: 137 Blackstone Court, Chelsea, Alabama 35043, and the contents thereof, to my beloved children, Jimmie Darnell Blackmon and Danyetta Janae Blackmon, to be theirs in fee simple

ITEM III

ITEM IV

I hereby will, bequeath and devise the rest, residue and remainder of my property, both real, personal, mixed, tangible and intangible, wheresoever situated, lying and being, to my beloved children: Derrell Jarmaine Blackmon, Jimmie Darnell Blackmon, and Danyetta Janae Blackmon, to be theirs in fee simple absolute, per capita.

ITEM V

Should there be any other child or children known to me at the time of the making of this will or at the time of my death, I hereby will, bequeath and devise to the said child or children the sum of One (\$1.00) Dollar.

ITEM VI

I hereby appoint, name, nominate and constitute my beloved son, Derrell Jarmaine Blackmon, as my executor of and under this my last will and testament, and direct and provide that no security, bond, inventory, accounting, or final settlement be required of him as my executor. My executor is invested with all power to sell any of my property necessary to carry out the administration of my estate without first obtaining permission from the Court.

ITEM VII

In the event my son, Derrell Blackmon, should not qualify or complete the administration of my estate, I hereby appoint, name, nominate and constitute my beloved daughter, Danyetta Janae Blackmon, as alternate executor of and under this my last will and testament, and direct and provide that no security, bond, inventory, accounting or final settlement, be required of her as my alternate executor. My alternate executor is invested with all power to sell any of my property to carry out the administration of my estate without first obtaining permission from the Court.
