FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on to wit, May 25, 2018, Richard F. Fox Sr. AKA Richard F. Fox and Myrtle A. Fox, married, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. as nominee for New Day Financial, LLC., which said mortgage was recorded in Instrument 20180601000193850 in the Office of the Judge of Probate of Shelby County, Alabama; said mortgage subsequently transferred and assigned to Freedom Mortgage Corporation by instrument recorded in Instrument Number 20220617000243530 in the aforesaid Probate Office Transferee and

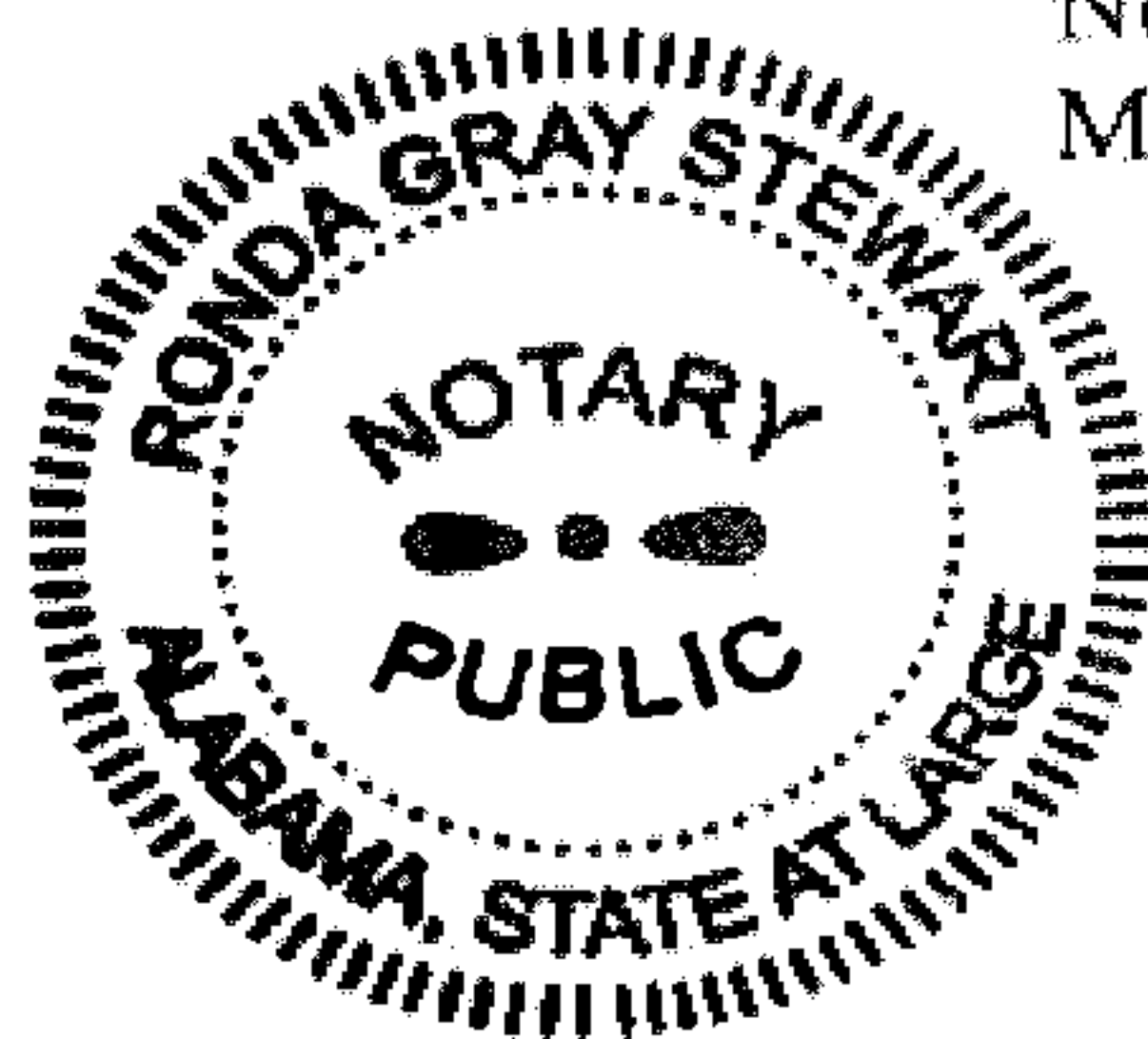
