KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on to wit, August 8, 2002, Connie D. Phillips, a single woman; Billy P. Summerlin, Jr. a single man, executed that certain mortgage on real property hereinafter described to New South Federal Savings Bank, which said mortgage was recorded in Instrument Number 20020812000379240 in the Office of the Judge of Probate of Shelby County, Alabama; said mortgage subsequently transferred and assigned to PennyMac Loan Services, LLC by instrument recorded in Instrument No. 20140307000064660 in the aforesaid Probate Office Transferee and

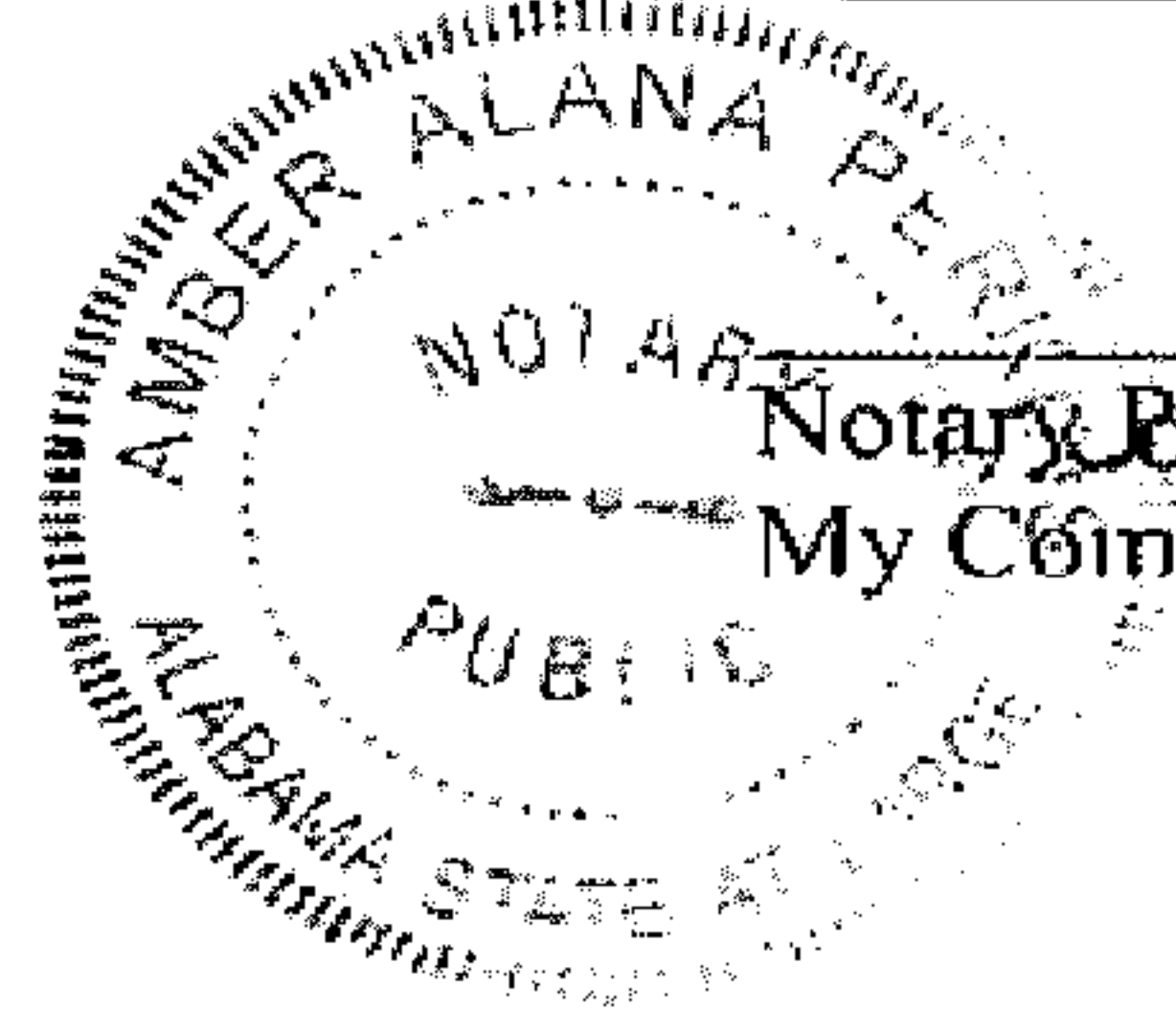

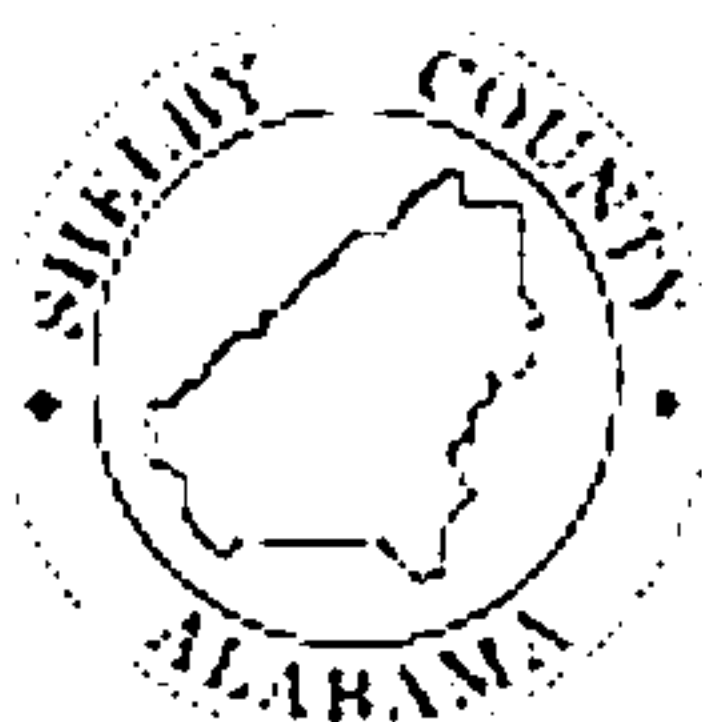
