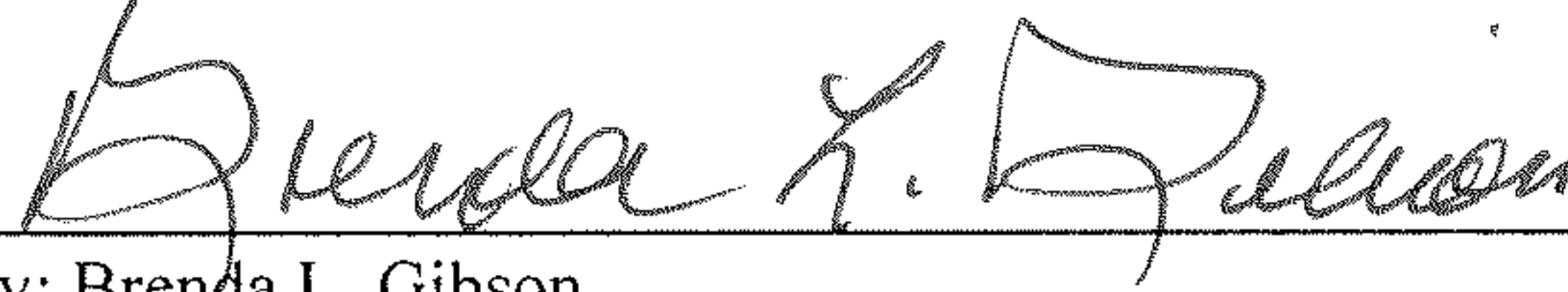
TO HAVE AND TO HOLD, unto the said GRANTEE, her/his heirs and assigns forever.

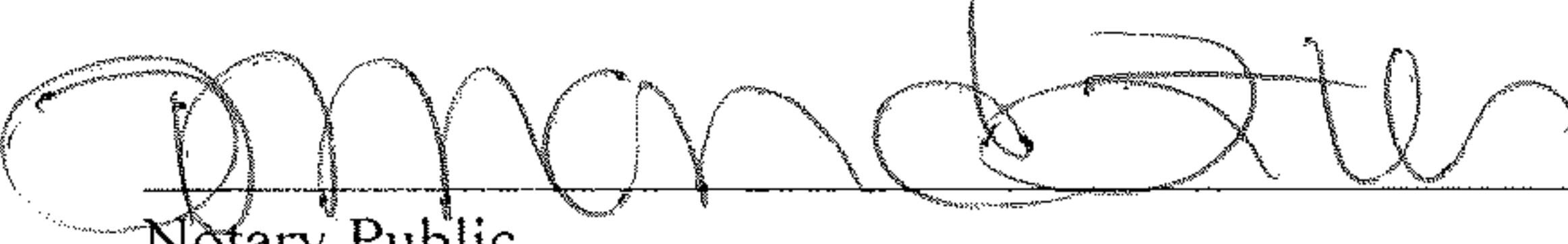
