That in consideration of **FOUR HUNDRED FIFTEEN THOUSAND AND 00/100 DOLLARS (\$415,000.00)**, to the undersigned Grantor in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, we, **Neil W. Popejoy and Debra Popejoy, a married couple**, (herein referred to as Grantors) do hereby grant, bargain, sell and convey unto **Carlos Alberto Angelo and Dakota MacKenzie Angelo**, as joint tenants with right of survivorship (herein referred to as Grantees), the following described real estate situated in Shelby County, Alabama, to-wit:

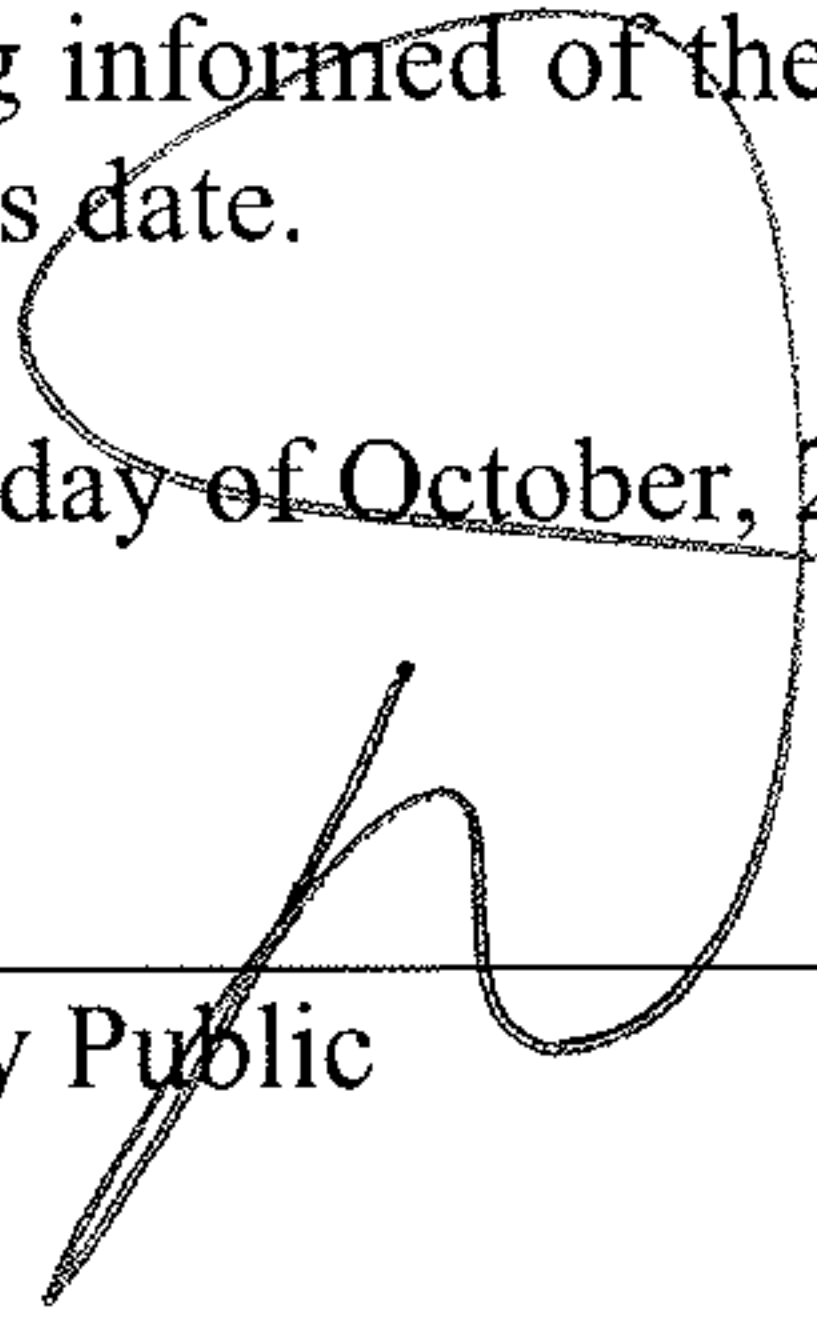

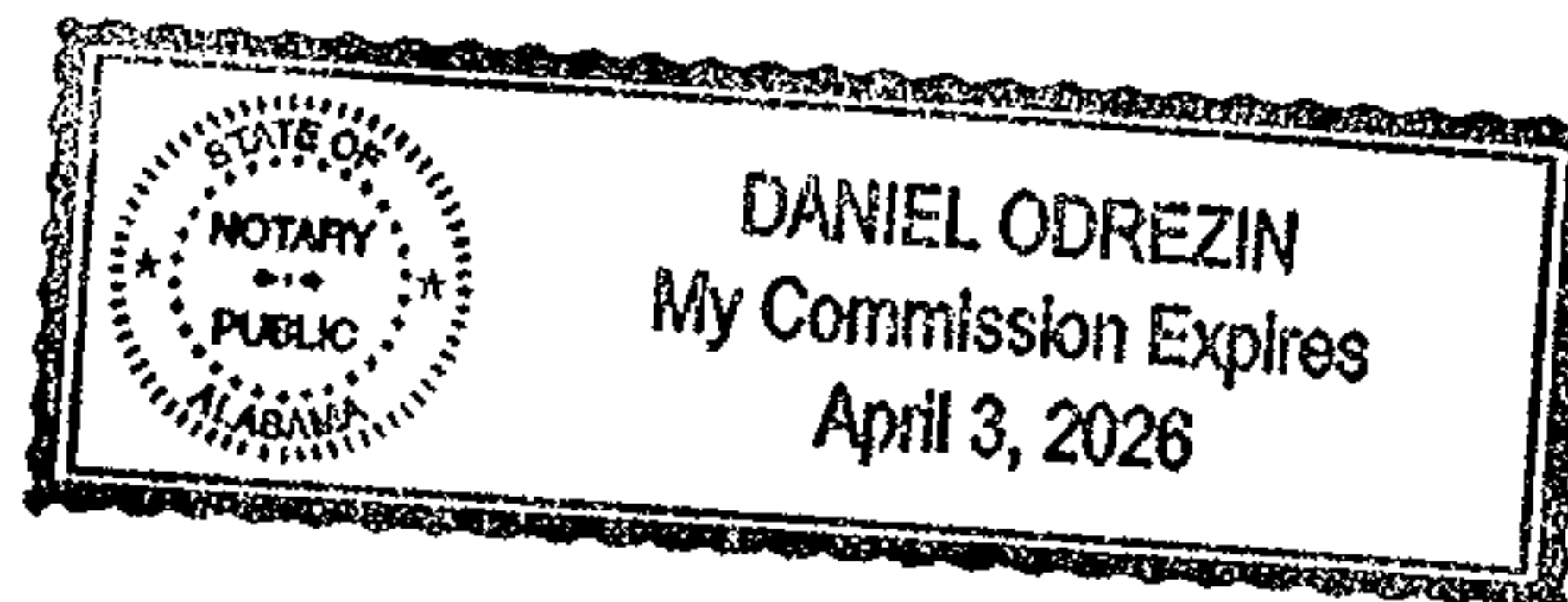
