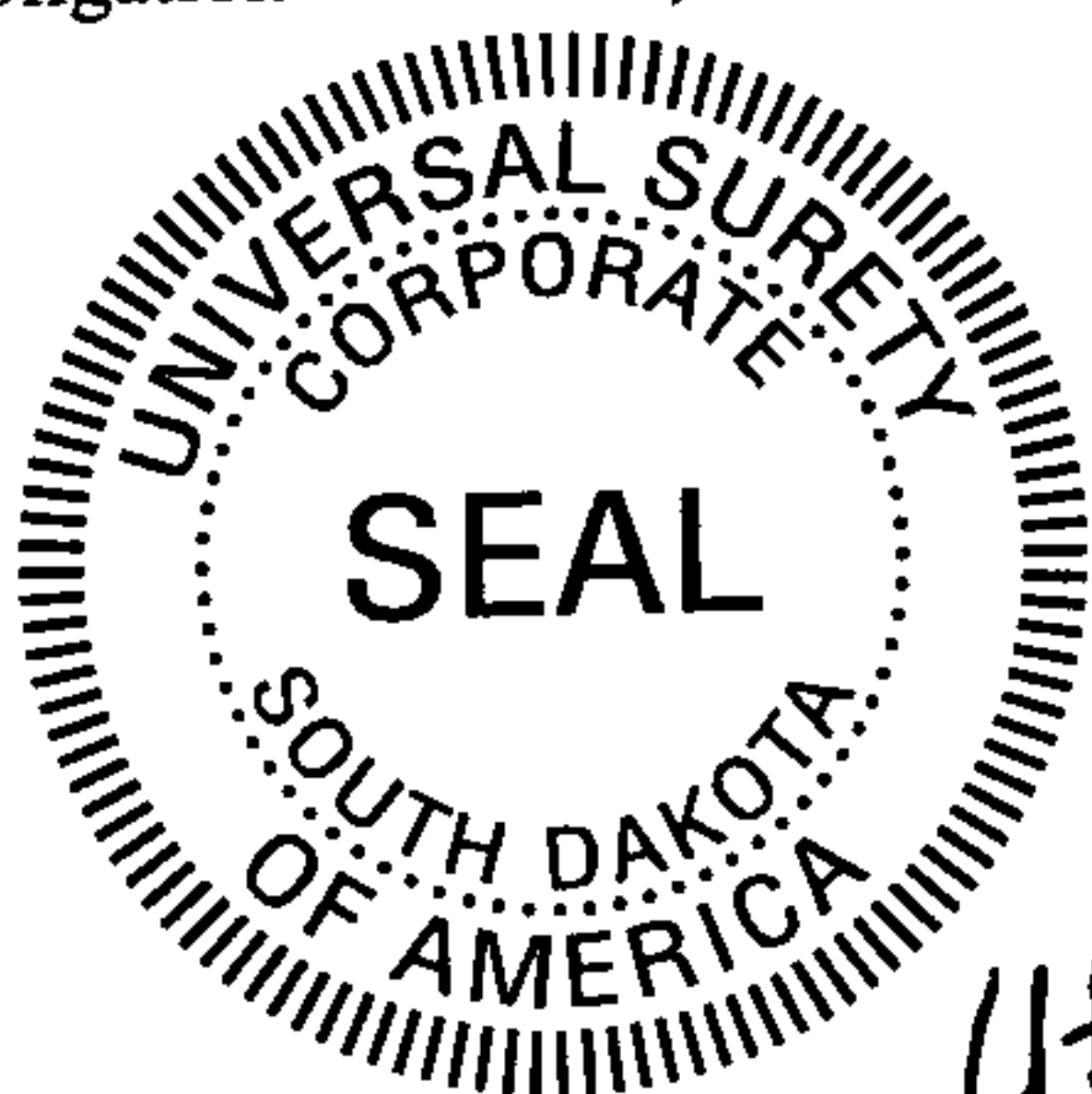

## OATH OF OFFICE

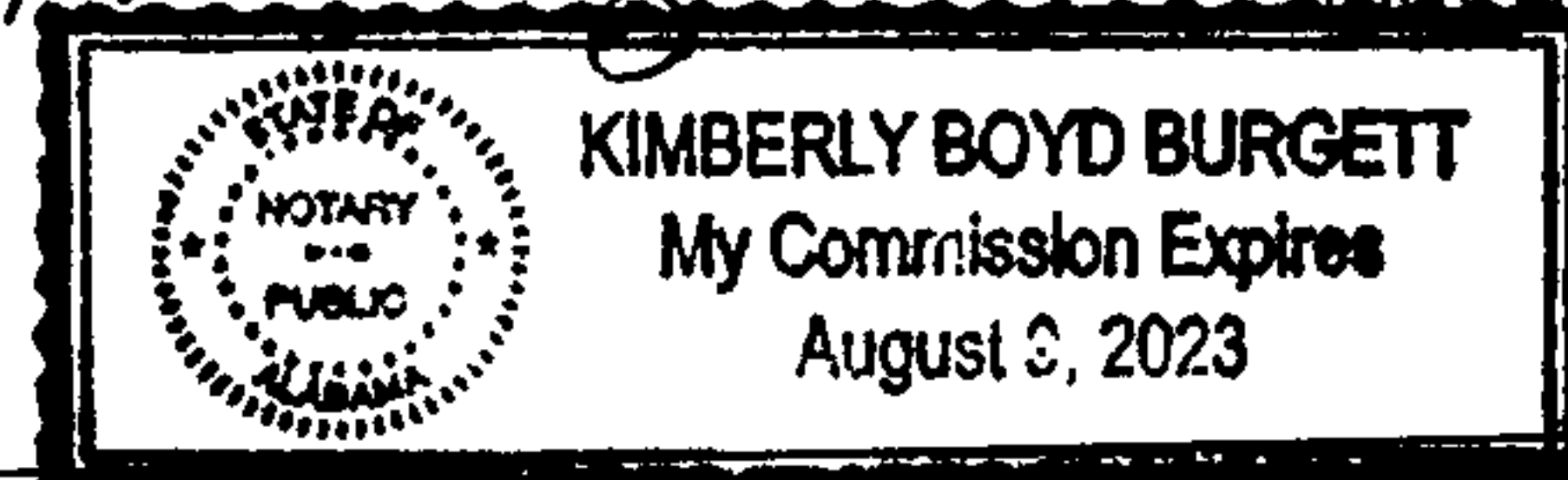

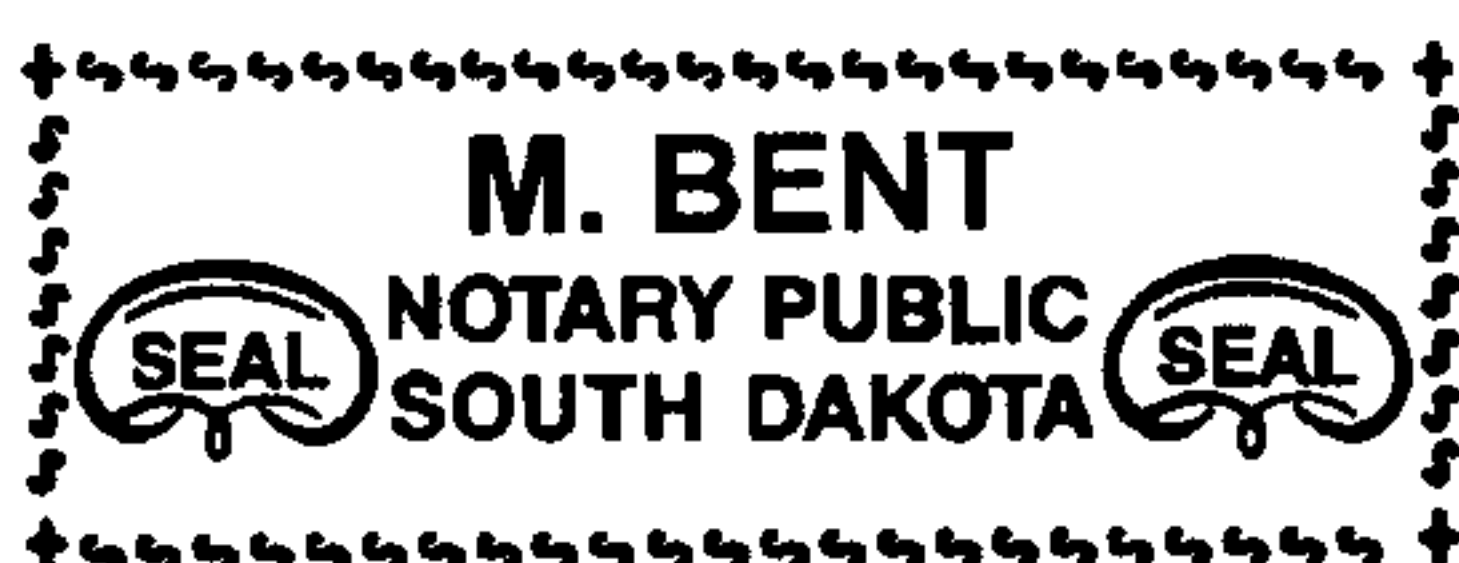
