Probate Office of Shelby County, Alabama.**

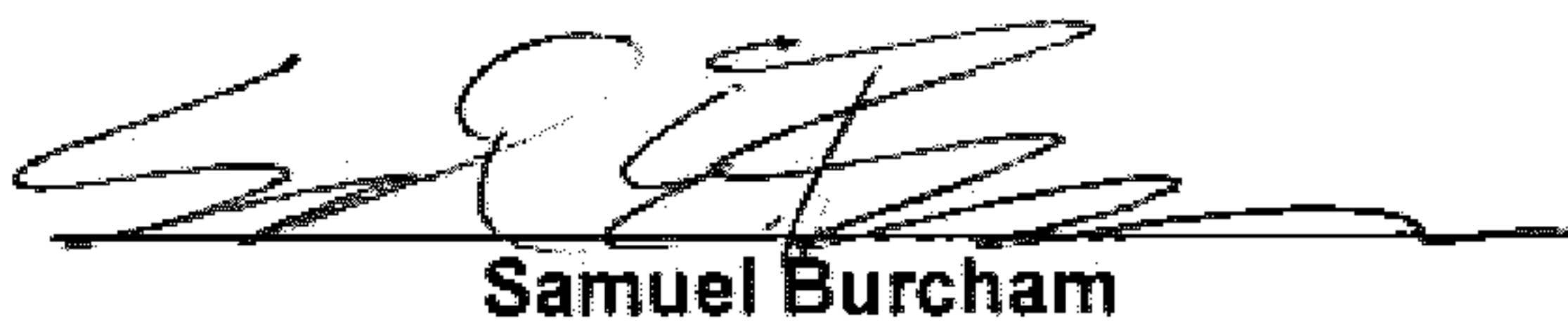
\$294,500.00 of the proceeds come from a mortgage recorded simultaneously herewith.

encumbrances of record.

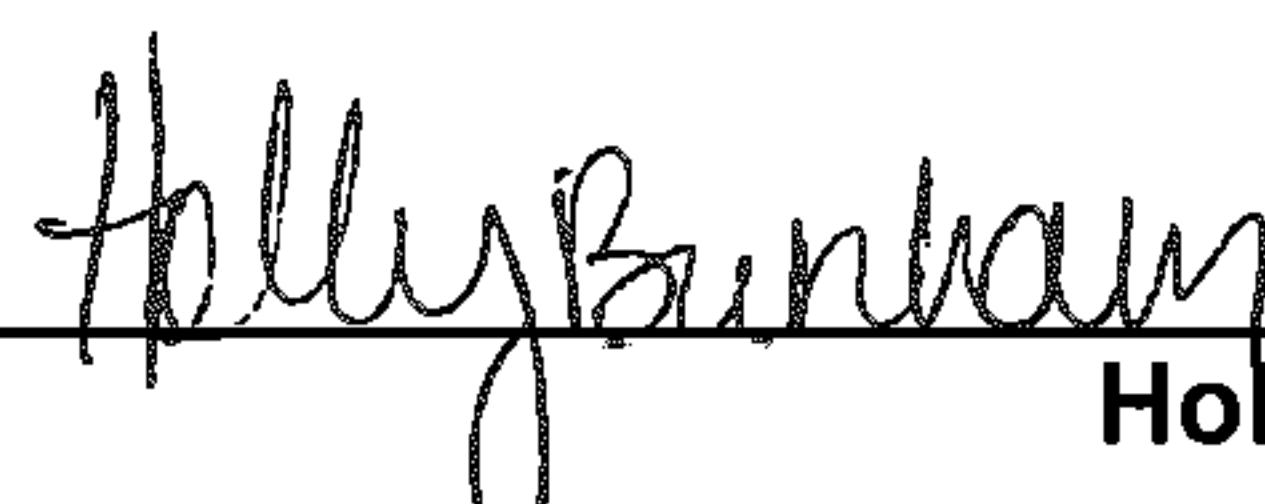
TO HAVE AND TO HOLD unto Grantees as joint tenants, with right of survivorship, their

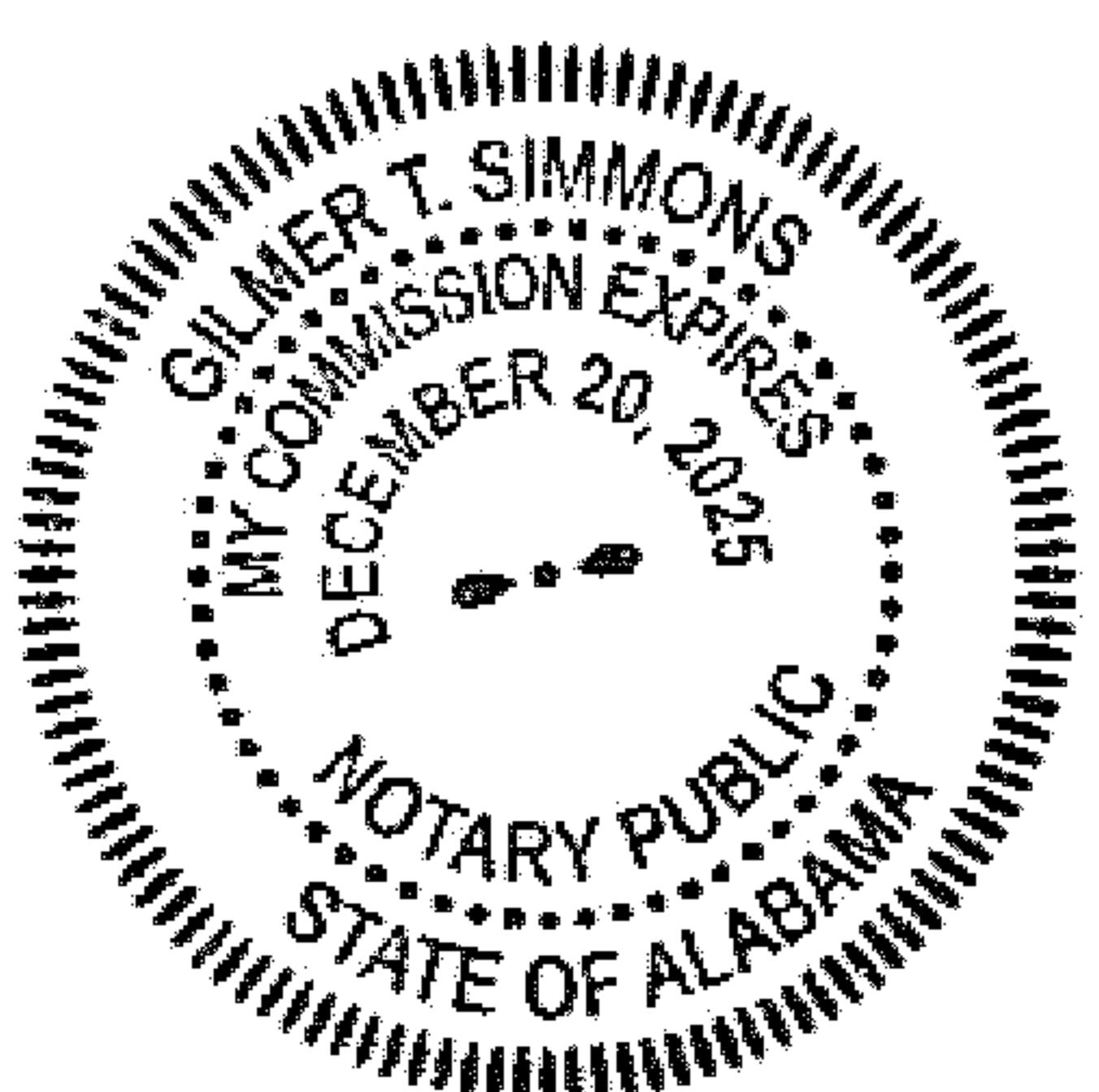
