WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

That in consideration of **Three Hundred Twenty Five Thousand and 00/100 Dollars (\$325,000.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, we,

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

Wendy Lozynsky and Michael Lozynsky

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:

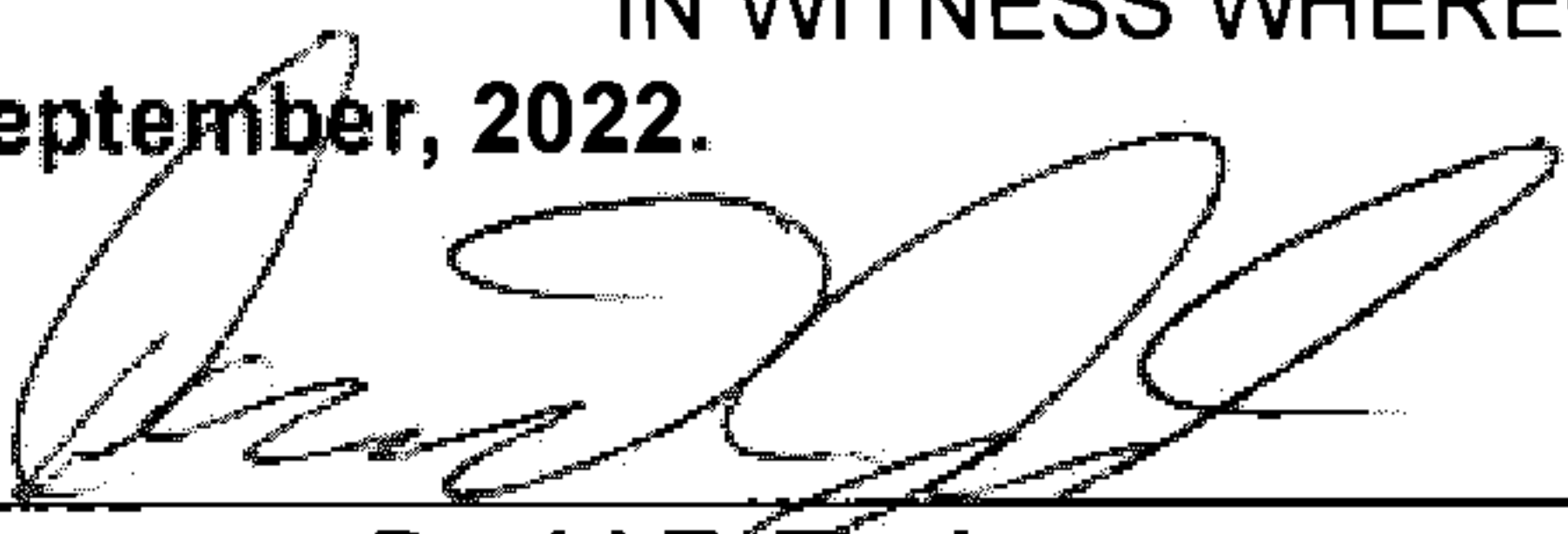
\$319,113.00 of the proceeds come from a mortgage recorded simultaneously herewith.

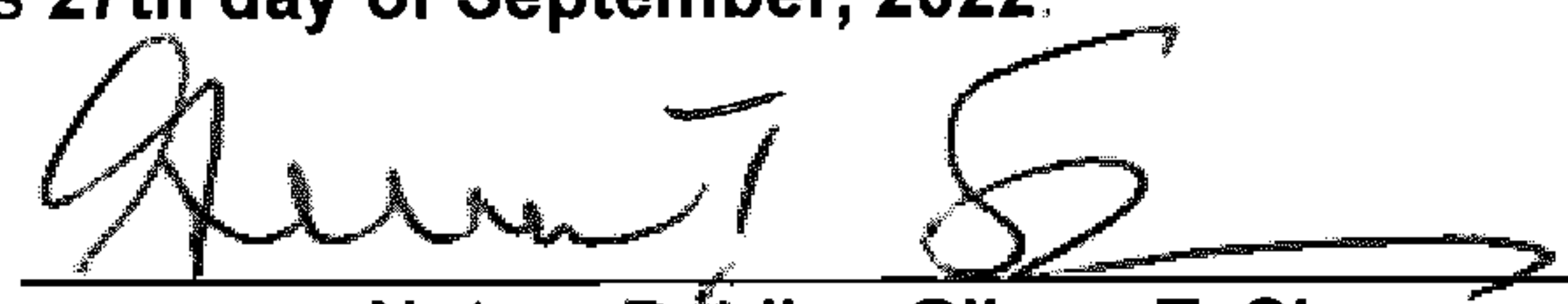

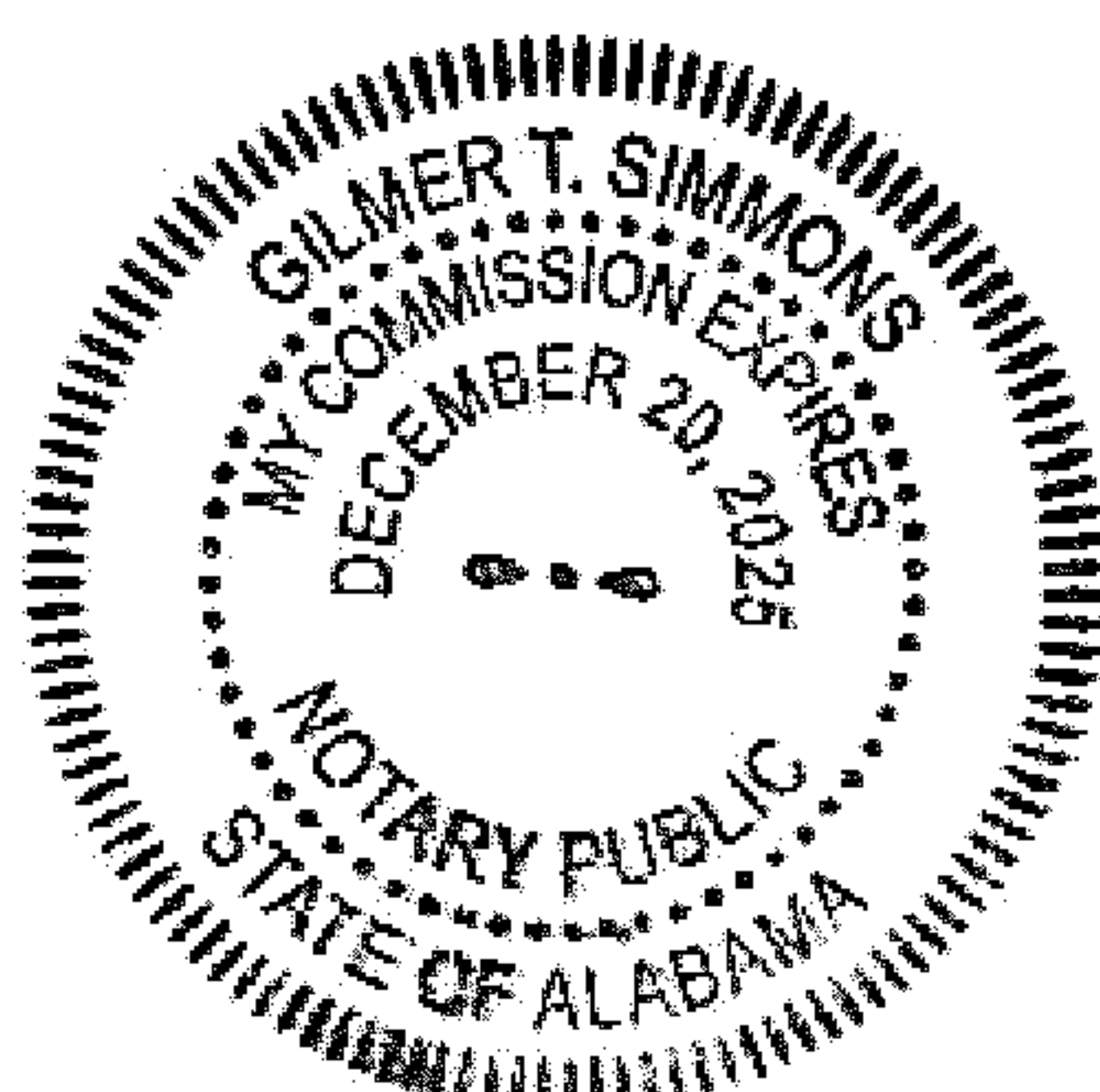
