WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP

**STATE OF ALABAMA
COUNTY OF SHELBY**

KNOW ALL MEN BY THESE PRESENTS,

On this October 4, 2022, That for and in consideration of **SEVEN HUNDRED FIFTY THOUSAND AND NO/100 (\$750,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned GRANTORS **CAROL SITTON (WHO IS ONE AND THE SAME PERSON FORMERLY KNOWN AS CAROL CLARK GOULD) and DALE SITTON, wife and husband**, (herein referred to as "Grantor"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **MATTHEW MILTON and SARAH REBECCA MILTON**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 15, according to the Survey of Windwood Circle, as recorded in Map Book 6, Page 154, in the Office of the Judge of Probate of Shelby County, Alabama.

Subject to:

1. General and special taxes or assessments for the year 2022 and subsequent years not yet due and payable.-
2. Municipal improvements, taxes, assessments, and fire district dues against subject property, if any.
3. Mineral and mining rights not owned by Grantor.
4. Any applicable zoning ordinances.
5. Easements, encroachments, building set back lines, rights-of-ways as shown of record by recorded plat or other recorded instrument, including any amendments thereto.
6. All matters, facts, easements, restrictions, assessments, covenants, agreements and all other terms and provisions in Map Book 6, Page 154.

Carol Sitton (who is one and the same person formerly known as Carol Clark Gould) is the surviving grantee of that certain deed filed of record in Book 286, Page 84; the other grantee, Jon Harvey Gould having died on or about October 6, 2019. Carol Clark Gould and Jon Harvey Gould were legally married and no proceeding for annulment or divorce had been filed or initiated at the time of his death.

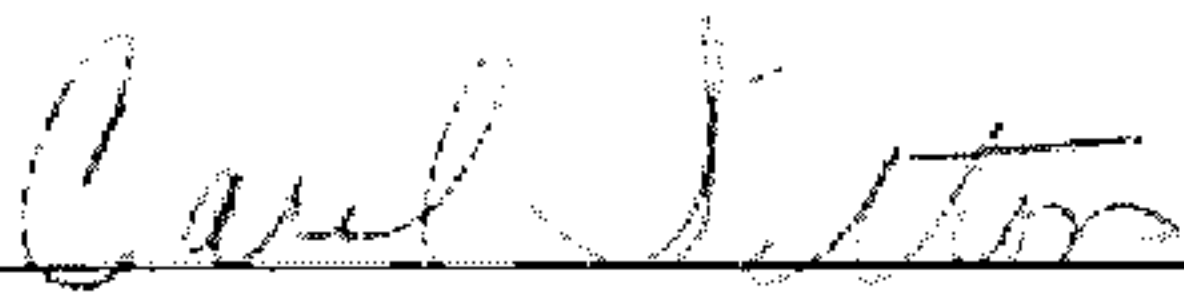
The purchase of the herein described real property is being financed in whole or in part by the proceeds of a purchase money mortgage being executed simultaneously herewith.

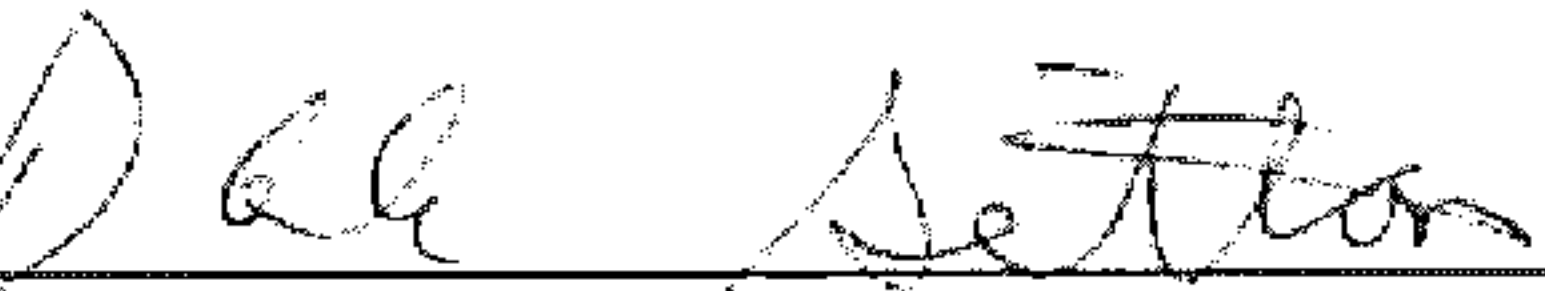

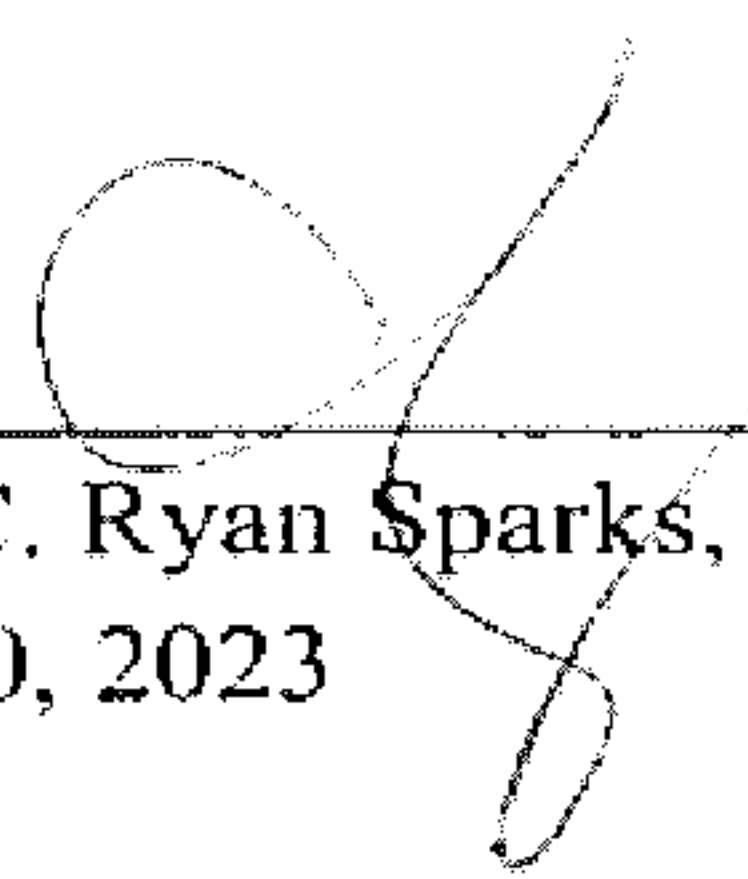
