Boan and Stephanie Boan, a married couple (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Jason Brian Hardy and Emily R. Hardy, a married couple (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.

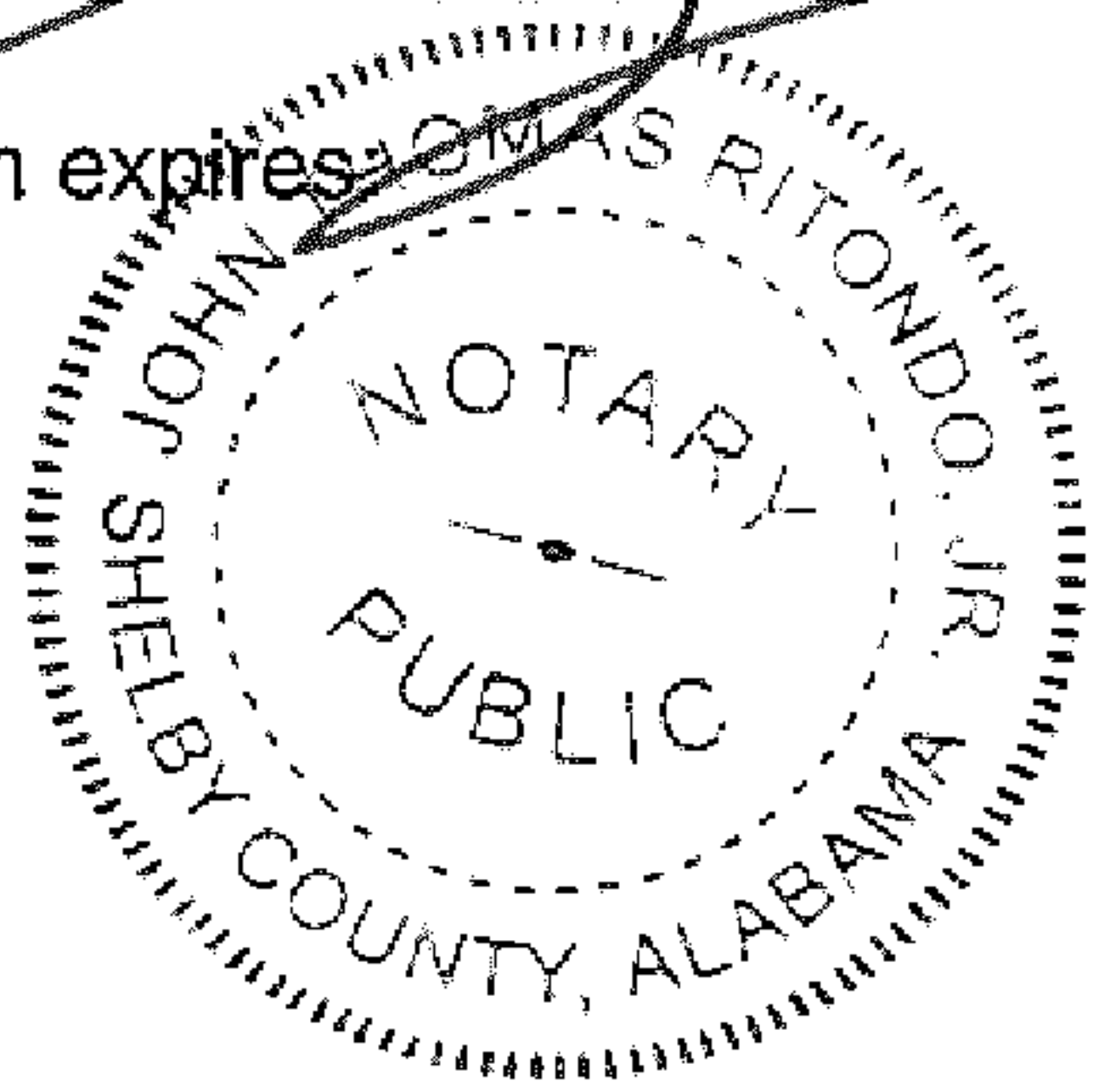

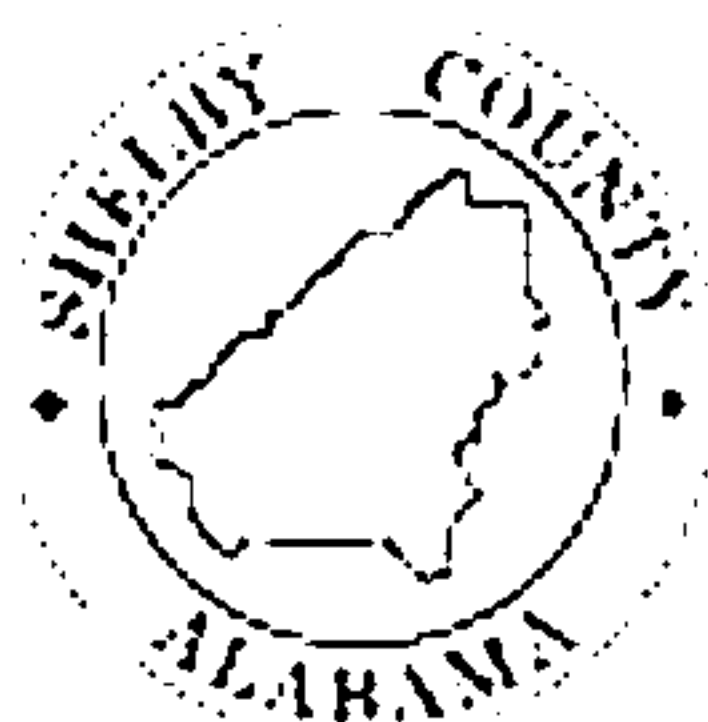
