Know All Men by These Presents: That in consideration of **Five Hundred Sixty-One Thousand Five Hundred Fifty and no/100 Dollars (\$561,550.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt where is acknowledged, **DONOVAN BUILDERS, LLC** (herein referred to as Grantor), grant, bargain, sell and convey unto **JESSIE W. WOODARD and KENDAL J. WOODARD** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:

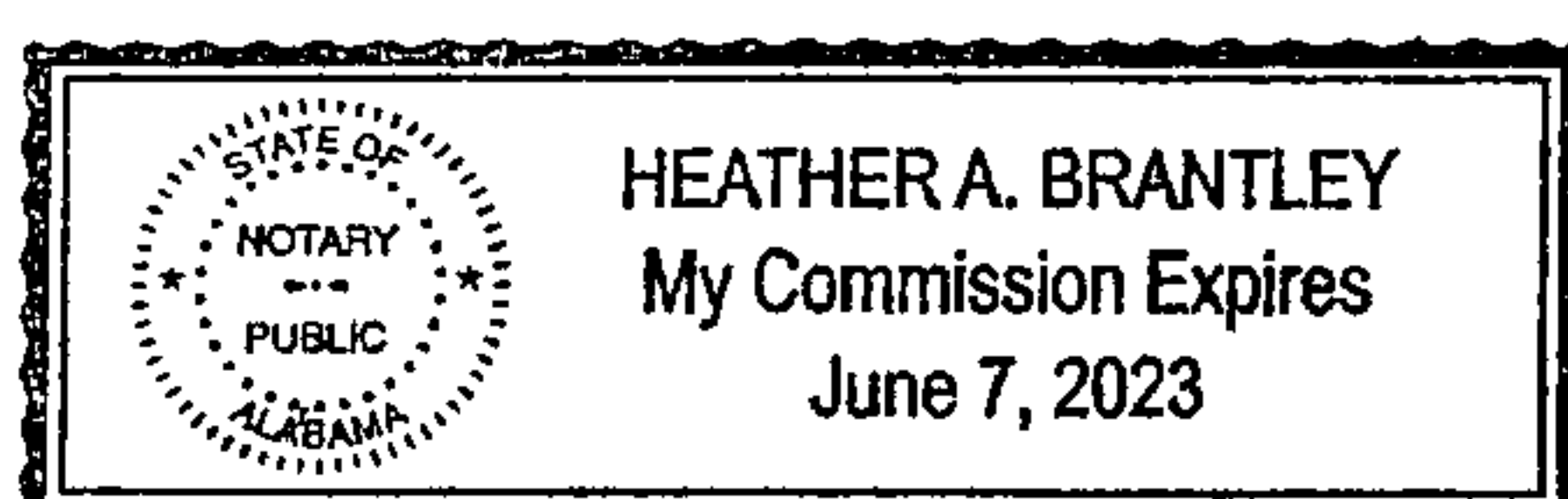

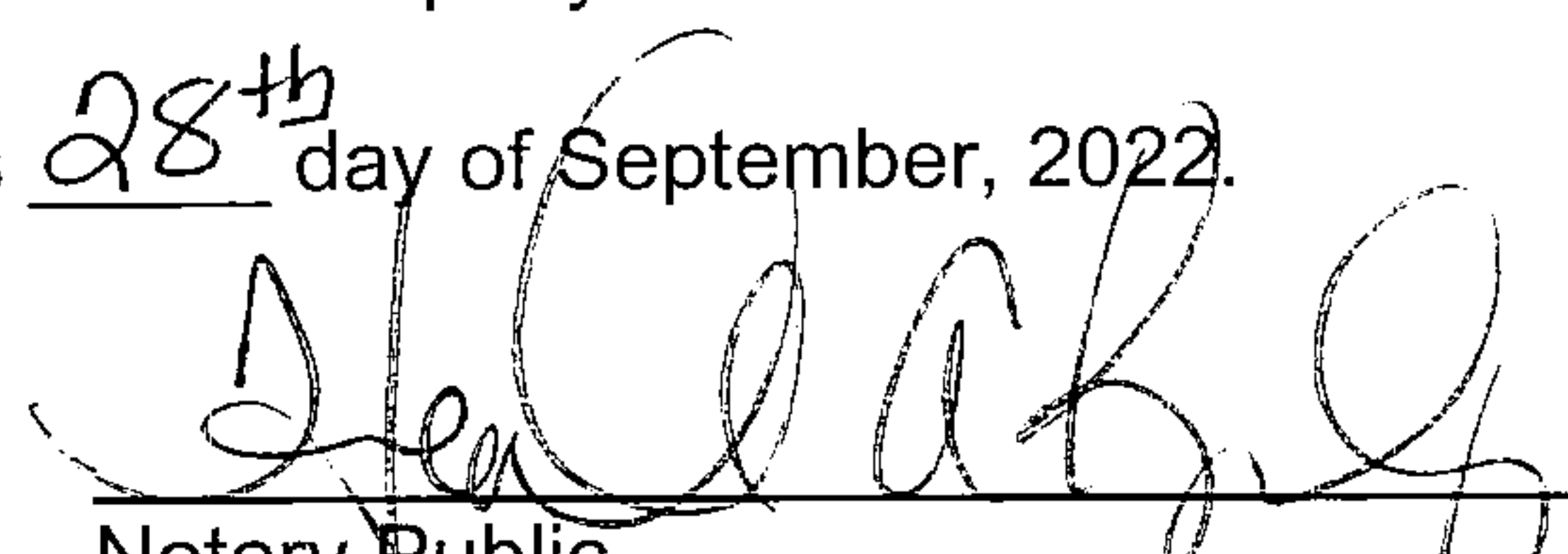
