Know All Men by These Presents: That in consideration of **Three Hundred Twenty-Two Thousand One Hundred Fifty and 00/100 Dollars (\$322,150.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt where is acknowledged, **SDH ALABAMA, LLC, a Georgia Limited Liability Company** (herein referred to as Grantor) grant, bargain, sell and convey unto **FREDRICK JONATHAN EDDIE HOUSTON, SR. and JANIE LEIGH HOUSTON** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:

And the Grantor does for itself, its successors and assigns, covenant with said Grantees, their heirs and assigns, that it is lawfully seized in fee simple of said premises; that it is free from all encumbrances, unless otherwise stated above; that it has a good right to sell and convey the same as aforesaid; that it will and its successors and assigns shall warrant and defend the same to the said Grantees, their heirs and assigns forever, against the lawful claims of all persons.

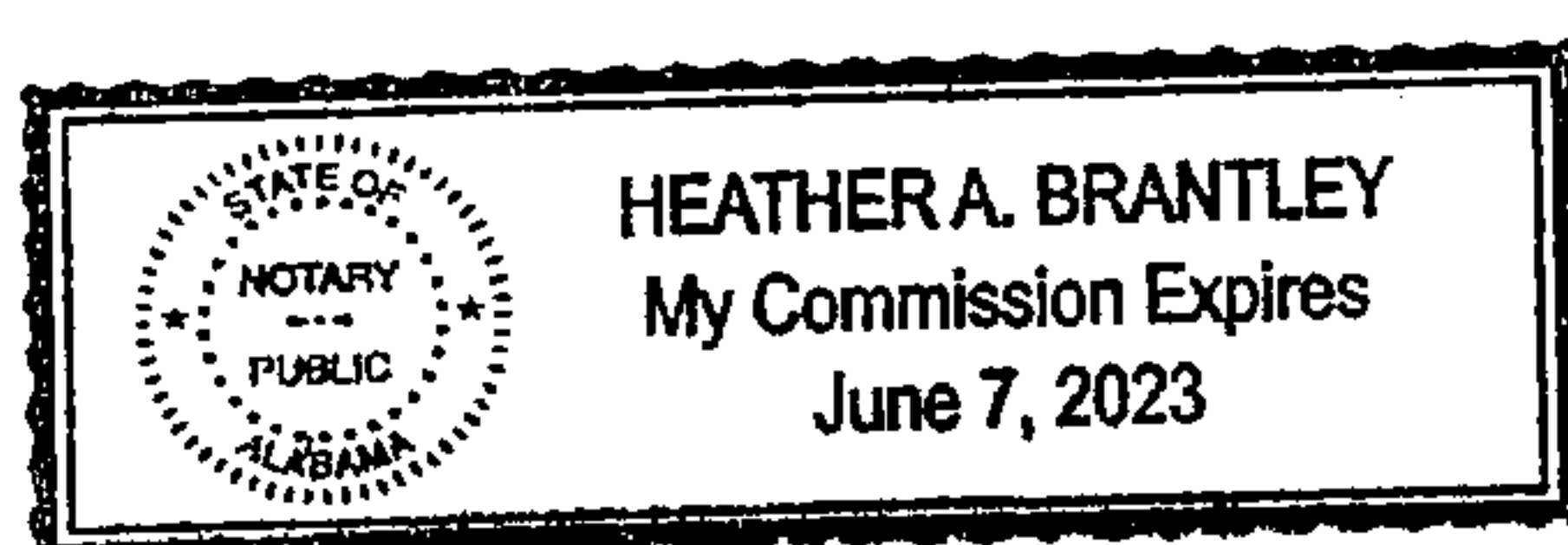


