That in consideration of the sum of **Three Hundred Twelve Thousand Dollars and No Cents (\$312,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Wesley Hurtt**, a Single man (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Austin Blaine Driver and Brandy Michelle Driver**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit:

Lot 3, according to the Survey of Carleton Estates, as recorded in Map Book 13, Page 48, in the Probate Office of Shelby County, Alabama; Being situated in Shelby County, Alabama.

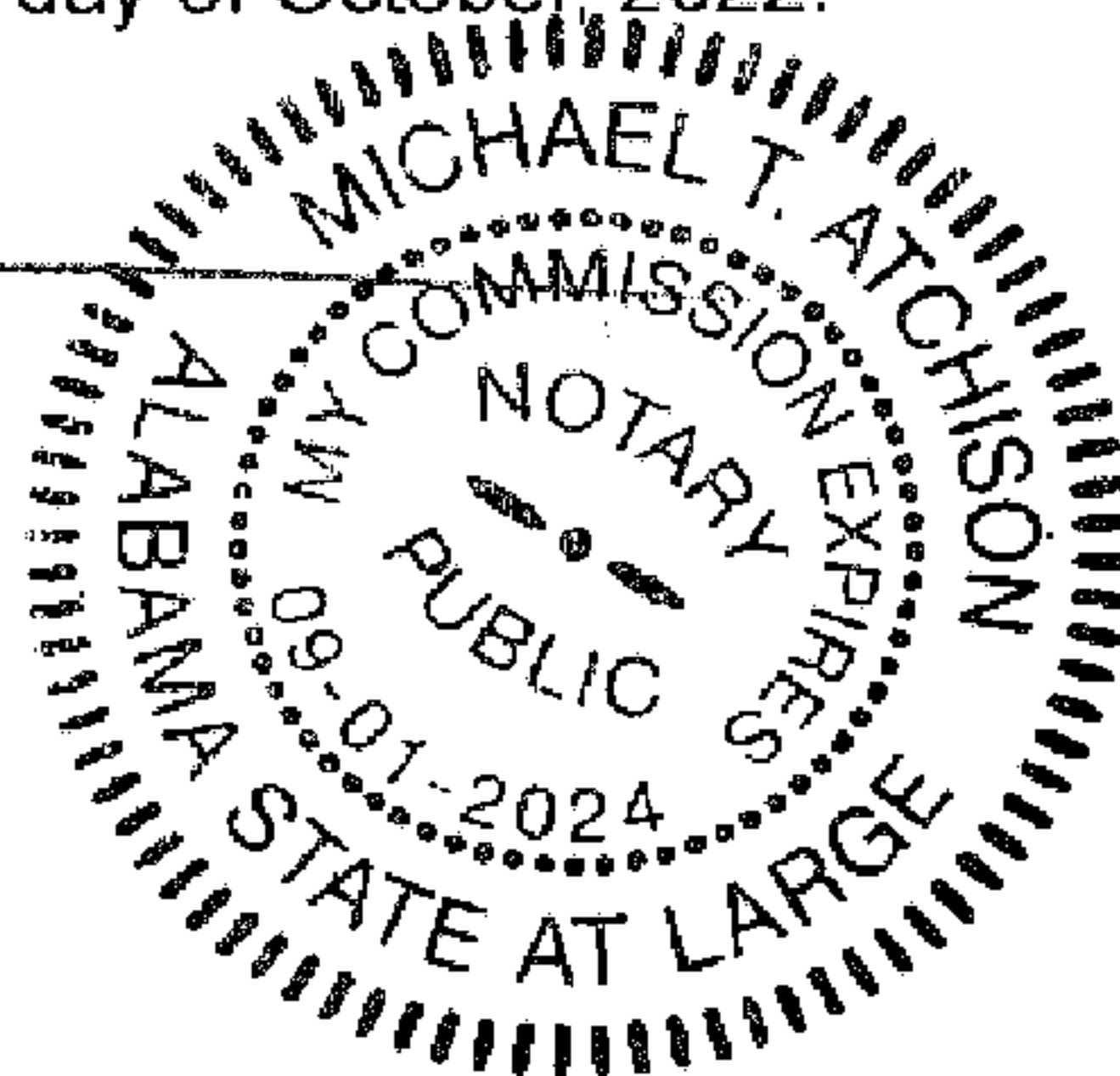

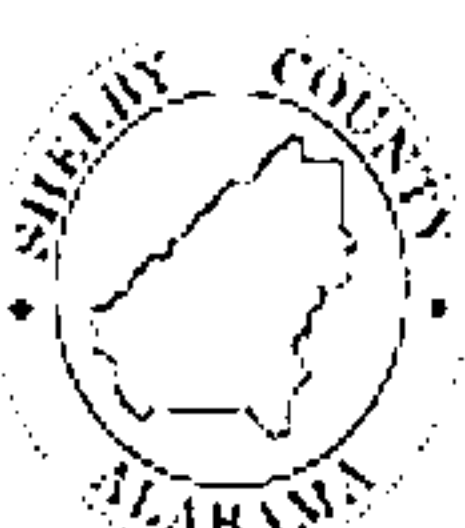
