That in consideration of **Seven Hundred Ten Thousand and no/100 Dollars (\$710,000.00)** to the undersigned grantor(s) (whether one or more); in hand paid by the grantee(s) herein, the receipt and sufficiency of which is hereby acknowledged, I or we, **Joseph C. Lancaster, an unmarried man** (herein referred to as grantor(s), whether one or more), grant, bargain, sell and convey to **Tariq Butt and Fauzia Butt and Rahan Tariq Butt and Hira Rahan**, hereinafter referred to as grantee(s), whether one or more), the following described real estate situated in Shelby County, Alabama to-wit:

Lot 3219, according to the Survey of Highland Lakes, 32nd Section, an Eddleman Community, as recorded in Map Book 35, Page 23, in the Probate Office of Shelby County, Alabama, being situated in Shelby County, Alabama.

Joseph C. Lancaster is the sole surviving grantee of that certain Deed recorded in Official Records Instrument 20100723000235770. Linda B. Lancaster having passed away on or about February 15, 2022. \$568,000.00 of the purchase price recited herein was paid from the proceeds of a purchase money mortgage closed simultaneously herewith.

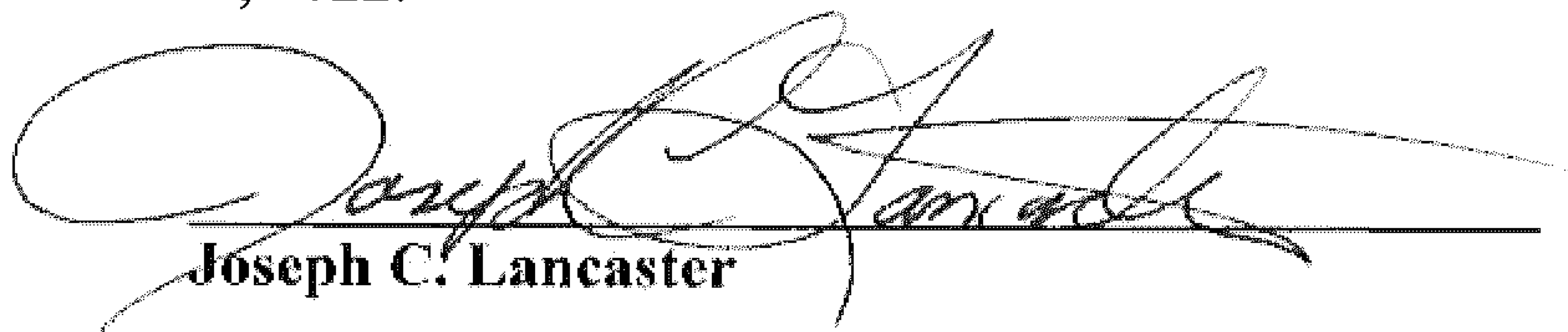
SUBJECT TO:

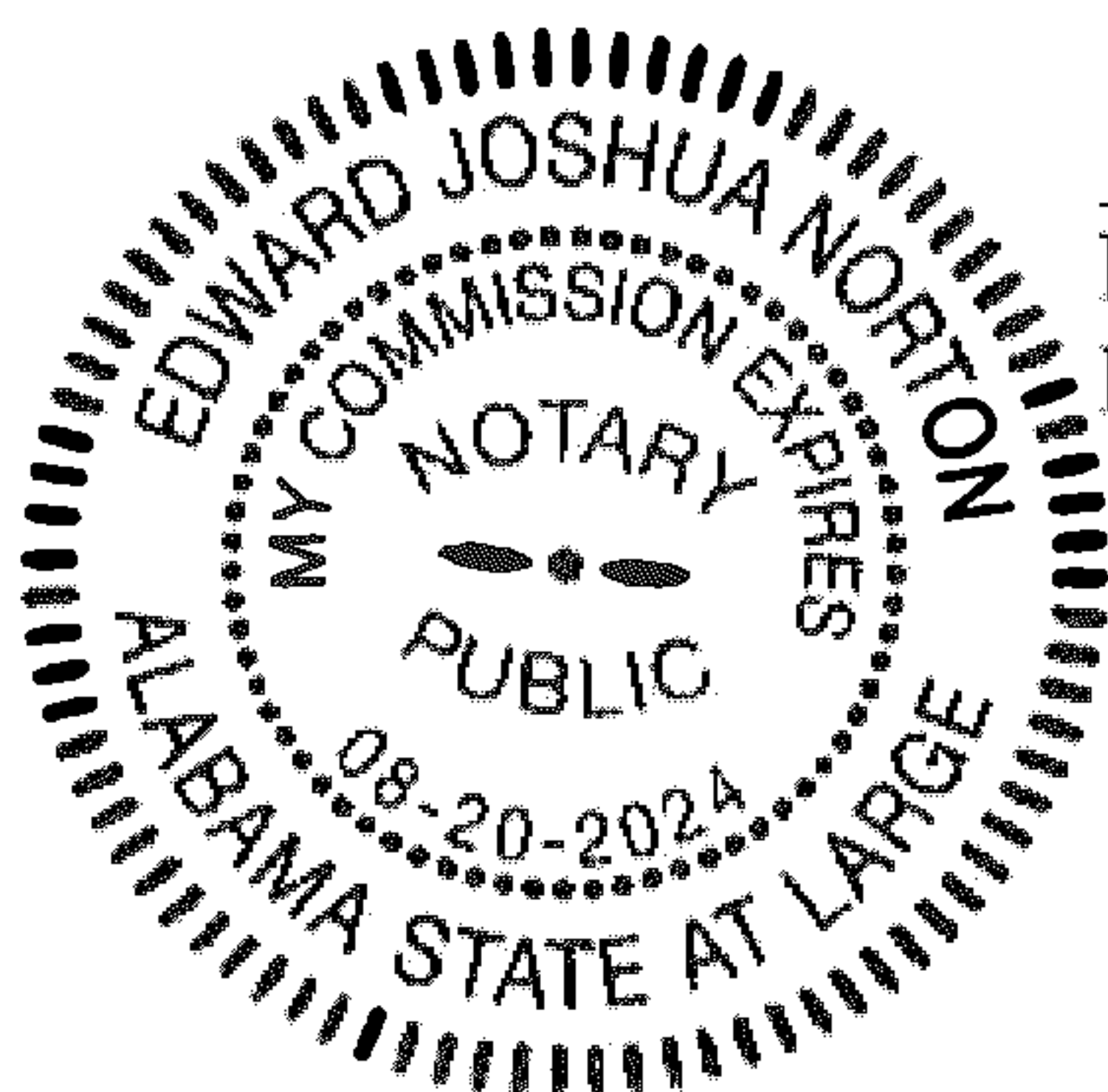
