FIRST AMENDMENT TO THE W.E. ADAMS FAMILY TRUST

THIS AMENDMENT TO THE W.E. ADAMS FAMILY TRUST dated September 15, 2009 (the "Trust") is made on this the 20 day of October, 2022, by **JIM W. BAILEY** as "Grantor."

RECITALS

1. The undersigned Grantor entered into that certain Trust dated September 15, 2009.
2. Pursuant to the provisions of the said Trust, Grantor reserved the power to revoke, alter or amend the instrument, in whole or in part, and he is now desirous of amending the said Trust in certain respects, as hereinafter provided.

NOW, THEREFORE, in consideration of the premises, the said Trust is hereby amended as follows:

I.

ARTICLE III, Section (a) is deleted in its entirety and replaced with the following:

I designate and appoint Jim W. Bailey as my sole trustee and delete the names of Eloise Bailey Adams, William E. Adams, Sr., and Kristal Adams Turpin. Diana Adams Erwin shall serve as the primary point of contact with family members and as successor Trustee in the event Jim W. Bailey fails to serve for any reason.

II.

ARTICLE VII(d) provides that additional property of any kind may be added to the Trust. Added hereby as such additional property is the single family residence at 113 Rossburg Drive, Calera, Alabama. PID 28-3-05-0-008-024.000

In all other respects, except as herein specifically altered and amended, Grantor hereby ratifies and confirms the said original Trust and as amended herein, reserving to himself the right to amend further the Trust Agreement.
