
Subject to a third-party mortgage in the amount of \$190,000.00 executed and recorded simultaneously herewith.

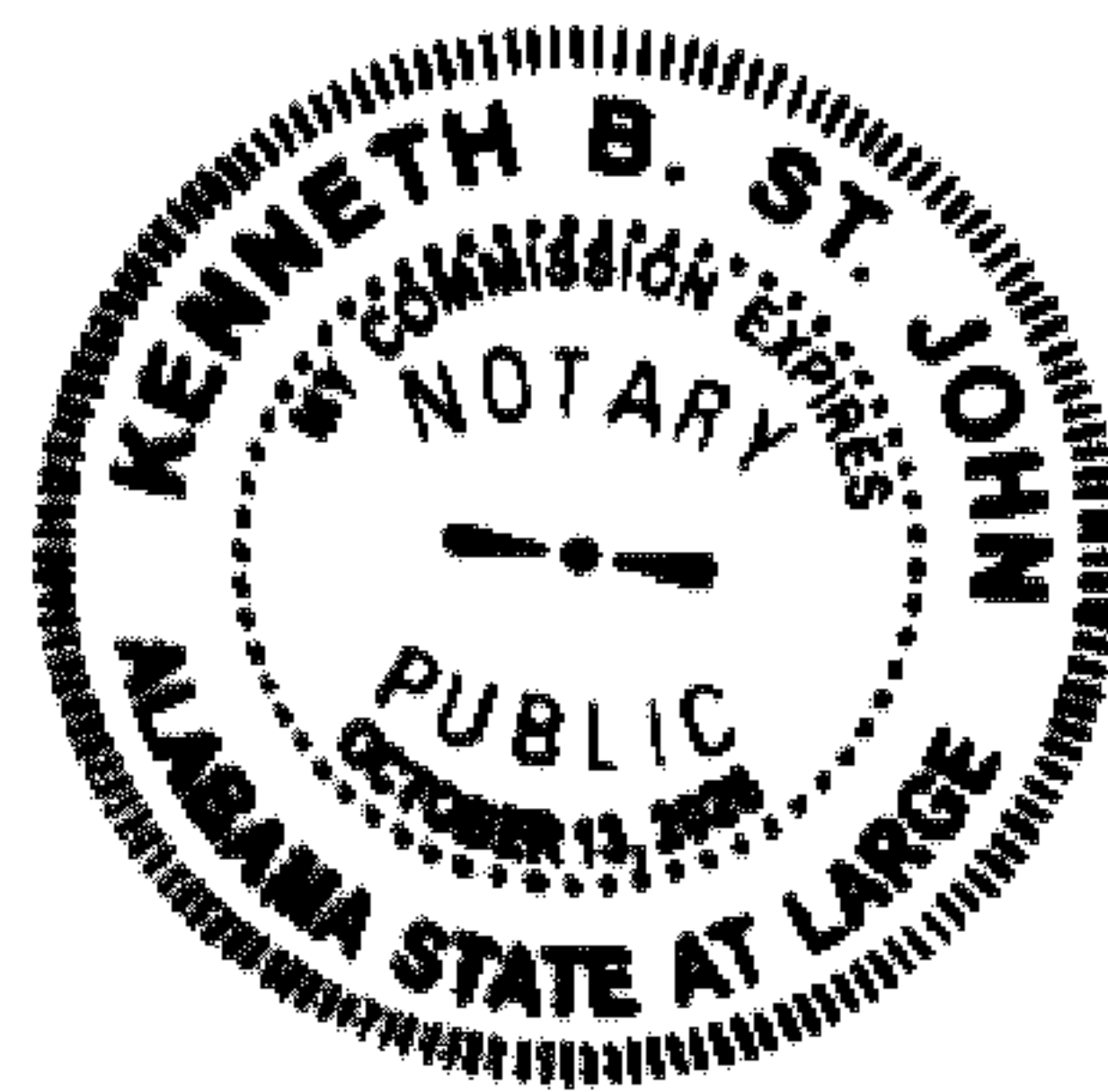
