**GENERAL WARRANTY DEED
With Right of Survivorship**

STATE OF ALABAMA }

COUNTY OF SHELBY } **KNOW ALL MEN BY THESE PRESENTS:**

THAT IN CONSIDERATION OF **Two Hundred Twenty Thousand Dollars and NO/100 (\$220,000.00)** to the undersigned grantors, in hand paid by the Grantees herein, the receipt whereof is acknowledged, we, **Susan E. Davis, who was formerly known as Susan E. Payne, and Jefferson Davis, wife and husband**, (herein referred to as Grantors), grant, sell, bargain and convey unto, **Kaytlin C. Swart and Shelby C. Parker** (herein referred to as Grantees whether one or more), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in **SHELBY** County, Alabama to wit:

Lot 11, according to the Survey of Clearview Estates, First Sector, as recorded in Map Book 12, Page 31, in the Probate Office of Shelby County, Alabama.

Subject to easements, set back lines, restrictions, covenants, mineral and mining rights and current taxes due.

\$190,000.00 of the above consideration was secured by and through a purchase money mortgage closed herewith.

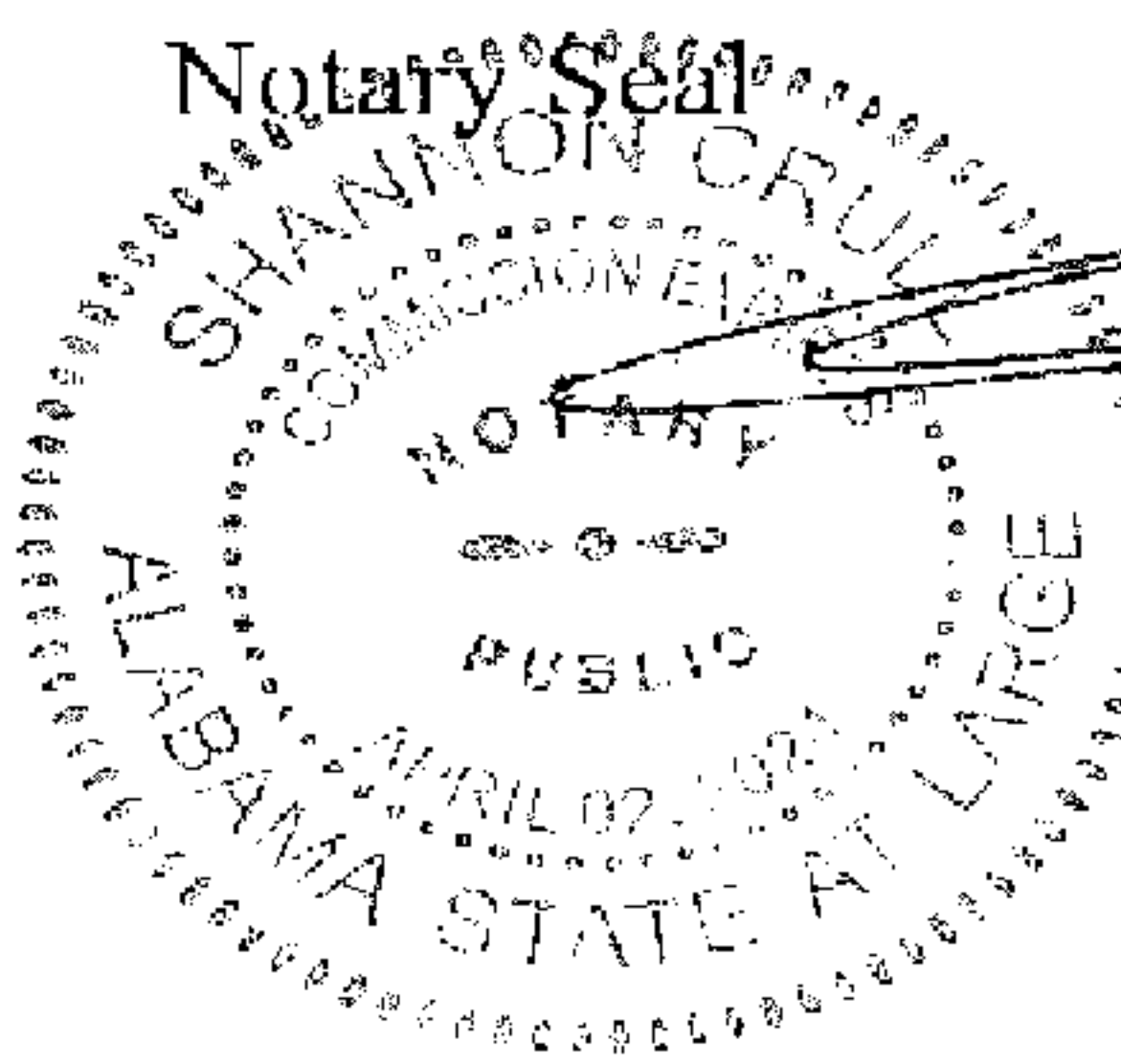

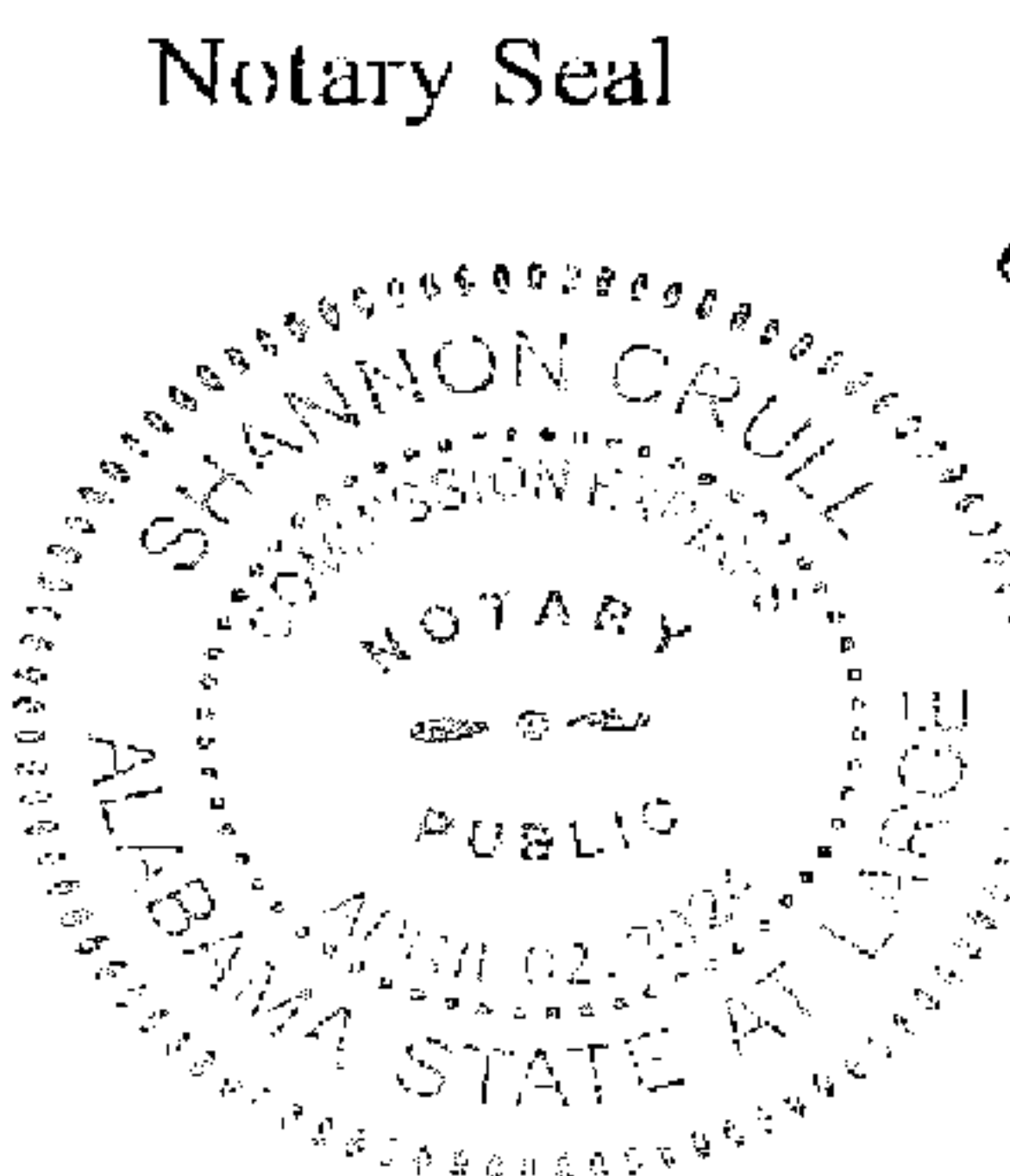
