Jacobs**, (hereinafter referred to as **GRANTORS**), in hand paid by the **GRANTEEES** herein, the receipt whereof is hereby acknowledged, the **GRANTORS** do hereby give, grant, bargain, sell and convey unto the **GRANTEEES**, **John Gabriel Long and Jennifer Thompson Long**, (hereinafter referred to as **GRANTEEES**), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of **Shelby**, State of Alabama, to-wit:

**Lot 23, according to the Survey of Southpointe, 9th Sector, Phase 2, as recorded in Map Book 16, Page 81, in the Probate of Shelby County, Alabama.**


