**GENERAL WARRANTY DEED
With Right of Survivorship**

STATE OF ALABAMA }

COUNTY OF SHELBY } KNOW ALL MEN BY THESE PRESENTS:

THAT IN CONSIDERATION OF **Five Hundred Thousand Dollars and NO/100 (\$500,000.00)** to the undersigned grantors, in hand paid by the Grantees herein, the receipt whereof is acknowledged, we, **James Franklin Kuhn, III and Claire Ann Kuhn, husband and wife**, (herein referred to as Grantors), grant, sell, bargain and convey unto, **James B. Caffy and Lois A. Caffy** (herein referred to as Grantees whether one or more), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in **SHELBY** County, Alabama to wit:

Lot 9-09, Block 9, according to the Map of Mt. Laurel, Phase 1A, as recorded in Map Book 27, Page 72 A&B in the Office of the Judge of Probate of Shelby County, Alabama.

Subject to easements, set back lines, restrictions, covenants, mineral and mining rights and current taxes due.

None of the above consideration was secured by and through a purchase money mortgage closed herewith.

TO HAVE AND HOLD to the said Grantees for and during their joint lives as joint tenants and upon the death of either of them, then to the survivor of them in fee simple, and to the heirs and assigns of such survivor forever, together with every contingent remainder and right of reversion.

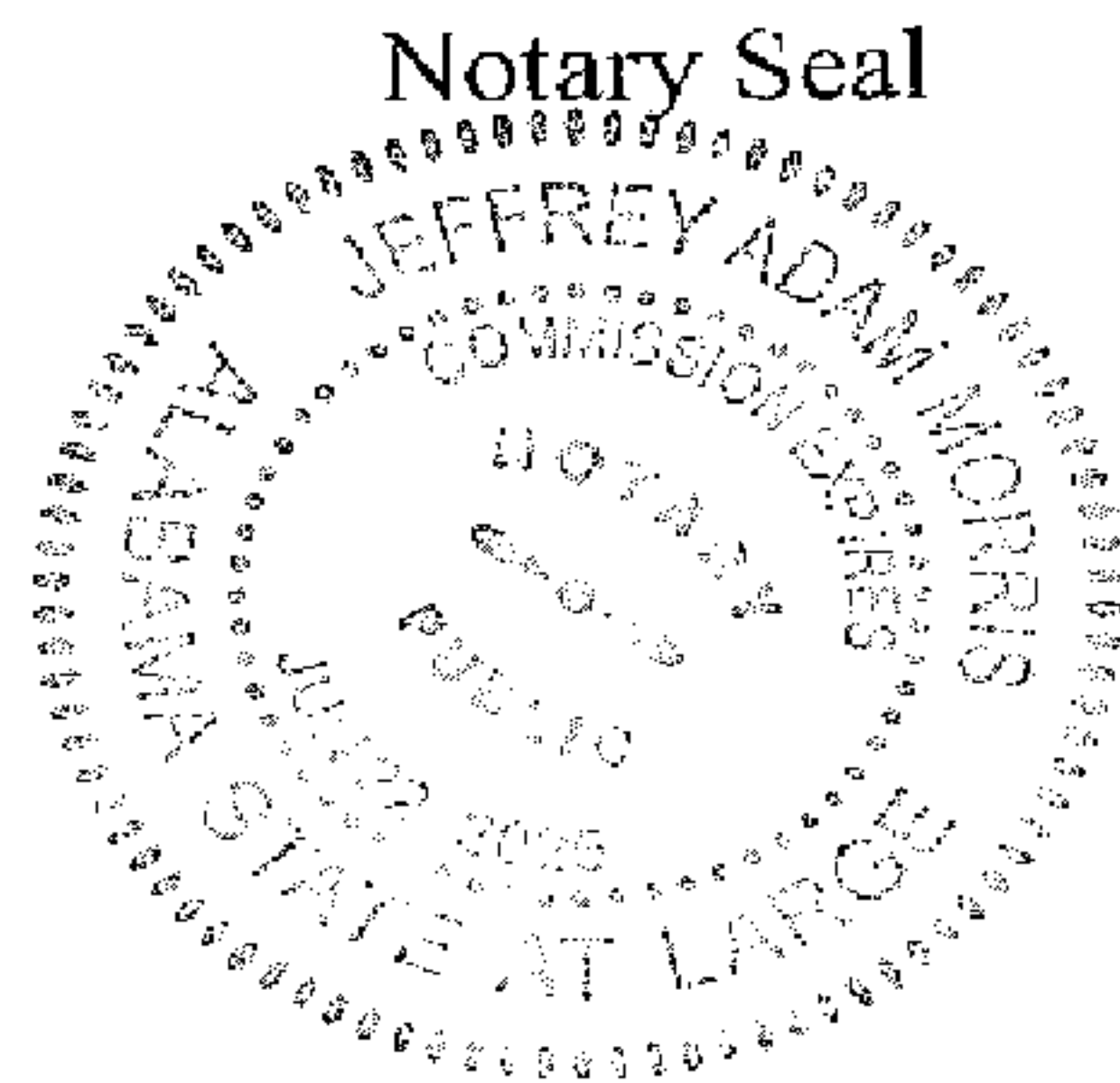

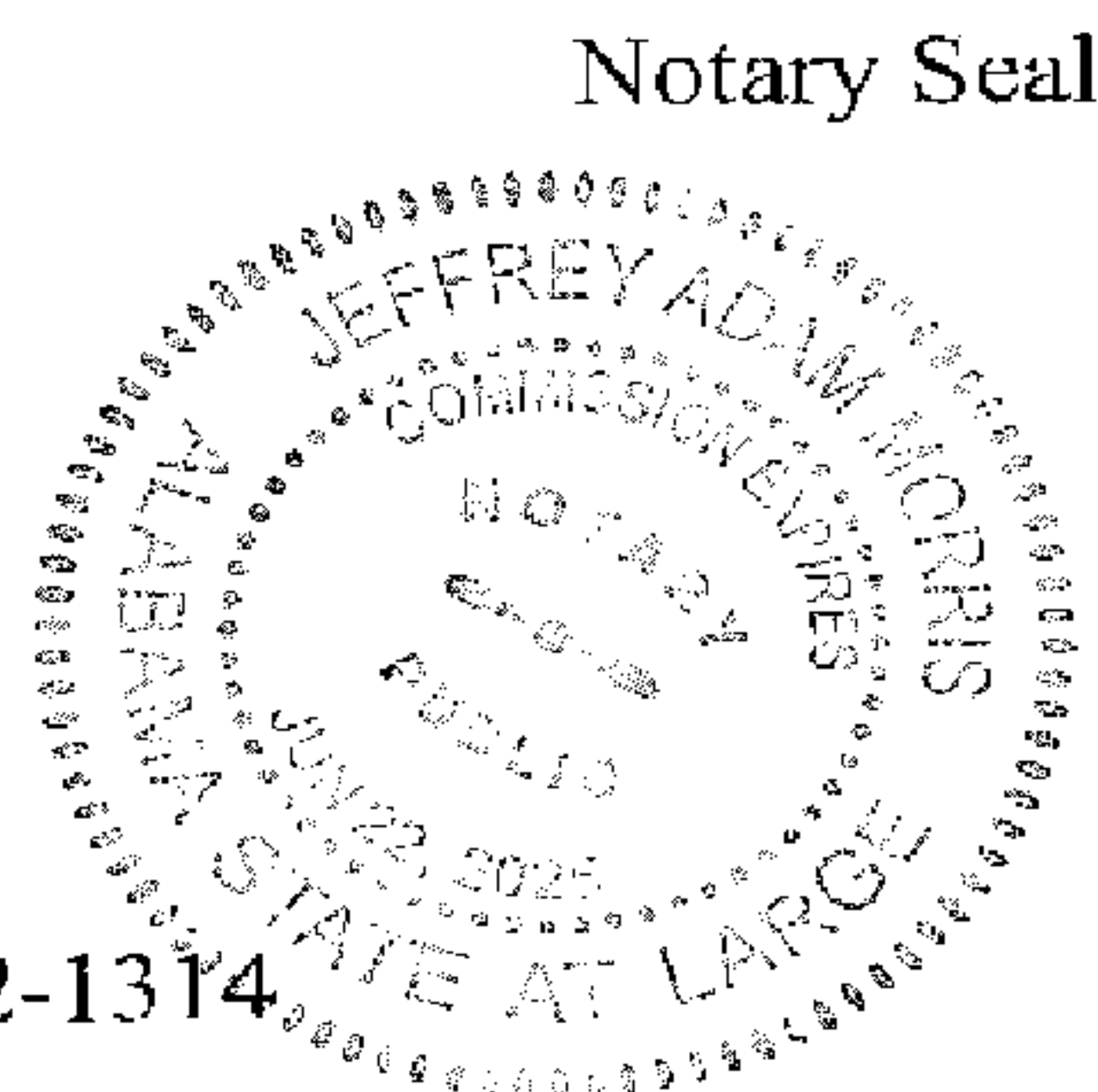
