WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

That in consideration of **THREE HUNDRED SEVENTY EIGHT THOUSAND AND 00/100 Dollars (\$378,000.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt and sufficiency of which is acknowledged, we,

**Michael C. Peterson and Valerie K. Peterson, husband and wife**

(hereinafter referred to as “Grantors”) do grant, bargain, sell and convey unto

**Tracy Brooks Armstrong and Sarah Horsley Armstrong**

(hereinafter referred to as “Grantees”), as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:

**Lot 50, according to the Survey of Sunny Meadows, Third Sector, as recorded in Map Book 9, Page 91 A & B, in the Probate Office of Shelby County, Alabama.**

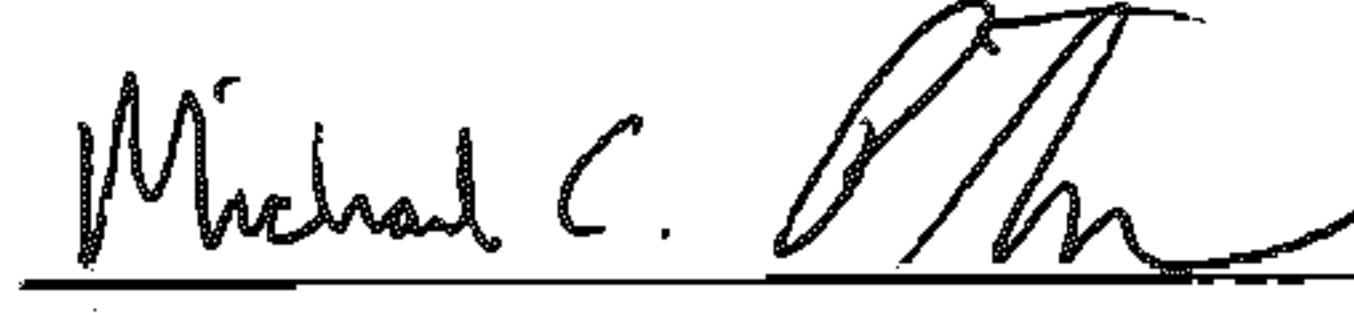
**\$302,400.00** of the proceeds come from a mortgage recorded simultaneously herewith.

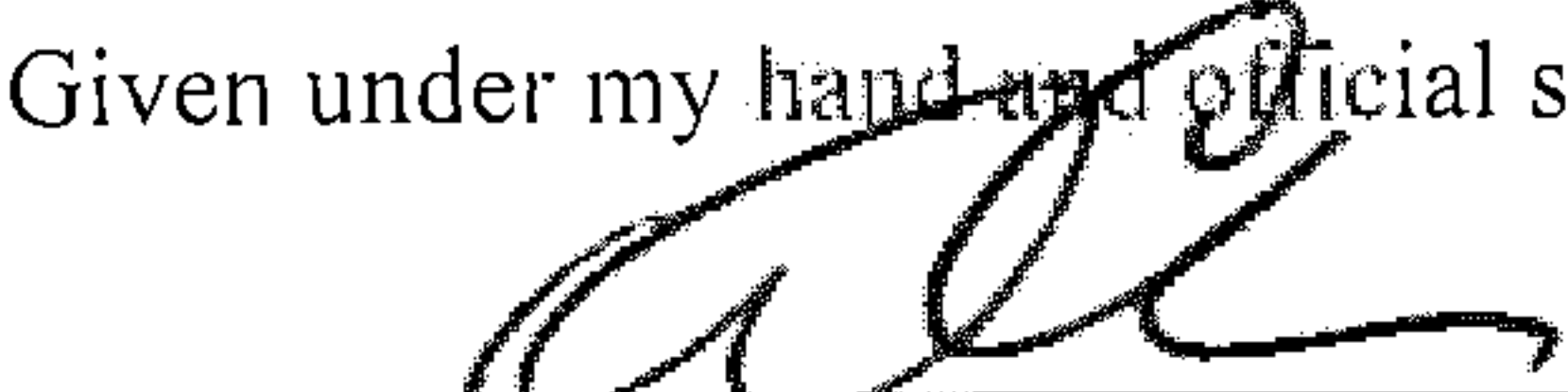

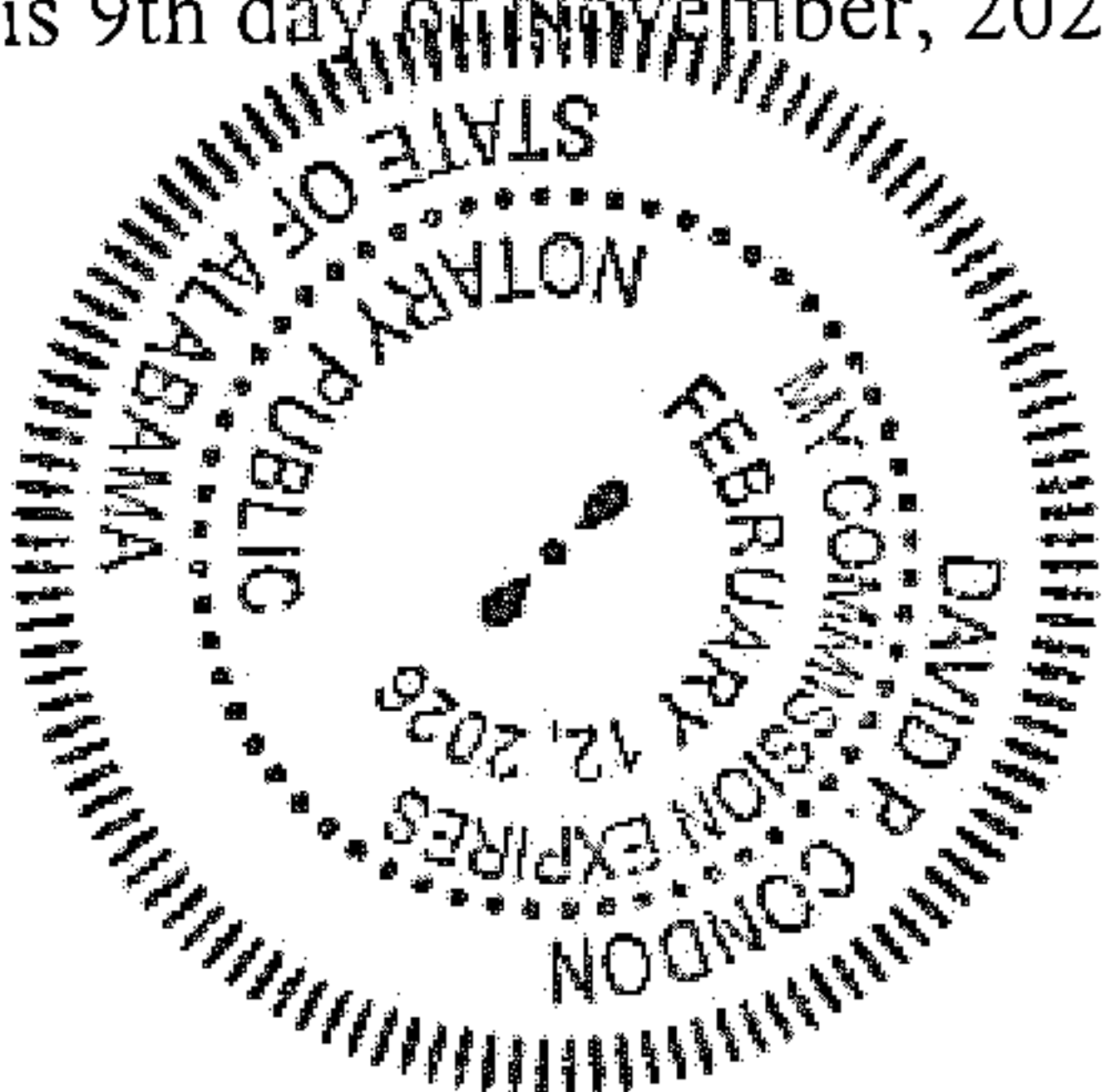
