BARROWS and MELODY BARROWS, husband and wife,** (herein referred to as "Grantors"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the GRANTEE, **RED MOUNTAIN RESOURCES, LLC,** (herein referred to as "Grantee"), Grantee's heirs and assigns, any and all of the respective Grantors' interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA,** to wit:

Lot 11, according to the Survey of The Highlands, Phase 1, Sector 3, as recorded in Map Book 48, Pages 39A and 39B, in the Probate Office of Shelby County, Alabama.

Together with the nonexclusive easement to the use of the Common Areas as more particularly described in the Amended and Restated Declaration of Protective Covenants and Agreement for The Highlands, filed for record in Instrument 2017031300084930, in the Probate Office of Shelby county, Alabama (which, together with all amendments thereto, are hereinafter collectively referred to as the "Declaration").

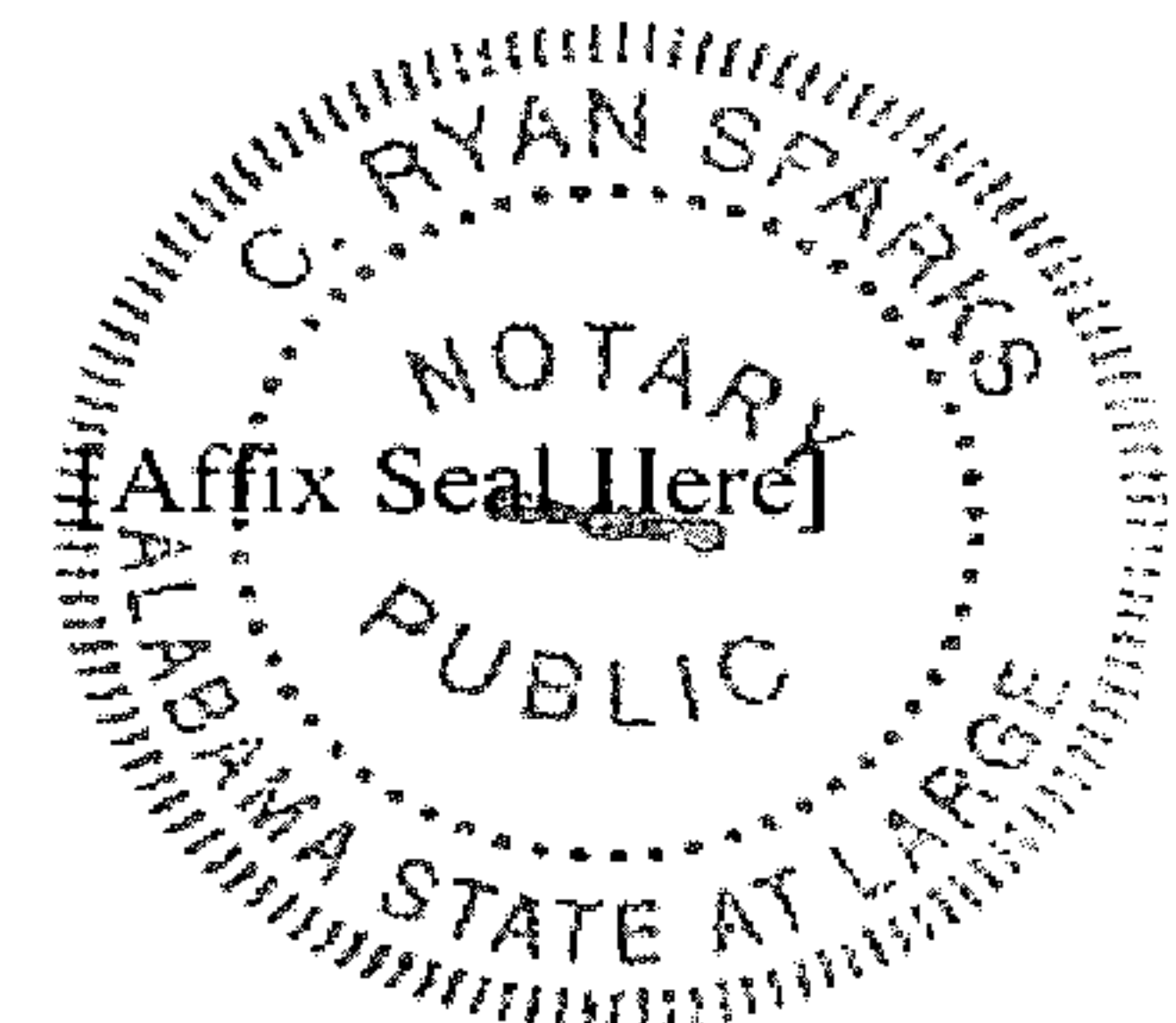
